

to collapse, or in the case of night sightings – disappear. Separation of this column is almost predictable, as the height of the UFO above the water and the size of the UFO (governing the width of the field) itself, probably determines how much water weight the vortex can sustain. It would be interesting to compose a table with these figures, however due to fright or awe on the part of witnesses, most of the time these details are lost:

**07-17-1992 Taking on Water** They pulled their sail down to slow their boat to avoid a collision, but when the ship approached their boat they realized it wasn't a ship. It was a UFO with a lot of lights on it. **It was sucking water up into it** and passed slowly within twenty meters of the boat, but the fishermen don't think the UFO saw them. It just went by them about six meters above the water, sucking up a column of water almost as wide as the UFO. The water didn't fall back into the ocean. The UFO went past them and disappeared in the distance. This reference: UFO Danger Zone, by Bob Pratt, Published 1996, pp. 231-232.

**04-26-1994 UFO "TAKES A DRINK** Below the UFO the water began to chum. Mist swirled into the air. **A center plume of water shot up to the bottom of the UFO.** It was a waterspout. The UFO moved slowly to the left and I aimed the camera and took Photo 49. (See case 04-26-1994 – CF-) Ten to fifteen seconds passed while I stared at this amazing scene. **Suddenly the waterspout collapsed. ## A FUNCTION OF HEIGHT?

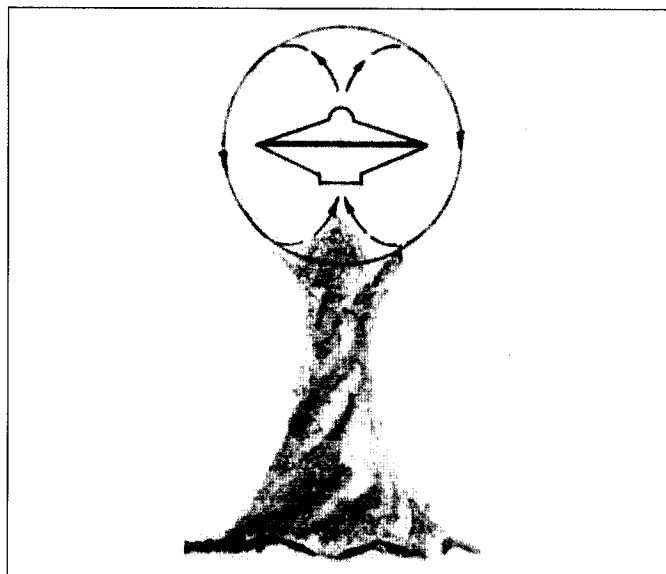

These cases of witnessed effects on water inspired the idea that these effects might be tied together in relation to each other. Some of the cases are of a UFO apparently "taking on water" not by means of tubes, pipes or hoses (as is the case in several reports), but by a column of water lifted by an unseen force directly to the craft. In the other scenario the UFO causes an observed "indentation" of the water. It would appear that these reports are contradictory of each other because of the differences in the effects; however, I believe that the differences are only the result of distances between the field of the UFO and the water.

In figure 5, we have what could be an illustration of the complete steps of the UFO's exit from a body of water, and the water's reaction as it does so.

These craft operate by physical principles! Though the details behind their operations are unknown to us, they should not be considered beyond our understanding. Excusing the craft's functions as paranormal, or that of holographic projections, or the result of some other impenetrable obfuscation is not the way to understand the physical principles governing its technology. We should concentrate on the craft's mechanics – because it is clearly a machine.

## Another Missing Week long Abduction, this time from Portsmouth England

During the summer of 1989, a young man called Paul, 17 years of age at the time, was walking home after an evening out with some friends at the fairground and arcade situated on the sea front. As Paul neared his home, (which was just round the corner from the busy main road which he was walking down), he became aware of the familiar figure of another friend of his, just across the road from him. His friend was waving frantically, as if to gain his attention, but Paul soon realised that it wasn't his friend at all as the person

suddenly shape-shifted into another image altogether. As he looked on, the figure suddenly levitated about 8 inches from the ground, with its feet pointing downwards in the air as if on tiptoes.

For some reason Paul felt no fear. The figure floated and fluttered across the road towards Paul, then it started to make some weird hand movements for about four minutes. It was at this time Paul became aware that everything around him was totally silent. It was only

11.30pm, and still relatively early for a busy seaside town such as this. The road and the paths should have been thronging with holidaymakers and traffic, but it was totally deserted. This "being" held Paul's gaze, just looking at him, as if staring right into him; then all at once he was hurled into a bush near a driveway. Paul said whatever force was used to throw him was incredible, as he is physically a very strong person.

Picking himself up, Paul looked around and began to get a better look at the figure. Clearly this was in no way human, for it was very thin with an over-sized head, skinny arms and legs and huge black almond eyes... something akin to what we now know more popularly as the "Grey Alien". Paul said the next thing he experienced was the "Grey Alien" plunging a needle-type instrument into his neck, which made him pass out.

There is no memory after this, but he woke up in the same place where he was injected, and he thought perhaps only two hours had passed: So he quickly ran back home, just a few minutes away, and banged on the front door with all his might. A very worried and angry father greeted Paul, saying "where have you been for the last week?" to which Paul replied, "very funny!", as he thought his Dad was joking, but when Paul looked at the date on his watch, he got a further shock as he realised that indeed, 7 days had passed since he left home! Then just as his dad was speaking, Paul heard a strange, electrostatic-type crackling sound in the air, which stopped his father in mid-sentence. His dad began to stagger and shook his head, and then he changed his emotions completely, and now became convinced that Paul had in fact only been out for the night. Paul's mother was also convinced that Paul had been out only one night, even though he came in with a good growth of stubble on his face, which indicated he had been gone much longer.

It seemed almost as if his parents had twice been programmed not to pick up on this situation, as the police had not even been informed during all that time and Paul knows full well how his parents would have gone barmy after a just few hours absence, never mind a whole week. Things just didn't add up in Paul's mind as all. Very quickly it seemed as though nothing had ever happened; as if a mind-erasing exercise had been preformed on all of the family and the whole incident was quickly forgotten; until that is, Paul started getting mental "flash backs", memories of what had really happened to him, some six months later. What he was now recalling was a brilliant white light, and in that light was between four or five "aliens" holding him down on some kind of bed; all Paul remembers is the smell of burning flesh, making him feel nauseous.

After the abduction Paul suffered from various levels of depression for quite some time, and to this day suffers from an intestinal disorder as well. Paul has since had a number of UFO sightings around his location; some involve other witnesses. For instance, one evening, coming back from the Cosham area on the back of his friends motorbike, both of them saw a huge triangle coming across Portsmouth, gliding over the old fort on the hill going towards Waterlooville.

**FSR Comment:** This Portsmouth case carries huge importance as it contains a witnessed incident of mind control in operation. The witness noticed an electro-static crackling sound which happened as his parents fell under an unseen hypnotic influence. In this way his week long absence was successfully concealed from them. This un-nerving theme of mind control also occurs in the initial appearance of his captor who mentally projected himself a disguise; the image of a close friend. An unpublished London abduction from the early 1990's involved a similar level of manipulation; the abducting entity being led into the family home by the victim's father who was holding him by the hand. The father said "there's someone here to see you, he says he knows you." Then on seeing the alien visitor the abductee suddenly felt a wave of great fear and lost consciousness.

A reported attempted abduction in New Orleans in the USA in 1961 illustrates our innate human capacity to fall under total mind control by UFO entities. This case comes from the excellent UFOevidence web site. The account begins one month after three teenage witnesses observed a fifty foot ring of lights inside a construction site of newly built tombs in a cemetery. Small four foot figures with lights were observed, the story continues:

Something woke me up at exactly 3.00am and I heard a voice calling me to the window. At this time I was living at my parent's home and the front of our house including my bedroom faced a large lake. One of my walls was completely glass. I got up and went to the window and looked out. I saw nothing. But again I heard the 'voice,' I knew it was not aloud but in my head. The voice was adult male and told me that they were coming to get me to take me 'home.' He said they would be there shortly. I told him in my head, that I was not going unless Joe and Ida were going too. He said they were coming. I felt strange, like I was responding to an unheard voice in what I did next. I went into my closet and took out a suitcase and started packing. It was like I knew what to pack without thinking about it. Then I wrote a goodbye and thank you letter to my parents telling them I was going 'home.' In this letter I mention what of my possessions should go to whom. Then I sat on my bed to wait.

It seemed like a long time went by before I heard the man's voice again. Again he instructed me to come to the window. He told me that plans had changed for now and they couldn't come but that they would be back for me at another time. The next day after school, I called Ida and asked her if anything unusual had happened last night. She told me that she was awakened by a man's voice telling her he was coming for her and that Joe would be there too. She laughed and went back to sleep. Then I called Joe and he related the same thing. Neither Ida nor Joe said they heard a second message about them not coming. When I looked in my suitcase I had the strangest assortment of clothes for all seasons, and I still have the letter I wrote but it is undated.

## From the FSR Chinese archive. The case of the Alien pregnancy 1993.

FSR continues to examine the cases involving evidence of emotional bonding and sexual motivation in alien contact. The following case arose from a Chinese national living in America. It was first published in a Chinese magazine called "Chi Gung and physical exercise" published in Sian Province in August 1995. It then came to the attention of Paul Dong.

In April 1993, a well documented report of a young, unmarried woman who was subjected to rape by an Alien and later confirmed to be pregnant. For one reason and another she decided to have an abortion in a hospital. The unborn child more than 50 days old was taken from her without her being able to see anything. As a result of her experience she has written 80,000 words in her diary and she is still adding more information about her contact with Aliens. Although she wants her identity to remain secret, she has decided to give me the details in order to get her story out to the public.

The incident occurred one afternoon in April of 1993 as I relaxed on my bed, my tape recorder was playing the voice of my Tien Gung instructor (Tien Gung is another kind of Chi Gung) I felt as if I was floating on a cloud, when suddenly I felt a presence in the room and a weight pressing down on me. There was movement as if I was being handled in a most intimate manner and I was unable to fight it off of this invisible force. I felt my mind was starting weakening in terms of resistance, and all the time I could hear the sounds of neighbours next door and in the street. I was unable to call for help as the terrifying ordeal of rape took place. My resistance was all gone and I knew and feared what was happening to me and that I would become pregnant. I tried to ask mentally if it was an Alien but I did not get a response. The whole experience lasted about half an hour before I felt I was alone again and able to move. After this I prayed for my menstruation to happen, but it didn't and medical tests then revealed a positive result for pregnancy. I felt I could not tell anyone about my experience in case it got me into further trouble. I climbed to the top of the mountain nearby and called out "where are you, Alien, is this your child, please tell me and if so I will keep it" I called out to the universe "please help me and answer me" and I called out many times and no answer came and I was in despair. For the first time in my life I felt totally helpless in this huge world. Without being able to turn to close friends and neighbours for help, because who would believe such a story. I had the pregnancy terminated at the hospital and I was full of regret over the loss of life. I was fearful of listening to the Tien Gung tape for about 8 months after. Then on the night of 3rd January, 1994 suddenly I had an urge to listen to the tape and very soon I again felt myself being forced to obey something invisible which was pulling me towards my bed.

I felt I was in a dream but everything was so real around me. I

was then determined to discover the reason for the tape doing this to me. I telephoned the instructor, Tien Gung Master, Chan Lor Tien and told him about my experiences. He told me not to be frightened and that I should write down everything to help the authorities learn more about the intentions of other beings and help the world to straighten out its problems. One afternoon, I was in a dream like state and this time I was able to see the Alien standing in solid form in front of me, his form was clearly definable. He had pencil thin eyebrows and slit-shaped eye sockets and a very wide bridge to his nose. He had no mouth, was quite tall and age wise I would compare him to a human male of 40 years. I felt he had an air of an older man, a kind and respectful man. In front of him I felt like an innocent little girl and he will forgive me all my faults. So I asked him where he came from and he answered by telepathy "from very far away" I asked him which direction and he said "north east of this planet" I asked him how big his planet is, he replied "several times bigger than this planet" I then asked him how he came here, he answered by thought process" he then told me that the universe is just like one big happy family and we must love each other in complete harmony. The next thing to happen was that two more male Aliens appeared, before they all left together. They returned again and again and took me somehow to a control room in a spacecraft and I was able to observe on a large screen my whole body. Up until now I had not enjoyed good health for 20 years but now I felt very fit indeed. The Aliens kept me company all the time and one occasion I had severe back pain, one of them put his hand to the area of pain and patted gently for several times and all the pain left me. They also predicted the future well in advance and now I possess the ability to heal the sick.

Gordon Creighton states in a letter to Paul Dong in autumn 1995, many thanks for the press clipping about a "sexual case," does this mean that never yet, in all these years, have you found a sexual interference case in China itself? If at this time there is no sexual interference cases yet being reported or discovered in China, what do you think it means?(Gordon often referred to the sperm and egg samples reportedly taken during abduction cases as sexual interference cases).

Paul Dong replies "to answer the question of sexual interference cases in China, we all believe there are some of these cases all over the world that includes both England and China. The difference is the Western people have a more open mind to this but the Chinese especially those who live in mainland China are afraid to report such cases because:

- A. Nobody will believe them.
- B. They are afraid to speak out.
- C. The government might check on you.

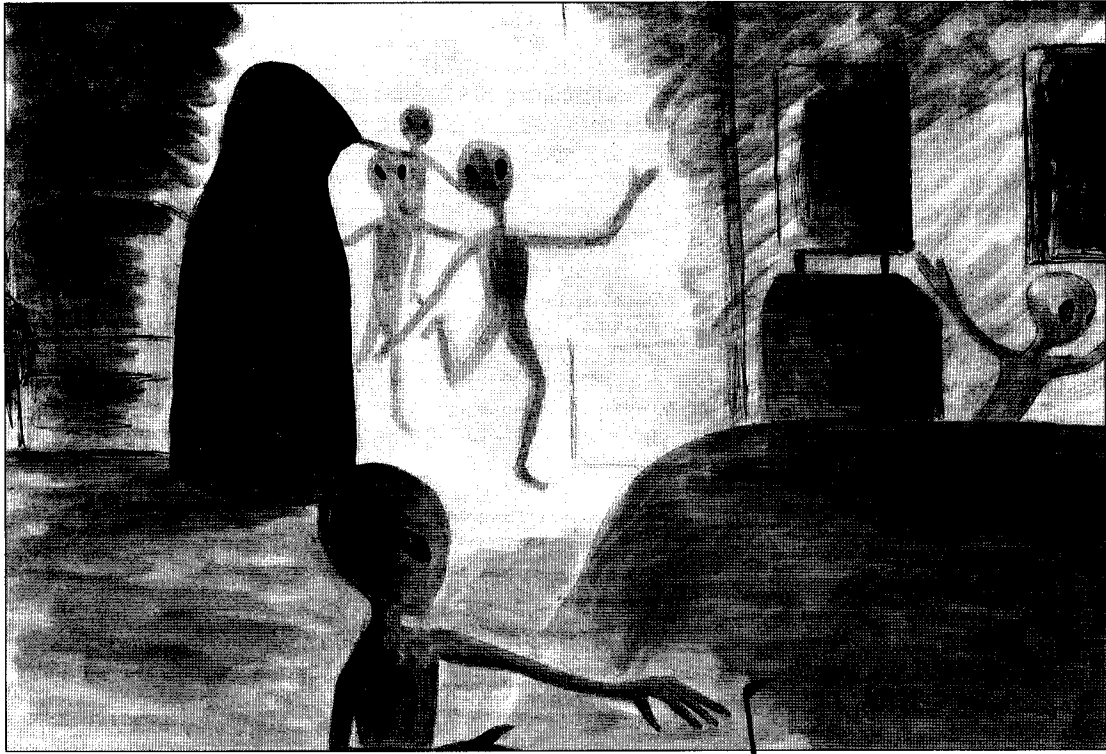
I do hear tales about sexual cases in China but no one reports it directly to me or publishes it in a magazine.

## Bedroom visitations of a different kind.

There is a very common and disconcerting alien or humanoid encounter which is called a "bedroom visitation" which falls under the "Type E" alien encounter rating, essentially meaning an encounter with an alien or humanoid entity without the presence of an associated craft or object. The term bedroom visitation was coined during the 80's and 90's when such encounters seemed to have become more frequent, but have been occurring since the early days of Ufology.

One of the most common entity types reported in "bedroom visitations" are the so-called short "greys" which seemed to have gained popularity in the late 80's and 90's and are a media favourite (it seems that the media only knows one alien type), but from the beginning other bizarre humanoids or creatures have been visiting our bedrooms. Following is a list of such cases taken from the files of researchers and organizations worldwide.



Huron, Erie County Ohio, mid April 1976, during the night Vera Perry was awakened from sleep and glancing toward the doorway, saw a figure, standing upright, staring at her. He was about 6 foot tall, dressed in a greyish outfit with a thick neck, and was bare headed, apparently bald. The facial colour was similar to a mushroom (pale grey?) and in the place of eyes were brownish tinged areas that curved around the side of the head. She could see no nose, and the mouth was merely a straight line. The figure stood motionless, when Ms Perry began screaming the entity vanished. (!) There was no interaction between Ms Perry and this entity, we note that it was grey in colour but with unorthodox eyes not often reported.

**Some visitations can be quite unexpected in nature case in point:**

Torreon, Coahuila, Mexico, May 1976 (same year) time around 2330, during the course of a very hot night the witness had been attempting to sleep while reading a novel and had left his patio door opened due to the extreme heat. Around 2330 he attempted to get up to close the door but found that he couldn't move a muscle, at the same time he spotted a human-like figure standing at the bedroom door. The figure was covered from head to toe by a shiny "black" suit. The figure stood still without moving, while the terrified witness attempted to move but still could not. For 20 seconds the figure stood at the doorway and then it turned around and disappeared towards the direction of the darkened patio. At this moment the witness was able to move and jumped up closing the door to his bedroom. He quickly dressed and went to a nearby hotel where he stayed the rest of the night, still unable to sleep. (2)

**At times and thankfully our humanoid intruders are quite human like in appearance and the witness is less afraid:**

Gomez Palacio, Mexico, January 2 1978, late night, a man was sitting in his front room reading late at night

when he suddenly looked up to see tall blond, blue eye man in the room. The startled witness asked, "Who are you?" On receiving no reply he asked "What are you doing here?" At this point the stranger, whose body was surrounded by a strange glow, turned around without touching the floor. The stranger, floated through the doors of two other rooms and into a patio at the rear of the house followed by the witness. The glow around the man

body increased and he flew up into the air and out of sight. (3). A truly bizarre case, considering the mode of travel of this particular intruder. A pair of human-like intruders surprised a female witness in Russia:

Rostov-on-Don, Russia, October 1982, night, a local resident, Mrs. Tatiana Surina was awakened at night by a gentle push. Near her bed she noticed two figures, a young woman with long golden hair and a blond haired man of average height. A bluish light surrounded both. The man was holding Tatiana's hand at the wrist as if he was measuring her pulse. In a few moments a powerful humming sound was heard, resembling that of an electric transformer and both visitors vanished in plain sight. (4)

**Other visitors could be definitely more unpleasant in nature as in the following incident:**

Vancouver, British Columbia, Canada, January 1990 late night, Eva Trent had fallen asleep when she awoke to a buzzing sound. Opening her eyes she was horrified to find two strange creatures standing on either side of her bed. The entity to her right was about 78 ft tall, weighed about 300 pounds, had apparently no clothing and seemed to have either crocodile or snake type skin. The creature to her left was identical in appearance but smaller in height and weight.

They seemed to be communicating in a chirping manner. Each of the entities eyes glowed. Eva quickly discovered that she was unable to move. As she stared at the two creatures she found that either one or both were giving her instructions telepathically. The nature of this was seemingly for her to create mentally visual scenes of various kinds and then "they" proceeded to distort that particular pleasant scene in a perverse manner. Apparently the creatures were intent not only to observe her emotion reaction, but also possibly to feed off the energy that was produced. After awhile Eva began to mentally resist the mind manipulation and began to pray earnestly. A short time later she fell back

to sleep. The next morning the witness found 5 of her music tapes grossly distorted as if extreme heat had been applied. However no evidence of fire or odor was present. (5). A truly disturbing encounter, I always wondered if the praying really helped, maybe it helped Ms Trent relaxed enough in order for her to fight off these nasty intruders. Other visitors can be downright menacing case in point:

Moscow, Russia, April 1978, late evening, a woman was lying on her couch reading a book and after finishing reading the book she attempted to fall asleep. Suddenly she felt some pressure on her entire body, she was under the impression that some "load" had been dropped on her body. Perturbed, she looked around and saw a deep heavy fog entering the opened window. Suddenly from within the fog two very tall figures appeared, these were about 2.5-2.8 meters in height, dressed in luminous clothing with round and also luminous helmets. The figures approached the woman and leaned over her. At this point she heard some unintelligible speech. She wanted to move and turn away from them, but she was now unable to move, she was totally paralyzed. She begged them that it was getting heavy and that she was suffering. In an instant both figures disappeared the same way they had appeared, first into the fog, which then floated out the opened window. She was immediately able to move again. (6). It is possibly that the humanoids were not aware that they were causing great discomfort on the witness.

**There are numerous "visitations" on record which are so frightening to the witnesses that evoke different reactions on the part of recipient or recipients.** West Virginia, exact location not given, January 25 2001, early morning a witness woke up from a sound sleep to see what looked like a hooded figure all in black standing in the doorway of the bedroom with its arms outstretched. The terrified witness hid beneath the covers and did not see the figure depart. (7) Salmon Arm, British Columbia, Canada, April 23 2001, late night. The witness awoke to a noise outside his door and saw a blue glow in the room. He then heard a loud buzzing sound, then his body went all tingly and numb and an immense feeling of fear came over him. He could not move or speak. He then noticed 2 small shadowy figures that were almost dancing around his bed, while he was trying to move. He managed to blurt out "Get out" and the figures and the light vanished. (8)

**At times brief communication between the intruder (s) and the witness is reported, be it telepathic or otherwise.** Szamotuly, Poznan, Poland, February 2001 around 0400A, a 21-year old woman woke up in her bedroom to find three strange creatures standing close to her bed. They communicated with her via telepathy. They told her that she was one of them and had a special mission to do on earth. (no specifics on that) The humanoids were small and thin. They wore dark gray suits and had small thin heads. (9)

**Some of the encounters are indeed of the most intrusive kind.** Amasya Turkey, July 23 2001, 2130, the witness, a young mother, was breastfeeding her baby in her fourth floor apartment when she turned her head

and saw a strange humanoid in front of the balcony door and curtain. After a few seconds the humanoid suddenly disappeared. She described it as about 1.5 meters in height, with very big jet-black eyes, slanting up. His head was oval shaped and bald. His colour was grey, like smoke. No other details were noted because of the witness state of panic and the short duration of the encounter. There were unconfirmed reports of UFO's seen in the area that night. (10) **This type of report although not frequently reported before the late 70's and after that appears to have around for hundreds of years if not more, maybe during ancient times and even in the early 20th century these visitations were deemed demonic in nature or at times angelic or even miraculous in nature. An example of an early case is the following:**

Cologne, Germany, 1912, afternoon, saw the young witness, Ernest Dickhoff alone in his bedroom when he felt a strong urge to look behind him. He then saw two strange beings, sitting on his bed. These appeared to be man-like, but seemed to be naked. After a short duration the beings suddenly vanished in plain sight. (11) Two years later there was another similar encounter, St. Didier sur Rochefort, Loire, France, 1914, 0400A, a Mr. Perret was at home sleeping when someone tapping on his back suddenly awakened him. He turns and sees a luminous being the size of a 10-12 year old child. The being had a white glittering face and wore a very shiny outfit. He illuminated the room completely. The being then walked through the closed door and vanished, an afterglow remained behind for about 3 seconds. The frightened witness remained in bed. (12) **Whatever the circumstances or whatever type of being or beings is encountered by the witness supposedly safe and secure at home, we must all agree that these so-called bedroom visitations (not necessarily bedroom) are among the most frightening and bewildering of alien or humanoid encounters.**

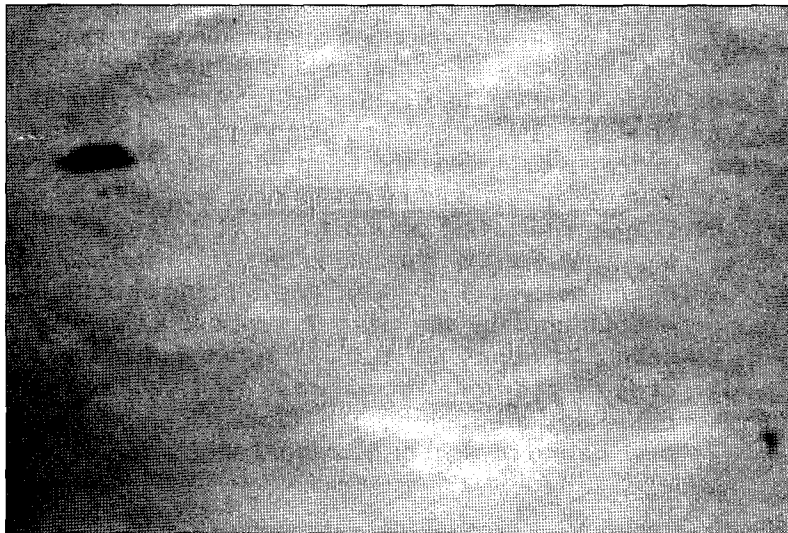

# The abduction of a Spanish national from Tauji beach in the Gambia 2004. Part I.

The following article comes from a sixty year old Spanish lady known as Marife, it describes an extraordinary event in her life which follows the trend in this issue exploring reports of seaborne UFOs. This case is unique because the witness managed to photograph a pair of flying objects just prior to her abduction taking place. There is also a very familiar silhouette in the background which suggests to those with a discerning eye that a 'flying man' may also have been present. This case has rarity value as it took place in Africa from which we have uncovered very few reports of abductions. The late Cynthia Hind, the premier researcher in Africa until the late 1990s claimed to have only managed to uncover a single native African abduction which she was unable to investigate due to witness reticence. The following case has a native African co-witness who may well have been simultaneously abducted.



At approximately 6.30pm on September 11th 2004 I was standing at the end of the beach next to a little fishing village called Tauji in the Gambia. Apart from my guide and me we were completely alone other than for some young boys in a boat who were vigorously waving their arms.

I thought they were greeting us and I waved back. Just then I looked skywards. I cannot specify whether the phenomenon was already there or if it had appeared suddenly. Above the ocean, apparently low and close to the beach, I saw an object in the form of a metallic bird. **(FSR Comment: compare this description to the bird object featured on the back cover of this issue).**

At this moment the object unfolded a 'wing,' revealing two very big and powerful spotlights. It was as if it unfolded its left wing to allow these light tubes to pass. These wings gave off a reflection, the upper part of the object was a brown colour speckled with red. I would best describe the tubes of light which protruded from the object as ivory, off-white coloured. The upper part of the tubes gave off intense orange reflections, even though the lights themselves were white. At this point

the object appeared smaller than a helicopter. There was an additional object, smaller and more elongated was surrounded by a halo of light. Far higher than sitting between the two objects and covered part clouds, I saw a huge golden disc that I thought it was the sun.

The first thought that came into my head was to say, "what a strange country, where even the birds have lights!" I managed to take a first photograph, standing above. I tried to take another and a thought came into my head, "why am I going to take a second photo to take photos of birds with lights." As if it was something out of the ordinary? I have the impression that the guide and I remained rooted to the spot in place seeing neither the sea nor the object. A strong impression is that we heard a loud noise like a motor we looked around and continued on our way.

When I woke up the next morning, something strange had happened. The things in my room which I always left in the same place were in different places. I suffered a small nosebleed and a scrape on right side of my head. My watch had lost twenty minutes. My thoughts remained scattered for the next two days. I stayed in the Gambia until the 16th September. I had various excursions with this guide and at no time did we speak about the incident on the beach. In the December I spoke to him about it on the phone from Spain. I asked him, "Do you remember that object in Tauji?" He replied that it was very strange. My English was insufficient to question him about it further.

When I examined the single photo I had taken it appeared not to fit my memory of how the event occurred. When I took the photo it seemed to me that the object was closer and it had a different form, the children appeared further away. In the photo the object is further and the children are closer. This makes me wonder if there had been a phenomenon of space/time distortion. I would say that for some twenty minutes my guide and I were in a parallel universe.

In February of 2005 I underwent two hypnosis regressions in Madrid under the care of a clinical psychologist. The first session lasted three and a half hours and the second lasted two and a half. All the images and drawings in these sessions were totally unfamiliar to me. I have never been inside a spaceship before, all I know is that this happened to me and I want to testify to the fact. I would dearly like to see the other witness in the incident hypnotically regressed, as well as interviewed with the local woman in the photo and the two boys in the boat. (The results of these hypnosis sessions will feature in the next issue of FSR 51.3, alongside a complete photograph of the encounter).
