of the sun's corona of Light will reach the Earth. Thus the sunlight will slowly – from century to century – gain in clarity and strength. This slowly increasing brightness of the sunlight will be observable from the Earth.<sup>1</sup>

In the future, the wave of Light that eliminated the ravaged Kingdom, and which envelops the entire Globe outside the atmosphere of the Earth as an insulation layer, will prevent the unattached accumulations of Darkness that drift about on and around the Earth both inside and outside the atmospheric layers – from penetratin darkening and completely destroying the innermost dwelling places the spheres. Such destruction has often occurred in the past, the obliging God time and again to purify and restore them.

Apart from the fact that Darkness, guided by the intelligence the Eldest, has in many ways hampered and prevented the advan of the Light in a spiritual sense, it has also without guidance blind and aimlessiy wrought disturbance on the Globe itself through t many dreadful natural disasters that from the earliest times ha caused death and destruction, which the Youngest could a prevent.

These natural disasters are mainly due to the radiations of Darness of the Globe itself, which attract the accumulations of Darkn that are present in layers of varying density within the atmosphere the Earth. The severity of the eruption depends on the innate pow and density of the two mutually attracting and approaching forms Darkness. At the eruption, which takes place the moment the raditions of the Globe meet with the attracted accumulation of Darness, the two forms of Darkness are depolarized and can then eliminated by the Light-ether.

Even though the Elder has returned to God's Kingdom, all various forms of natural disaster will persist. But there is a possibil that they will diminish, in direct proportion to the depolarization and elimination of the Darkness.

Part of the depolarized – neutralized – Darkness was elimina through absorption by the radiations of Light that were sprewidely from the spirit-bodies of the incarnated Youngest before, ravaged Kingdom was annihilated by the wave of Light. But at the disappearance of the ravaged Kingdom, the wave of Light.

in poil acti acti acti acti acti which has replaced it as a huge insulation layer around the Earth, also takes part in the elimination of the neutralized Darkness. From the insulation layer of Light the disincarnated Youngest have extruded fine strands of Light through those strata of Darkness that rest directly on and around the Globe; these strands of Light are led – also by the Youngest – to areas of neutralized Darkness in order to absorb it and in this way to remove it from the Earth, following which this Darkness is drawn into the great purifying circulation through God's flaming Being by the Light-currents of the ether.

The depolarized Darkness that after a certain time has not been absorbed and eliminated will gradually be mixed once more with the polarized Darkness, and thus after a period of latency – neutralization – revert to its original forms.

Although large quantities of neutralized Darkness are constantly eliminated by the Light, the process is exceedingly slow, since the Light can absorb only the depolarized Darkness that is produced by natural disasters such as, for instance, earthquakes, volcanic eruptions, thunderstorms and the like, or by many other manifestations of the numerous and highly varied forms of the powers of Darkness.

Between the lowest and the highest frequencies of oscillation (i.e., rates of vibration) of Darkness extends an extremely wide range of rapidity, concentration and radiation that manifests itself in numerous material and immaterial forms, for example: 1) energy, i.e., electricity, electromagnetism, steam power, and so forth; 2) radiation, i.e., sunlight (solar rays of the lower and lowest frequencies originate from the sun's core of Darkness), phosphorescent light, artificial light (produced by electricity, gas, oil, etc.), heat, radioactivity, and so forth; 3) matter and substance; and a great many other forms as yet unknown to human beings.

At the time when God assumed the guidance of the creatures of His fallen children. He also took charge of the work of restoring order to the chaotic conditions that the incursions of Darkness had caused on the Globe; and as the Earth was gradually supplied with more and more Light – partly through the Passage of Light, partly through the ethereal radiations of Light from the aura of the spirit-bodies of the Youngest – Darkness was brought more and more under the regulating influence of the Light and was thus forced to

serve the Light by helping to restore the destruction that had been wrought through the downfall of the Fldest. Thus: the more regular a law is - whether it is a law of energy, radiation, matter and substance, or whether it is a law that directly concerns reproduction and propagation - the greater is the influence of the Light; whereas the more the law in question is encumbered with irregularities and exemptions, the smaller is the influence of the Light. And when human free will must be taken into consideration, Darkness generally has the greater influence on the established order. An easily under standable example of a law that is not completely regular, and in which human free will intervenes, is the following:

If the processes of conception and birth conformed to laws established by Go or if they had been brought completely under the control of the Light, a strict determinate and standardized period of time would elapse between the instant conception and the completion of birth. No abnormalities would occur during prenancy, no premature or abnormal births would then ever take place, and the infa would in all respects be completely healthy, well-formed and capable of surviving But since God did not make these laws, and since the bad habits and unhealthy was of life of human beings make conception and birth highly dependent on the infinence of Darkness, the regulating influence of the Light has still far from reached full effect on these processes.

In the course of time the Light has gained a far more regular and ordering influence on procreation in the animal world – especially in the case of animals living the wild state – than in relation to human beings; for animals, having no independent free will, simply give way to their urges and instincts and thus submit without resistance, albeit slowly, to the increasing influence of the Light. Whereas on count of the spirit that is bound to the human body, human beings live a conscious life and have a free will for good or for evil. And so long as human beings do no understand how to use their free will in the proper way, so long as they allow Danness to dominate them instead of voluntarily submitting to the Light, so long the Light only imperfectly regulate the laws that determine, for example, to propagation of the human race and the liberation of the human body from abnumblity and deformity.

All that to human beings may appear as the intervention of supenatural powers, all that human beings of undeveloped intellect a perception are unable to explain, has in the course of time be regarded as miracle, superstition, fantasy and the like. All these a parently inexplicable phenomena occur in accordance with regular psychic and astral laws – when they are authentic; but since hum

beings have only a limited knowledge – in many cases no knowledge at all – of the various manifestations of psychic and astral powers, they neither will nor can understand that a natural explanation underlies the apparently "supernatural".

These laws for transcendental phenomena are known, and were known, both to the spirits of the Light and to those of Darkness, for which reason these laws, although permanent and regular in themselves, have often been used in an unlawful manner. One result of the use of these laws by an earthbound spirit without God's permission was, for example, the discovery of the healing waters of the spring at Lourdes. This event, which is known to many contemporary human beings, will as a typical example be further elucidated, since it has been described by some as a miracle and by others as pure superstition.

The French peasant girl Bernadette, who was the intermediary between the sensory and the transcendental worlds when the existence of the spring at Lourdes was revealed, has given a fully truthful account of what she saw and heard. However, contrary to Bernadette's belief, the female apparition that appeared before her was not the mother of Jesus. This spirit, who was acquainted with the astral and phychic laws, appeared visibly and audibly without God's permission before the young girl, who was a clairvoyant and clairaudient medium. In her last incarnation this spirit had been a prominent Frenchwoman, whose conduct had in many ways been highly damaging to France. The anger and hatred of the people, combined with her own consciousness of guilt, had bound her, after the death of her earthly body, to wander about year after year on the astral plane of the Earth, unable to ascend to her home in the spheres. On her restress wanderings she discovered an underground stream that was visible to her and whose water contained certain radioactive substances. Since she knew that the water if used at the site - the radiations being very transient - would alleviate a number of bodily sufferings, and even partially or completely cure certain diseases, she believed that she could atone for some of her guilt toward the people of France by revealing her discovery to them. She therefore addressed herself to Bernadette, who as stated above was a medium, and in order to gain greater credence imparted her message in such a way that she could be mistaken for the Virgin Mary. Her words were: "I am the Immaculate Conception." She knew that this description befitted her no more than it did the mother of Jesus, but excusing herself by the so-called Jesuit adage that the end justifies the means, she had no hesitation in leading people to perceive her as the "immaculate virgin who conceived without sin" - the mother of Jesus. As must all others who are guilty of

falsehood, she has had to atone in full for this deception; but the nature of atonement is a matter between her and God.

Much use is made of the healing waters from the spring at Lourdes. It should pointed out, however, that these healings do not result from the radioactive rad tions alone, but are in many cases due to autosuggestion on the part of the patien. The absolute faith in being healed that many of them possess, together with a fervent prayers and intercessions for help that are answered by God, draw the healing rays of the Light-ether toward the patients, and the desired healing is then par or completely achieved. Even if such prayers and intercessions are directed to Virgin Mary, God will answer them when they are offered with fervour and in cere trust. But only a few of the body's ailments can be cured in this way; and not accounts of healings experienced at the spring are in accordance with the truth

In view of the foregoing, the healings that occur through the application of wa from the spring at Lourdes' can be regarded neither as miracles nor as cures basentirely on superstition, any more than can the discovery of the spring. The appently supernatural in this case does have a natural, lawful background; but the launder which the existence of the spring was made known to mankind were ployed in an unlawful manner, that is without God's permission.

People have very often placed on beings from the transcendent world demands whose fulfilment was, and still is, in violation of t laws given by God. Thus it has happened, for example, that me bers of a spiritualistic circle have often demanded of spirits w manifested themselves during the circle's séances that they show prove their existence, their personal identity and their spiriti strength, or demonstrate that they were emissaries from God, and forth, by performing materializations, dematerializations, and ma other "feats" of this kind. Doubtless without being aware of these spiritualists have thus often demanded that their spiritual co municators should act against the Laws given by God. And when spirits have not wished to act against these laws, and thus failed produce the desired evidence, these people have forthwith label the spirits of their mediums as frauds, without being willing to inv tigate or respect the reasons for their refusal. Conduct of this ki by human beings is as foolish as that of a thief who would say to honest person: "Go and steal, and I shall believe in your honest

Human beings must learn in the future to respect the psychic a the astral laws, even though they do not understand them; learn they must not demand, but only pray; learn to receive with gratity the proofs that are given from the transcendental world according the insight and wish of God; learn that the spirits of the Light v

not behave as lawbreakers simply because certain people will not understand until they have seen or received that which they themselves demand. And of one thing can human beings be certain: the greater their demands, the less will they be given from the transcendental world. Only they who seek in prayer, with faith and in a completely unselfish manner, only they can achieve close contact with the spirits of the Light and receive the necessary help to find that for which they seek.

The laws of lesser, greater or complete regularity that directly concern purely earthly conditions, whether relating to energy, to radiation, to matter and substance, and so forth, or whether to the psychic and astral laws that govern the contact of the transcendental world with the physical, all these laws are only provisional – temporary – which is to say that they apply only by virtue of the existence of the Earth, and only for so long as the Globe exists.

Through that intelligence with which God has enriched human beings, and through instruction from the incarnated Youngest, some of the forces of Darkness – electricity, electromagnetism, steam power and so forth – have been put to use in the earthly world and must therefore, being partly under human control, in many ways contribute to the easing and improvement of life on Earth.

Many toxic substances – organic and inorganic – that originate from Darkness have similarly been put to use in the service of the Light, for example as medicines and disinfectants, or utilized in many other ways, for example as pigments, etching reagents and so forth.

Several explosive substances that in the service of Darkness are used to cause death and destruction – for example as weapons of war – are also used to serve the progress of the Light, for example in the levelling of the ground, blasting of obstructions, drilling and so forth.

Also through the diseases of the body is Darkness forced to assist in maintaining the overall balance. An acute illness can relieve the sufferer of accumulations of Darkness – strain, germs, bacteria and the like – that threaten to destroy the body. The cure, which among other things is due to the healing influence of the corona of Light and the Light-ether, restores health to the body – the accumulated Darkness is eliminated and the balance thereby restored.

Inrough the Laws of Retribution and Reincarnation, which are also temporary, and which God has given to promote the progress of mankind on Earth, the spiritual destruction and disturbance that Darkness constantly causes among human beings is equalized and counterbalanced in many ways.

Through the Law of Retribution each evil thought and every evil or criminal act reverts to the person who conceived the thought of committed the act; in this way the originator must endure the same spiritual or physical sufferings as those intended for or brough upon others. Balance is then restored through the sufferings endured by the originator.

Catastrophes that are due to the influence of Darkness on the existing order, and which intervene in the lives of human beings h causing disturbance and destruction, are similarly utilized by God to restore balance under the Law of Retribution, thus forcing Darknes also in these cases to serve the cause of the Light. For instance people who directly or indirectly become victims of earthquakes mine or traffic accidents or of fire disasters, of the devastations of war, such as maiming, disease, starvation, loss of property and s forth will always, because of the spiritual and physical suffering en dured, have the guilt of misdeeds, killings, murders and other crime committed in previous lives counterbalanced and annulled, so that their future lives on Earth become brighter and happier. For it mus be clear to all: that no human being endures any greater spiritual of physical suffering2 than that brought upon himself or herself i previous lives, and since God never lacks the means to interced when this is necessary, people who have no guilt from previou earthly lives that can be expiated in the above manner will never b exposed to this kind of suffering. (See pp. 252-53).

All who fully repent of their evil and sinful actions can through the remorse obtain God's permission to atone for their sins by one of more acts of love or compassion toward those against whom the have sinned.

Even death must serve life and the Light, since the spirit that released at death, possessing the results of the accumulated experences of the recently ended life on Earth stands prepared to acquire new experience and new learning through new earthly lives.

And when the many incarnations of humanity have come to a end, according to the Law of Balance of the Light, God will through a mighty cataclysm cause the remainder of the Darkness that has no yet been depolarized to assist in the dissolution of the Globe, which through the downfall of the Eldest was brought under the dominic

of Darkness. Then will the perfect and final balance have been achieved: humanity will have been released for ever from the Earth for millions of years the stage for human sin and grief and suffering; the Globe will disintegrate; the Darkness depolarized through the cataclysm will be absorbed and transported by the cycle of Light to its ultimate purification inrough God's flaming Being – and the saga of the Earth will have come to an end.

All that has been stated concerning the oscillations, depolarization, radiations and various other manifestations of Darkness as well as the descriptions of the regulating and balancing influence of the Light have only been given in broad outline, since specific knowledge of the various branches of the natural sciences is required in order for the transcendental world to furnish a more thorough and detailed explanation. But people with scientific training who wish to proceed from this given basis can always be assured of receiving valuable help from their spiritual leaders – the disincarnated Youngest. Much that can be brought to light and utilized by human intelligence is still unknown and unresolved, while similarly a number of the powers of Darkness still remain to be brought under human control and made useful in many ways.

Since the Earth is a world of Darkness, human intelligence will be engaged mainly in utilizing the products of Darkness. But human beings will gradually learn to discern and determine where the influence of the Light intervenes in the existing order.

From the moment in the remote prehistoric past when the Eldest decided to oppose the incarnated Youngest in order to obstruct their guidance of humanity, the Elder has like God¹ laid plans in outline for the incarnations of the Youngest and the human spirits. In accordance with these plans the Eldest or the Elder himself sought to lead human beings astray and away from the paths of life desired by God.

The Elder has in the same way predetermined the fate of entire peoples, entire nations, in order to lead as many as possible away from the paths of the Light.

Since all thoughts<sup>2</sup> – evil as well as good – are received and reflected by the ether, the Elder's predetermining thoughts of future events were recorded as images in the ether of Darkness that surrounds the Globe.

Three different types of ether-image occur: future-image

present-images and after-images.

1) Future-images are the aforementioned records of the Elder predeterminations for the fate and conduct of individual huma beings and of entire nations. These future-images, which were mean to bring misfortunes and sufferings upon humanity, like everything else originating from Darkness, have, also, been forced to serve the cause of the Light in accordance with the Law of Balance. The dising carnated Youngest – the leaders and guardian spirits of manking have thus been able to discern from these future-images what plot and designs threatened their charges at the hands of the Eldest. The have been able to determine, from the faintness or clarity of these future-images, whether the recorded events lay far out in the future or whether they were imminent, and have accordingly been able to take precautions if possible to avert or mitigate the destructive future events that threatened the individual or humanity at large.

Where nations were concerned the Elder normally outlined h predeterminations for several centuries into the future, so that by the time he returned to God he had recorded in the ether of Darknes that surrounds the Earth many future-images of the manner i which the lives of all the peoples and the nations on Earth for man years ahead should develop according to his will. But when some years before his return he understood that the Light must ultimate defeat him, he devised further appalling occurrences for the future of nations in the form of devastating wars, assassinations, yet mor wars, misfortune and misery, etc., reasoning that hatred, envy and lust for power among human beings would help him draw Darknes closer about the Earth, and thus, despite the counteraction of the Youngest, postpone the day of victory of the Light over him. The Youngest, who were all aware of both these and the earlier pre determinations, did all they could to prevent them from occurring on the plane of the Earth as real events. At the time that Christ such ceeded in winning back his eldest brother, several of these ominous events had already come to pass as realities upon the plane of the Earth, while others were about to do so. The Youngest tried in man ways to divert or moderate the existing and impending conflic between the governments of the various nations, and thus, if the were possible, to prevent the outbreak of the appalling wars in which such conflicts would otherwise result. But the many and energetic a tempts by the Youngest to guide the leaders and the rulers in peaceful settlements of their standing disputes remained withou

result, and numerous of the Elder's ether-recordings were called forth into reality in the earthly world by the will for evil of human beings themselves. But although the Eider carries the chief responsibility for the recorded predeterminations, human beings must also bear grave and onerous guilt for the horrors, murders and misdeeds that were committed through human malice, hatred, greed and lust for power, and which could have been avoided had human beings striven for the good and the true in life instead of heeding the promptings of revenge and injustice. And if the Youngest are to prevent the remaining threatening ether-recordings from being called forth into reality upon the plane of the Earth at the time appointed by the Elder, human beings, and especially their leaders and rulers, must assist by paying greater heed to the admonitions of their conscience, since the efforts of the Youngest will otherwise be in vain; for God compels no human being to turn away from Darkness, and He compels no one to do that which is right.

The Elder's future-images have often been seen by clairvoyant human beings, but through abnormal refractions in the ether these images have from time to time been perceptible to people who were not mediums. Several people have thus simultaneously seen ether-images – forewarnings – for example of marching soldiers, scenes of battle, murders and the like. The images have appeared in the open air (not unlike earthly mirages such as Fata Morgana) or in enclosed spaces, for example in the rooms of palaces, manor houses and ordinary dwellings that later became the scene of the crime foreboded by the ether-images.

Through similarly abnormal refractions in the sound-waves of the ether, sounds belonging to the future have been audible in the earthly world as omens, for example the sounds of battle, the crash of as yet imaginary train collisions, screams, sighs, groans, the sound of firm, stealthy or dragging footsteps and a great deal more.

No detailed explanation of these phenomena will be given, since they will all gradually cease as Darkness is eliminated.

Not all criminal deeds have their origin in the Elder's ether-recordings. In many cases they are due to the mutual hatred, envy and so forth of human beings. In the same way, by no means all the misfortunes that have occurred, and will continue to occur, can be blamed on the Elder. Many are due to human recklessness, indolence negligence, dereliction of duty and so forth. Human beings who in these or in other ways cause the maiming or death of themselves or of others must bear the full responsibility themselves, and cannot lay the blame upon the Elder.

2) Present-images, in other words recordings in the ether of human thoughts that likewise in many ways affect the life of the individual and the existence of all humanity.

Since all thoughts are received and transmitted by the ether-waves people influence' each other for good or for evil. Impure and evithoughts are attracted by wicked and feeble persons, so that the often commit acts under the influence or compulsion of thought conceived by others. The one who transmitted the thoughts must a such cases share the responsibility with the one who committed the act. But only God can determine whether the act resulted from the individual's own thoughts, or from thoughts that were attracted to or forced upon that person.

The principal psychic law, on which the telepathic power of thought is base will not be disclosed to mankind from the transcendental world, since the ethic standard maintained by human beings is not yet high enough to preclude all misu of this knowledge.

Through experimentation, human beings may possibly come to recognize and determine for themselves some of the more elementary laws for telepathy of thought.

3) After-images are reflections of human actions performed according to a conscious thought-plan, or according to thoughts the arise instantaneously from within the self, or that are attracted to c imposed on the self from the outside.

The moment a thought becomes action the thought-image fade and vanishes, and as the action is carried out, it is recorded or responds exactly to the image of the action seldom corresponds exactly to the image of the thought, since people virtual never carry out their actions precisely according to the thoughts the precede them, even if the conscious thought-plan is prepared with the greatest care, since many events unforeseen by human being often interfere at the moment of action, whereby much can changed or prevented.

or similar misdeeds, are often fixed for long periods of time in the accumulations of Darkness at the place where the crime was committed. These images dissolve and vanish when the perpetrators the action have fully repented of their sin. But when those who has committed the crime do not repent during their earthly existence, during the period of time for contemplation and repentance that

allotted to each released spirit at the time of death of the physical body, the image remains until the sin has been atoned for in some way in a new incarnation. It has therefore often happened that an after-image of this kind has remained in the same place for centuries.

In contrast to the thoughts, which are borne away by the ether-waves, the images of evil and vile actions are reflected in the accumulations of Darkness and remain there until they fade and disappear. Images of good deeds are reflected in the radiations of Light from the spirit-body.

The radiations of Darkness from after-images often produce a distinct feeling of <u>uneasiness</u> in sensitive people when they are present in places were crimes have been committed. Clairvoyants have often seen and described after-images of scenes of battle, murder, robbery and other evil deeds.

After-images of good or insignificant actions are dissolved and gradually fade away as the action withdraws in the individual's memory; but when the human spirit is released at death from the earthly body, everything – good and evil – remains recorded in the consciousness of the spirit.

In the same way that after-images are preserved in the accumulations of Darkness, sounds that stem from crimes already committed, such as screams, blows, the impact of an axe, stampings, shuffling footsteps and so forth, are preserved for long periods in accumulations of Darkness as after-sounds. These sounds may on occasion become audible in the earthly world in places where crimes were committed. The sounds can be so "real" that they can be heard by people who are not mediums. These sounds will cease as the respective accumulations of Darkness are eliminated.

Since human thought is a reflection of God's Thought, human beings are able by the existence of their thought to give form and shape to the products of their imagination, so that these can appear visibly on the astral plane. In contrast to the spiritual beings that God has created, the forms of human fantasy are not everlasting but only ephemeral, their existence being subject to dissolution and destruction.

The higher the spiritual self that is bound to the human body, the clearer and more firmly constituted are its thought-images or phantoms; but in most cases people do not shape or finish their thoughts completely, for which reason that which appears or is brought forth in the spiritual-astral substance normally resembles only misty, elusive and colourless sketches. All authors, painters, sculptors, and others who wish to translate their thoughts with the help of earthly materials, so that in some way they can be perceived and understood by their fellow human beings, consciously or subconsciously form or create in their thought one or more images of

that which they wish to make accessible to sense perception. The clarity, brightness of colour and durability of the images and phantoms are dependent on the artist ability to work with the spiritual-astral material. They normally fade away when the individual relinquishes the initial thought in order to let new images and new phantoms emerge.

Since clairvoyants can normally see these thought-phantoms but are not alway able to differentiate within their field of vision between a phantom and a huma spirit, numerous legends and fantastic tales of the so-called "elemental spirits" has come into existence in the course of time.

Ever since the earliest ages after the time when God had endowed humanity wit spiritual life, i.e., thought and will, human beings – especially the most primitive the least developed people – have imagined nature to be populated with invisible beings whom they believed capable of intervening in earthly existence in various way and of making themselves visible to the human eye. The forests, seas, rivers, lake mountains and so forth all had their own spirits – good-natured or evil-minde helpful, mischievous or vindictive beings. In the forms created by human though they were visible to clairvoyants. Many even believed that the elemental spirits rule over and regulated the thriving of nature, that animal and plant life was dependent on the vigilance of these creatures. Since all natural life is subject to establishe laws, it is easy to see that all such beliefs belong to the world of fantasy. Gradual as human spirits mature, as their insight deepens and they lose all belief in independently thinking and acting elemental spirits, and as these spirits therefore no long occupy their thoughts, the phantoms will dissolve and disappear.

Since all formerly earthbound spirits have been removed from the Earth, possessions by these spirits can no longer take place. If person now appears to be possessed, the reason for that person malicious, evil or irrational behaviour must be sought elsewhere. Three categories are described in the following:

1) One of the Eldest is bound to that person's body. (Many of the Eldest are at present still incarnated among human beings).

2) Split personality, i.e., memories from previous lives on Eart emerge in the person's consciousness, causing the individual regress to one or more of its earlier personalities. This can occi where the insulation layer between the spirit and the body has bee damaged by the incursions of Darkness, often brought about by the individual's own evil thoughts and sinful way of life; or this may to due to the misuse of mediumistic talent.

While the spirits of the dead remained on the plane of the Earth, sp personalities¹ often originated from their malignant possession of human being The "dead" would thrust aside the spirit bound to the relevant body and then assume its place. But since the parasitic spirit was not bound by the life-giving cord, its energy would sooner or later weaken, thus obliging it to return the borrowed body to its rightful owner, who would only partly have been able to make contact with the brain of its physical body during the possession. The spirit that had thus been temporarily thrust aside could usually remember that it had shared its physical body with one or more intruding personalities. But in some cases the person had no recollection of having been seized by a parasitic spirit.

3) Radiations from accumulations of Darkness that gather around the individual, attracted by the Darkness emitting from that individual's personality. The encounter between these two forms of Darkness will then result in evil and impure thoughts or in criminal acts.

There is often a fourth category, in which the spirit that is bound to the physical body is not normally responsible for what happens. For example, if the physical brain has been damaged in some way by concussion, sickness or old age, the spirit cannot enter into communication with the brain and therefore loses some and occasionally all controlling power, and the person is no longer "himself", i.e., he loses his individual personality.

At the time when the Youngest at God's request decided to let themselves be incarnated on Earth, the human beings were still few in number, but they lived scattered over large parts of the Globe.

Since the Eldest had endowed them with almost no means of sustaining and defending themselves, their struggle for survival carried off thousands upon thousands of them at a very young age.

Several of the human types then existing were of such a low order that there was but the smallest possibility of leading these human creatures forward to greater spiritual maturity and greater bodily refinement, for which reason the Youngest from the outset declined to be incarnated among them. A few types were then selected, and the Youngest embarked on the monumental task of leading human beings out of Darkness and forward toward their Father's Kingdom.

Thus there are races of human beings in whose midst the Youngest have *never* been incarnated. The spiritual level that has now been attained by a number of these primitive beings is reached with the help of the divine element<sup>2</sup> that is given to every human being at the **7.2**

moment of conception, and which always at each new incarnation endows the human spirit with a further spiritual enhancement. New-ly created and young spirits are mostly incarnated among these primitive or fairly primitive peoples. Gradually, as God's need of these peoples for the first incarnations of human spirits diminishes, they will slowly become extinct.

When the first incarnations among the more primitive peoples have been concluded, as the spirit matures and its will becomes stronger, it is incarnated among more highly developed and finally among the most advanced human races. This happens so that the spirit in every aspect of life can learn to overcome evil in all its various forms. The human spirit must in this way experience all that is offered by life on Earth and thereby achieve a many-sided tevelopment of thought and will, at though allowance must be made for the natural limitation that follows from the fact that a male spirit is always bound to a male body, and a female spirit to a female body. (However, exceptions to this rule have occurred with the unlawful incarnation of the Eldest. See Commentary, pp. 201-02).

Through millions of years, inconceivably slowly, step by step and generation after generation the Youngest led human beings forward gradually providing them with new and greater knowledge, and with more and more aids and implements for use in everyday life.

In the beginning and through many ages the Youngest in their human existence were only little higher than human beings in intelligence and in spiritual development. Through their sense of beauty the female Youngest that were bound to earthly women endowed their progeny with ever greater bodily refinement.

At a certain time in the prehistoric past the Eldest began in manifold ways to oppose and hinder the Youngest in their efforts by constantly drawing across the Earth more and more of the Darkness from the ravaged Kingdom, and by directing it to the places where the greatest human progress was evident.

As stated previously, the first truly civilized realm, which developed after millions of years, was situated in the Pacific Ocean. But many thousands of years before this realm was destroyed and disint tegrated into island groups, the process of civilization had started is other places on Earth, for example on the Island in the Atlantic Ocean, in the eastern part of Central Africa and in a few places in Asia.

After the demise of the Island, the work of the Youngest was transferred mainly to northern and to eastern Africa and to the interior and southern parts of Asia.

At that time the majority of human beings still led a predominantly nomadic life, with no formal leadership. (The elders of the tribes usually acted as leaders in any tribal affairs). Laboriously they migrated with their cattle over vast distances; and thus were widely spread across the Earth many of the families that through the repeated incarnations of the Youngest had been endowed with greater nobility and beauty, both spiritually and physically, than had their forefathers. These families intermingled again with the peoples already living in the places where the wanderers settled for longer or shorter periods of their nomadic lives. The spiritual level of these peoples was higher or lower according to whether or not the Youngest had been incarnated among them. Through blood relations between the nomads and the original settlers there arose new human types, new races; some families were improved by this interbreeding, others degenerated and met with extinction.

When also the African realm perished and its inhabitants fled to various other places, the Youngest transferred their efforts to northeastern Africa – the area later to become Egypt – while a new process of civilization was begun in the southern part of Europe, and the work already under way in Asia was continued.

Until about half a century before the destruction of the Atlantic Island, the Youngest, despite the opposition of the Eldest, had brought all the peoples of the Earth, with the exception of the most primitive, forward in a reasonably straight line. But from the moment when the Eldest presumptuously began to incarnate themselves, they were able to offer an even stronger resistance to the Youngest, since the Eldest as human beings more easily gained power over their weak and immature fellow beings, with the result that the slow and relatively even progress of civilization and of the Light was supplanted by an erratic sequence of advance and retreat. For since the Eldest, as related in Ardor's Account, sought incarnation as human beings primarily where they could best achieve high positions1 that would presumably satisfy their lust for earthly power and their urge to dominate, and since the great spiritual strength that was due to their inadequate insulation layer was especially prominent against the background of the low spiritual level of the weakly devel-
