

brittle", disintegrating straight away inside the cameras.

Jarikov said that other recent visitors to the site had managed to see the remains of a military helicopter - identified as an *Mi-8* with coloured and painted camouflage.

Jarikov says that apparently this Russian helicopter had flown very close to the wreckage of the UFO and had been destroyed (the precise method of the destruction not being identified).

Jarikov also writes: "The skid-track of the craft along the ground is about 800 to 1,000 metres long, and is clearly visible... it must also be completely visible from Space.

The craft's course was from due west to due east, flying on a very level trajectory. And, if we are not mistaken, its size really is 620m long and 120m wide".

Jarikov emphasised that the size of the craft and the big and evident skid-marks would have rendered it clearly visible to satellites. Because they have not been able to take photographs at ground level, he says, the Russian investigators were hoping that photographs taken from satellites could possibly eventually be released to the public and that this would finally confirm the *whereabouts* of the crash. ■

MORE ANIMAL MUTILATIONS IN SPAIN.
THE ASTONISHING "DEPREDATOR" OF LERIN
(NAVARRA PROVINCE, N.E. SPAIN.)

During the night of 8/9 October 1998, a sheep-pen owned by Natalio Rodríguez at Lerin, 22 kms. from Estella, in the Valley of the River Ebro, (Province of Navarra, N.E. Spain) was invaded by a mysterious animal that left some 25 sheep dead in very strange circumstances. The farmer had a total of almost 900 sheep there, in two pens, one pen with a stone -adobe surrounding wall (which was the one entered), and the other, containing 400 sheep, with a wire surrounding fence.

The slaughter could well have been far greater, but in the stone-walled pen the sheep, in panic, broke down the gate and escaped. As they fled, the attacker killed 11 or 12, their bodies being found over an area of almost 800 m. from the pen.

Our MIZAR investigations team found strange and most disturbing physical features in this case -features that link the case to others that occurred, in the River Ebro Valley, at Hecho, and Ansó, and at Falces, in the mid-1900s.

Firstly, the footprint of the killer was of a most unusual and abnormally large size, far too big to be of a wild dog or a wolf -it was 16 cms. long and 11 cms, wide, and 4 cms deep, with no pad (?) (almohadillo) and no signs of a fetlock such as would be a feature common to the hind legs of dogs. And the paws were more "claw-like" than dogs' paws are. These tracks were found over a radius of 600 m.

But even more astonishing was the result of our study of the predator's methods, because it had attacked only the sheep that were in the stone-and-adobe walled pen and not those in the wire-fenced pen. This, as the farmer points out, indicates *intelligence* on the part of the attacker: it chose to go for the pen out of which it would

be most difficult for the sheep to escape. (The stone/adobe wall is 1.55 m in height). After finishing off the victims it had caught inside that pen it pursued the rest of the escaping sheep over a radius of up to 600 m or 800 m. This shows a most unusual capacity for killing -ALMOST AS IF, SO IT SEEMS, THE PREDATOR HAD THE ABILITY TO PARALYZE THE FLEEING ANIMALS!

We made a study of those sheep that were merely wounded (they died later) and found that their injuries were *identical* with those on the dead sheep. That is to say, ALL HAD TWO SINGLE WOUNDS ON THE SAME SIDE OF THE NECK and no other marks or claw-scratch or fang-mark on any other part of the body (udders, rumps, etc.) And the two wound-marks were always rhomboidal in appearance, 2 X 4 cms., and very close together -far too close together to be from the teeth of dogs or of wolves) and of a blackish colour, the animals subsequently dying of infection.

AND THERE WAS A TOTAL ABSENCE OF ANY TEARING OF THE SKIN OR ANY REMOVAL OF SKIN OR FLESH. MOREOVER THE ATTACKER HAD NOT DEVOURED A SINGLE MORSEL OF ANY OF THE FLESH OF THE SHEEP -SURELY A VERY ILLOGICAL THING SEEING THAT WHEN A PREDATOR ATTACKS IT DOES IT IN ORDER TO EAT -NOT TO AMUSE ITSELF! FINALLY, THERE WAS NOT ONE SINGLE DROP OF BLOOD ANYWHERE - NOT EVEN AROUND THE WOUNDS, WHEREAS NORMALLY, WHENEVER SHEEP ARE ATTACKED THERE IS A COPIOUS SEEPAGE OF BLOOD FROM THE WOUNDS.

THE OFFICIAL "EXPLANATION".

The Provincial Government of Navarra's official version says that it was the work of "dogs that have gone wild". But the farmers reject such a theory, and prefer to think it was *a wolf* -which, incidentally, *is a protected species now*, and official compensation is paid for wolf attacks on farms!

But, as we have observed it, *the physical evidence fits neither of these two theories*. The marks on the necks of the sheep are of a clinical, *well-nigh surgical* efficiency, and a wolf or dog would be unlikely to have left no scratching or tearing on the corpse however slight the resistance that the animal might have put up. The fangs would always have removed skin, or wool, or flesh, and would not have left wounds *so clear and so perforative* as in this case!

A dog would always use all of its four canine teeth in order to grip the victim's neck and open it up, and wouldn't only put in two teeth! Nor would the two wound holes be set so close together as the photographs show.

Finally, in all attacks of this sort, by wolves or dogs, there are *always* abundant traces of *blood* -particularly so when "wild dogs" (feral, which are more "amateurish" - less expert) are involved.

With regard to *wolves*, officially the wolf is *extinct* in the Province of Navarra, but of course they could come in from other regions near by.

But then -*since when* did a wolf make its attack using only two teeth and not the four, and leave no marks whatsoever elsewhere on the body, extracting its fangs so neatly from the wound without even the most minimal scratch or tear AND THEN EATING ABSOLUTELY NONE OF THE FLESH (whereas the normal pattern is that the wolf only attacks farm animals when there are none of the usual small animals for it in that particular place). And since when did wolves leave not a spot of blood?

And how is it that its footprints are double the width of the normal footprints of a wolf -which would be a about 8 cms.?

And why -if it is a wolf- does it not attack the flocks of sheep in the mountain regions, closest to its own habitat, instead of coming down onto the cereal-growing plains. AND, WHEN IT COMES, WHY DOES IT NOT EVEN EAT ANYTHING!

Spain's top naturalist, Dr. Felix Rodríguez de La Fuente, has stated in his documentaries that the wolf, in

its evolution, has developed a powerful cervical musculature so as to be able to tear and sever the blood vessels of its victim's throat and kill it -all brought about with an abundant -and logical- flow of *blood*.

Summing up then, we must relate this case to other cases that have occurred along the banks of the River Ebro in the Province of Aragón and on the Iberian Cordillera - *all of them pointing to the action of animals of unknown characteristics and of unknown origins*.

So far, we do not know of any UFO activity reported lately in the Lerin region, but the physical features encountered (and which are viewed as "disturbing" by the zoologists and veterinarians whom our MIZAR Group have consulted) put one in mind of "*anomalous genetic canine mutations*," (such as the "BEAST OF GEVAUDAN that ravaged the south of France in the 18th century), or put one in mind of "*strange products of genetic experimentation*" by private laboratories, or Governmental agencies possessing state-of-the-art technology (i.e. the clinical aspect of the wounds), or maybe military agencies of the Government. *In any case, the fact remains that, over the entire subject, there reigns a total silence, and not a single thing is being done to solve the situation*.

NOTE BY EDITOR OF FSR.

An excellent report! But the fact that these new young Spanish investigators waste time on even talking about "genetic mutations" and "genetic experiments" (a sop of course to the majority opinion in Spain which probably is much less well informed than the current opinion in other western countries) indicates that maybe they are a little timid still and unsure of their ground. But there is no conceivable justification for such waffle. The plain fact is that, for some years past, Spain too has had its share of *chupacabras* or of some other exotic and sinister creature of similar habits, and as our many reports from Puerto Rico have shown, *all these phenomena are directly related to UFOs*.
