

Le 4 octobre 1972, entre 3:15 et 3:55 du matin, à Buenos-Aires, M. Gilberto G. LE RECIT

EN ITALIE

Observation et photo le 28-8-1971 à 21:30 légale entre Catanzaro (38,50 N - 16,36 E) et Vibo Marina, à 1 km de cette dernière. Le témoin 16 ans, son père, son frère, son oncle présents, ont réclamé l'anonymat. Ils ont la caution du « Centro Unico Nazionale » et nous avons reçu avec la photo, son autorisation de publication.

Les témoins étaient de retour d'une promenade en voiture de Cantazaro, quand près de Vibo ils aperçoivent une lumière qui se déplace de la terre vers la mer sur une trajectoire SE-NO, entre 30 et 45° sur l'horizon. Le 10 juin 1973, aux environs de 19:55, au moment où elles roulaient dans une Citroën 2 CV, Mme Norma de Marco (propriétaire du véhicule) et Mme Haydee de Arlegain aperçurent un objet non identifié, se déplaçant de N-O à S-E, en l'espace de quelques secondes.

Ces deux personnes circulaient en voiture dans la rue Montevideo, vers le S, et purent distinguer dans le ciel, à une cinquantaine de mètres de hauteur (d'après les estimations) au dessus du toit des constructions, un objet circulaire, légèrement étiré vers les pointes, qui se déplaçait à une vitesse modérée vers Colonia Italiana. L'objet semblait tourner sur lui-même, changeant de couleurs, avec une prédominance de vert. Sa dimension apparente était d'une vingtaine de centimètres.

En même temps que Mme de Marco et Mme de Arlegain, M. Ezequiel Arlegain, époux de la seconde, roulait dans sa Chevrolet Rally-Sport

(modèle 1970), dans la rue Reconquista (parallèle à la rue Montevideo) en direction du S, à une heure coïncidant avec celle de l'observation précédente, et put observer le même phénomène. En arrivant au croisement de la rue Reconquista avec la rue Rioja, il arrêta sa voiture pour demander à son épouse et à Mme de Marco qui avaient tourné par cette dernière rue si elles avaient pu apercevoir le phénomène ; celles-ci lui détaillèrent leur observation qui coïncidait parfaitement avec la sienne.

Antérieurement, aux alentours de 17:45, M. Ramon Gedey, faisant partie du groupe EXO, alors qu'il se reposait dans sa chambre, put observer à travers les fentes de la persienne, deux pulsations lumineuses de couleur rougeâtre (genre infrarouge) qui inondèrent la pièce.

A ce moment-là, il ne donna aucune importance au fait, mais après avoir eu un entretien avec le couple Arlegain et Mme de Marco, il déduisit que les deux observations pourraient avoir un rapport entre elles.

Seven years after it had been investigated by a Rio de Janeiro journalist and a doctor, the story of the famous Antonio Villas Boas case of Brazil was first made known to the English-speaking world by the London journal *Flying Saucer Review* (FSR)*. That was in January 1965, and many people who read the account were inclined to doubt and scoff. After all, a semi-literate farmer from the backwoods claimed that he had been overpowered by beings from a landed "saucer," taken aboard and subjected to cleansing and medical tests which included taking of blood samples. Then, he said, he had been seduced by the female "captain" of the craft!

In the light of accumulating evidence, however, the Antonio Villas Boas case is now seen to be but one important cog in a mass of "machinery."

Blood and Sperm Samples Taken

We have recently learned of the remarkable claims of Gilberto Cocciali of Buenos Aires, Argentina. The story came to us from the French journal *Lumieres dans la Nuit*. Senor Cocciali, a 50-year-old half-educated construction worker said he was awakened by a noise at about 3:15 a.m. on Oct. 4, 1972. At first he thought this was caused by his dog returning from a nocturnal jaunt. However, when he went to the door to see for himself, he was confronted by a dazzling light which temporarily blinded him. He also lost all idea of time and place as well as any thought or idea of action. He says he was taken—how, he cannot recall—to a "laboratory" which had a huge central lamp.

In this laboratory—whether it was aboard a craft, or whether it was somewhere on Earth, he couldn't tell—he was aware of several "intelligent beings" that moved around him without speaking. (He

was also aware of a feeling that he should not be afraid.) The beings which, he said, were clad in green garb, were about 7½ feet tall, with slender profiles, and very long, wide chins. With a sharp pointed pencil-like instrument they took blood from the fourth finger of his left hand; then they took a sperm sample. After both samples were carefully placed into receptacles he lost consciousness. When he came too he found he was back home, and the time was 3:55 a.m.

Twelve days later, Senor Cocciali became aware of dull pains at the base of his neck. Soon afterwards he found that he was beginning to acquire knowledge in the realm of pure sciences such as physics and astronomy, and of philosophy—subjects that had been completely beyond the understanding of this building site laborer.

"A Hitchhiker From Space"

Senor Cocciali's account brings to mind another report from Argentina of an event said to have occurred several weeks earlier. Auto mechanic Eduardo Dedeu, of Bahia Blanca, described to the police a bizarre encounter he had at about 3 a.m. on Aug. 28, 1972. He was driving home from a dinner party at Medanos. When he stopped his old 1939 Ford to adjust the radio aerial, a person wearing a high-necked coat and a roundish hat signaled to him for a lift. Senor Dedeu agreed.

As he continued his drive, Dedeu saw that his passenger had a very long, deep chin. He asked him 2 or 3 simple questions, but the hitchhiker's mumbled replies were lost in the sound of the radio and were incomprehensible. Thinking his guest might be shy, Dedeu drove on until suddenly they came upon an object which he first thought to be a bus lying on its side in the road. Dedeu said he got out of his car, only to be dazzled instantly by a bright light. He also felt a surge of heat and ducked down behind the open car door for shelter. The object, now displaying white lights from its "windows," and a green light underneath, moved away rapidly to the left. When Dedeu jumped back into his car his strange passenger was gone. He was left with an uneasy impression that he had picked up a "hitchhiker from space."



cidents in South America. In 1968, there was a remarkable report from Mendoza, Argentina, in which we learned of the strange experience of 2 casino workers, Senors Peccinetti and Villegas. The latter was driving them home from work in his Chevrolet at 3:30 a.m. on Sept. 1, 1968, when the car suddenly ground to a halt. Villegas got out to check what might be wrong, and as he was joined by Peccinetti they found themselves confronted by 5 human-shaped "persons" who had very large, hairless heads. These beings were standing near an oval-shaped craft which appeared to be "floating" in the air. The creatures, who were clad in overalls, crossed a wide roadside ditch as though walking on a bridge—except that there was no bridge!

The casino workers said afterwards that they were instructed not to be frightened, and that this consoling message came from a voice that seemed to be right in their ears. This was followed by a lecture on elementary astronomy, mathematics, and planetary life systems and the finer points were illustrated by one of the entities who, armed with a kind of torch, etched a number of drawings and symbols on the doors and windshield of the car. Villegas and his companion watched this performance with a sense of helpless stupefaction. A "film" show followed on a screen that simply appeared close to the hovering object. The subject of the show was a warning against the world's misuse of nuclear power. The 2 young men stated that after this the fingers of their left hands were pricked 3 times. This operation completed, the creatures ascended along a light beam and entered the craft which, as soon as they were "aboard," shot skywards.

Frightened beyond belief, Villegas and Peccinetti ran to a nearby military unit and gasped out their story to the guards on duty.

Official Reactions

Hundreds of similar reports are on record from many parts of the globe, and the beings' behavior is now beginning to fall into a pattern. It should be remem-

bered that very few of the witnesses know, or are even able to read about the experiences of other witnesses, and that these witnesses largely come from the ranks of ordinary people. Quite often they later wish that they had kept their experiences to themselves. For instance, Peccinetti and Villegas were ridiculed in the local and national press which had at first gleefully published sensational accounts of the story and photographs of detectives carefully examining the inscriptions on the car. The same papers carried statements containing thinly-veiled threats by the police against other would-be reporters of saucer encounters. (Echoes of the sort of thing that have happened elsewhere in the world.) Yet there is one poor old illiterate in Argentina who has had a shattering UFO experience, but whose case has been studied zealously by local authorities.

(If readers wonder why there are so many cases from South America, the answer simply is that a "wave" is currently in progress down there; just as there have been waves, or peaks of activity, in the U.S., Canada, France, Italy, Spain, Scandinavia, and so on, at varying times.)

The Seer of Tres Arroyos

The Argentinian town of Tres Arroyos is about 300 miles south of Buenos Aires. There have been several strange incidents there recently, but none so strange as that experienced by Ventura Maceiras.

At about 10:20 p.m. on Dec. 30, 1972, this virtually illiterate 73-year-old *gaucho*, was sitting outside his shack beyond the fringes of the town, sipping *mate*. He is a caretaker, and his life is poor and frugal; he has no television to watch, never goes to the movies, and cannot read other than the simplest words. He does have a transistor radio capable only of picking up the local music broadcasts, and on the evening in question he was listening to this meager entertainment when it suddenly began to fade. He was thumping the radio set when he heard a loud buzzing and became aware of a brilliant light that came from a huge object hovering above him. Tubes below this object threw off sparks, and a "wheel" spun around the rim. There was a cabin with windows, and when the UFO tilted he saw two occupants, wearing gray clothing, and helmets with tubes to boxes on their backs. These beings had slanted eyes, and thin-lipped mouths. Maceiras could also see an instrument panel and a banner bearing what looked like a crowned seahorse and other symbols.

As the UFO descended there was a blaze of light, increased buzzing, and then it moved off to the northeast leaving behind a smell of sulphur. Within 3 hours Maceiras became very ill. After tinglings in his legs, he developed violent headaches which lasted 2 weeks and for 4 days was subject to bouts of diarrhea, nausea, and vomiting. He also broke out in spots, lost handfuls of hair, and developed a stammer. The case was reported to the local authorities and Maceiras, after questioning by the police, doctors, and engineers, was put under constant clinical and psychiatric supervision. His mental state was reported as lucid, and there were no contradictions in his many spontaneous replies to questions.

Now for the most amazing development of all:

Since Feb. 10, 1973, Maceiras was found to be growing a new set of teeth, and displaying other signs of rejuvenation. From 45 days after his encounter, this man, who could barely write his name, has startled doctors and investigators by discussing philosophy, theology, and astronomy, performing instant conversions of distances in kilometers to miles, and is predicting cataclysmic upheavals and other events. He also discusses medicine, and gives new, radical cures for diseases—even cancer.

Senor Cocciali, it seems, is not alone in his acquisition of new knowledge!

The Science Benders

The new breed of contactees are proving to be science benders. The "messages to mankind" may still be around, but we seem to have moved out of the "trip to the Moon" era, and into the age of blood samples, medical examinations, and instant encyclopedic knowledge. What, too, of the greatest "bender" of them all, Israeli-born Uri Geller? On Nov. 23, 1973, before a British TV audience of 15 million, and in the presence of university professors, Uri, in a live broadcast performed remarkable feats of telepathy and watch "repairing" by the power of the mind. He also stroked with his finger tips 2 forks held lightly by the TV interviewer, and seen close up throughout. The forks began to bend, and untouched, continued to do so until the prongs dropped off. Uri claims he gets his powers from UFO entities.

Bearing in mind all the other cases reported to us, it seems that some unusual power is attempting to break through to mankind. Whether or not it is a good force remains to be seen. What is certain is that we must learn more about it.

BUENOS AIRES BUILDER ALLEGEDLY KIDNAPPED BY ENTITIES

Translation from *Lumières dans la Nuit* No. 129 (November 1973) by Gordon Creighton

ON October 4, 1972, between 3.15 and 3.55 a.m., at Buenos Aires, Gilberto G. Cocciali, an uneducated 50-year-old building worker, claims to have been kidnapped by several large beings of human form, with long chins and wearing olive-green uniforms, who took from him blood and sperm. Subsequently he experienced deleterious effects as a result of the experience, but also acquired a new knowledge of scientific matters "through revelation" (interior revelation?). The case also involves reaction by animals.

St. Cocciali's account

On October 4, 1972, at about 3.15 in the early morning, Cocciali suddenly awoke from deep sleep, having heard some sounds coming from the entrance door to his house — sounds which, as he thought, might have been caused by his very strong and sturdy dog, a bitch 45 cms. in height, aged about nine months, which every night was in the habit of escaping from the house by jumping over the fence (1.50 or 1.60 metres) and then returning by the same route in the early hours of the morning.

As he approached the front door however to open it, he was dazzled and completely blinded by an extremely intense "light" of which he was unable to determine whether it was coming from a "concentrated beam" or was of a more widespread and extensive nature. All he knew was that this light was most intense and that he was totally blinded by it.

From that instant onwards, Cocciali, who is big and robustly built, and thickset, used to heavy building construction jobs, and possessed of only a primary school education, but in normal mental health and having had no physical or mental disease (apart from an operation—already long healed—for a stomach ulcer) completely lost all notion of time or place. Any thought or any idea of any action, or of anything else, melted away in his mind. Although he does not recall how or by what means or "by what kinds of intelligence," he was conveyed to a sort of large room, which he calls a "Laboratory," and which was all brightly lit up, with a huge central lamp that threw an indirect light, resembling a neon or fluorescent type of apparatus.

In this "laboratory" as he called it (he is unable to say whether it might have been the inside of an aerial craft or somewhere on this earth) he observed, fully conscious and quite sure of what he is seeing, several "Intelligent Beings" which were moving about around him but which did not speak. (He had a mental feeling that he had no cause to be afraid.)

The following report was received from Sr. Antonio O. Perez Aléman of Córdoba (Argentina) and forwarded to *Lumières Dans La Nuit* by our good friend and FSR reader S. Ignacio Darnaude of Seville. (The Editor of LDLN states that he has asked Sr. Perez Aléman for further details.)

Their forms were completely human, but they were from 2.20 metres to 2.30 metres in height, with extremely long, slender profiles, the size of their waists being scarcely as much as 25-30 cms. Their chins were wide and very long. (He made some sketches, but LDLN have apparently not yet received these. —G.C.

All these "Intelligent Beings", of whom he is unable to say how many there were, whether 5, or 10, all of the same height and all with the same features, were clad in a strange garb which seemed to him to be a sort of dark olive-green coloured uniform.

At once several of them made a start by extracting blood from the middle of the fourth finger on his left hand, by means of a device resembling a thick pencil with a point. It caused no pain. Then, after that, they took from him sperm, which they put carefully into a receptacle, as they had done with the blood.

Inside the "laboratory", which was constructed entirely of metal, he was able to observe various things which seemed to him to be "apparatus and instruments", the names or purposes of which he could not say, but which he thought were for research.

At that point, he again lost all sense of time or place, and knew no more until he recovered consciousness and found himself in his home again, at 3.55 a.m., in other words 40 minutes after he had left there.

Subsequently, he began to notice a number of strange and important facts. For example the finger, and the whole of his left hand as well, kept swelling up at irregular intervals...

Twelve days later, he became aware of various slight pains in the bottom part of the nape of the neck, i.e., in the upper "cervical centre" of the spinal column; his "intuitive sensitivity" began to undergo an access of perceptivity hitherto unknown to him, and he began to possess knowledge — which he previously had not had — of the pure sciences, such as Physics, Astronomy, and Philosophy, subjects

of which he had been utterly ignorant in his former condition as a building construction labourer.

After the experience his dog began to suffer from long periods of semi-paralyzed immobility, lasting several days at a time, together with pitiful states in which it displayed symptoms of anxiety and fear.
