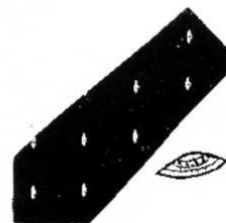

INTERVIEW WITH COL. ROBERT O. DEAN

FORMER NATO COLONEL REVEALS AMAZING SECRETS ABOUT THE UFOS.

"WE ARE IN CONTACT WITH SEVERAL EXTRATERRESTRIAL CIVILIZATIONS"

FOREWORD BY EDITOR, FSR.

This "world-exclusive" interview with Bob Dean appeared in the Madrid publication ESPACIO Y TIEMPO ("SPACE AND TIME") (No. 41) of July 1994 and we have the express consent of the authoress and of her husband to republish it in FSR. We are well aware of the many, many claims that have been made in the field of Ufology and that are still vigorously disputed. Among them unquestionably are the claims of such folk as John Lear, or William Milton Cooper, or Robert Lazar. There are responsible and well qualified people who assure me that there is much truth, or maybe merely some truth, in what these three men have said or written. **On the other hand, there are equally responsible and equally well qualified people who take the opposite view, and dismiss these three sources as disseminators of rubbish.**

My own position is that I can only say that I do not yet know the truth about these questions.

Another activist who falls into this same category is Colonel Robert O. Dean, a retired U.S. Army officer who served in NATO and who claims that while occupying that position he was able to see vitally important and top-secret NATO documents relating to our subject.

I do not know the truth about Col. Dean either. So far as I know, nobody in the USA or Britain has yet come up with supportive evidence that will settle the matter.

I conclude however that our readers will not find it a waste of time to learn what Colonel Dean has to say. He was decorated for his military service in both the Korean and Vietnam Wars and I think I'd rather trust him than a draft-dodger. G.C.

Although it was not public knowledge, a third World War was on the point of breaking out on at least three occasions, due to the incursions of large, circular, metallic objects above the Zones of the NATO allies and of the Warsaw Pact powers, and detected by the radars of both sides.

Due to these incidents, General Lyman Lemnitzer ordered an exhaustive study to clarify the situation and ascertain what was going on. This study lasted for three years, and its conclusions were as unexpected as they were enlightening. Colonel Dean was one of the few persons who had access to *Cosmic Top Secret Clearance*, the highest secret classification — higher than *Top Secret* — and who was able to examine the documents thoroughly.

Today, at the age of 65, Colonel Dean breaks his silence. He knows the risk he runs in violating the oaths that he swore, but, according to what he says, the information in his possession is of vital importance. Mankind, which has been deceived for all these years, ought to know the truth. Therefore, even at the risk of imprisonment, and of being discredited like so many others, or — even worse — at the risk of losing his life, he is daring to share with the readers of ESPACIO Y TIEMPO (SPACE AND TIME) what he considers to be the greatest scientific and political scandal of all time. Accepting the due responsibilities, this is how he has replied to our questions:

M. del A. How was it that you, a career soldier, got involved in the study of the UFOs?

Col. D. I had always been interested in the subject. I was an enquiring sceptic. But it was only when I got assigned to the Supreme NATO Headquarters in Europe, in 1963, that I had access to this type of information. I was attached to the military branch, and while there I became acquainted with a special report that had been compiled on the subject of UFOs. It was the result of a study that had been made because there had been several flights of large round metallic objects over Central Europe... and that state of affairs could easily unleash the third World War owing to the mistaken conclusions that such flights of objects were producing in

the different countries.

The Soviet bloc thought the machines belonged to the NATO allies' side, while of course the latter thought they belonged to the Soviets. Obviously they were objects under intelligent control... they demonstrably possessed great technological capacity and, as I have already said, it wouldn't take much for this situation to unleash a nuclear war

M. del A. When did the NATO study start and why did you have access to it?

Col. D. In 1961 General Lyman Lemnitzer, who was at that time the Supreme Commander of the allied forces of NATO in Europe, finding himself faced with this situation, decided to set up a special multi-disciplinary team inside the military for the purpose of investigating what those objects were, where they came from, and what were their intentions... and that led to the creation of this secret study to which I am referring. The investigation was given the very highest security classification, and the whole object was considered immensely "delicate". It was given the classification of *Cosmic Top Secret Clearance*. It began in 1961, ending in 1964, and it was one of the most complete studies that I personally was ever able to see. The information to which I had access surprised me extraordinarily and alarmed me.

M. del A. Before you go any further I'd like you to give a little more explanation of the difference between *Top Secret* and *Cosmic Top Secret Clearance*, because the latter is much less known.

Col. D. *Cosmic Top Secret* — this type of classification was created in NATO in Europe and was used in those days in the Supreme Headquarters Allied Powers Europe (SHAPE), located outside Paris. Nowadays this classification is already also in use elsewhere in parts of the USA, but originally it was created for SHAPE, and is a type of secrecy classification far above the ordinary usual grading known at *Top Secret*. I was one of the few persons who had access to reports classified as *Cosmic Top Secret*.

When the study ended in 1964 the final Report was more than eight inches (20 centimetres) thick, and furthermore there was another Volume of the same size consisting solely of Annexes concerning the reports included in the original study. Also there were photographs, and sketches... these appendices which completed the investigation results consisted of ten principal sections. One of these sections contained everything known about the effects of radar and of electromagnetism. Another dealt with the analyses of light and optics relating to the objects. Another dealt solely and extensively with the evidence for the subject and the history of its investigation.

Yet another appendix contained the technical and metallurgical analyses of the craft and the related meteorological studies and studies of atmospheric physics. Another appendix dealt with the biological analyses of the beings connected with or involved with the craft, including *autopsies*.

Another of the sections dealt with the thorough

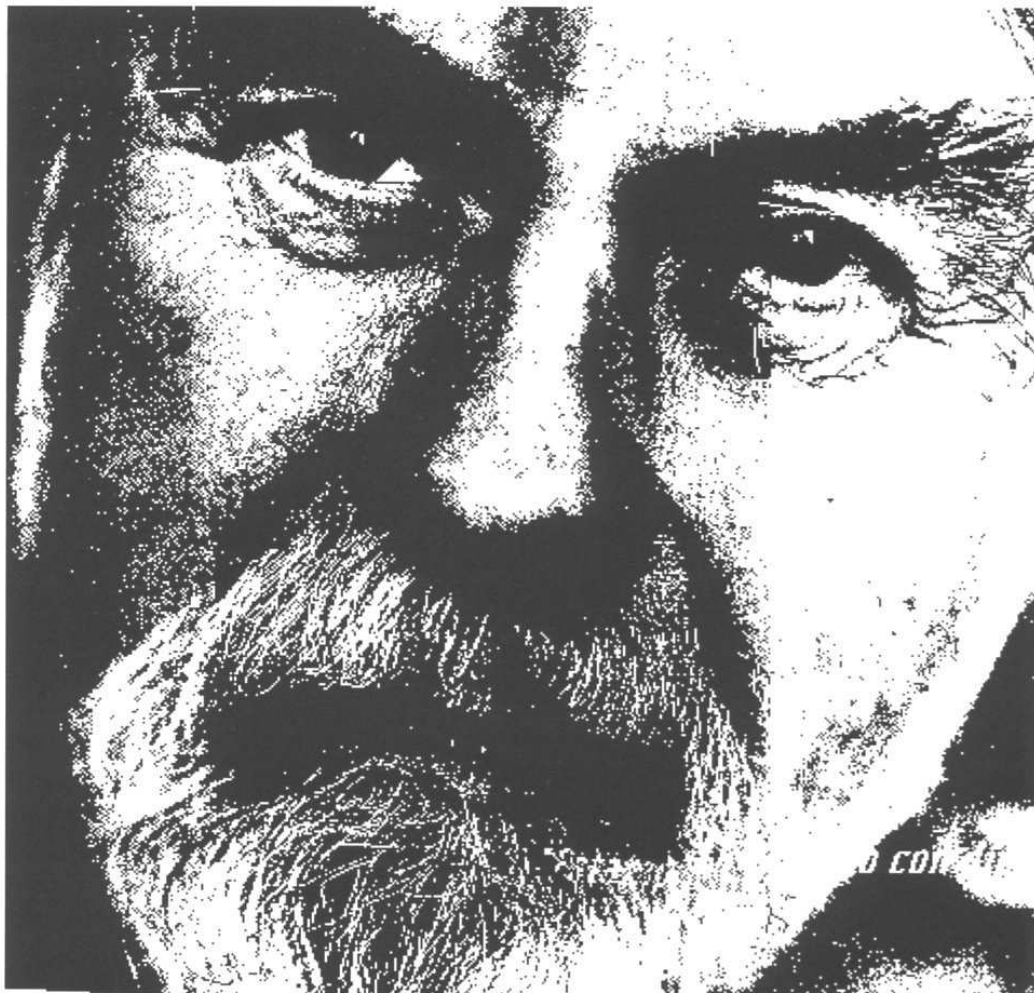
study of the implications and the social aspects and the impact that all this could have upon society..., and psychological analyses of the phenomenon.

And, finally, there was a concluding appendix, which I consider one of the most important, containing the implications at a *world-level*, and the long-term, teleological connotations of the information contained in the study. It is impossible to describe the effect that the knowledge derived from the reading of that study had on me. In fact, what I managed to learn about that exhaustive investigation totally changed my life and for ever.

M. del A. What conclusions did the study arrive at? And incidentally what transcendental truths emerged therefrom, so that you would be brought to reconsider all your previous concepts about life?

Col. D. For the first time I became aware that we are not alone, but that there are other intelligent beings here with us... and that the human race is not alone. And, replying to your question, I must say that the conclusions contained in that study that ended in 1964 basically reported and demonstrated that:

1. Planet Earth and the whole human race are, and have always been, under an intense and massive examination by a number of extraterrestrial civilizations. That Study was extremely complete and detailed.
2. Those other civilizations have demonstrated not only that they possess high intelligence but also a supremely advanced technology which could be maybe hundreds if not indeed thousands of years ahead of ours.
3. The evidence obtained and analyzed by the investigation indicates that apparently some process or plan is being developed, and that they are continually demonstrating that they are carrying through to completion some programme of theirs relating to the human race.
4. The evidence in that Report leads to the conclusion that those extraterrestrial civilizations have been studying us for a long time, possibly for some thousands of years.
5. The conclusion of the military analysts was that, so far, there seemed to be no military threat in the situation... that those beings did not have hostile intentions towards us. Everything seems to indicate that if they did have malevolent intentions, there would be nothing whatsoever that we could do to defend



ourselves. We would not be capable of fighting them.

6. NATO and the politics of SHAPE indicated that the study was continuing to be pursued through various military committees and that the military authorities of the various countries should pledge themselves to furnish the bulk of the resources required.
7. The entire subject was considered to be of the very greatest importance and supremely "delicate". The Committee recommended that the highest level of classification should be imposed upon the matter. Although in fact the Supreme Commander, General Lemnitzer, had already classified it under the category of *Cosmic Top Secret*.

M. del A. I can see that the reading of official reports of this calibre must give a shock to anyone having access to them. Specifically, in your case, what was the point that impressed you most and struck you most deeply?

Col. D. One of the things that made the biggest impact on me was the conclusion that those beings appeared not to have bad intentions towards us, of conquest or anything like that, because, had it been *otherwise*, we would not have been able to do a thing, given their advanced technology.

M. del A. One of the Appendices to the Study spoke specifically of autopsies on non-human beings found in supposedly crashed craft. Did you have access to those reports too? Did you see a complete report on an autopsy?

Col. D. Yes. I had in my hands the entire report on the investigation of a large craft of the "flying saucer"

type that crashed in 1962 at Timmensdorfer, near the Baltic Sea, in Germany. It fell on soft soil, near the Russian frontier, and consequently was not totally destroyed. One-third of it was buried in the ground.

A corps of the British military engineers were the first group of Army officials who were able to enter the craft. Inside it there were twelve dead bodies of the "Greys" type — greyish skin. Extensive autopsies were carried out by British military medical personnel and they discovered (and this was a tremendous surprise to the medical authorities involved in the affair) that the twelve bodies found in the craft were *all identical*, totally identical. They did not appear to have any reproductive system. Likewise they did not seem to have a digestive system like ours, as though they didn't process their food as we do... they had no digestive tract. The conclusions of the study made by those scientists indicated that the creatures seemed to be *laboratory products — some sort of genetic clones perhaps mass-produced*. That was the conclusion reached at the time. I saw all the photos taken of the beings and I couldn't believe it.

Another part of the Study stated that they had come to the conclusion that we had knowledge at that moment in time of *at least four different civilizations* — cultures — intelligences — that were present here on Earth and that were visiting us and interacting with us. One of the most interesting conclusions, and one which struck me most, was that one of the groups — one of the civilizations or cultures that were here on this Planet — *was*

identical with us — or rather, that we were identical with them!

And that made a vast impression on the people involved in the investigation. I longed to get a chance to copy it all down. I took a photograph of the cover of that part of the Report that wasn't actually classified as "Secret", but I didn't intend to end up in gaol in Fort Leavenworth! When I went to the bathroom, however, I took advantage to make some notes very carefully and secretly.

M. del A. All this that you are telling me is a bombshell — coming from you of all people — you who had a high post in the army with access to all that official investigation. Some of the points that you have mentioned were already known to us through certain reports that came to light a few years ago, and in which, apart from a few bits of filtered truth, there was also *disinformation* present. You know what I'm referring to. But all this that you are telling me now is the official conclusions arrived at in the Report by the Army medical personnel who were given the job of making the autopsies, is that not so? What I mean to say is this: *these aren't your own opinions, but that you actually had all this information in your hands?*

Col. D. Yes. And then in addition, after that, I learned that, independently of that Study carried out by the NATO Supreme Headquarters, other studies of the same kind were made by the USA and by England, with them arriving at precisely the same conclusions. I think it is very important to point out that reading that Study had such an impact on my life that ever since then I have devoted myself to investigating this whole business personally, so as to be able to see precisely what it is that it is leading us all to.

M. del A. A few years ago the public learned about the so-called *Dulce Papers*, revealing the existence of an alleged underground base with seven levels, in which extraterrestrial beings and the U.S. Army appeared to be working together. What can you tell me about that?

Col. D. I have no personal knowledge at all about the alleged situation at Dulce. Consequently, I won't venture to comment on it, since I lack any elements for making a judgment. However, I *can* tell you that I have knowledge of enormous — gigantic — subterranean bases constructed by the United States together with England, New Zealand, Australia, and other countries. And I *can* also tell you that I *do* know that in those bases there is contact with at least one group of these extraterrestrial beings.

M. del A. What is important in this case is the fact itself and not the number and the place. You have just told me that in certain bases one type of non-humans are working or are interacting with humans. Does this mean that the old hackneyed story about the alleged *Pact* about which there is so much dispute among Ufologists all over the world is true?

Col. D. Apparently *Yes*; more than that, I would tell you that yes, definitely there is some sort of agreement. Our country, the USA, seems to have an agreement

with at least one or two types of extraterrestrial races. Large numbers of people connected with the National Security Organization (NSA) and the CIA and other Intelligence and Security bodies have already spoken publicly about this. The circumstantial evidence seems to support it too, and we know of at least six bases — big underground bases — where fairly frequently a certain number of the employees of these U.S. Govt. organisations have seen U.S. personnel working together with non-terrestrial beings. Whether that is corroborative of the existence of an actual *pact* with extraterrestrial beings I would not be able to say. Obviously the only people who can make agreements of that sort in the name of the Nation are the members of the U.S. Congress, and, so far as we know, no such agreement exists officially.

Another well known place at present is the region in Nevada — specifically the Groom Lake Base — where the so-called “Area 51” is located. And another very important place where there is a gigantic underground base is right in the middle of Australia, in the region of *Pine Gap*, which, although it is on Australian soil, is administered by the National Security Agency (NSA) of the United States. It is said that probably the same sort of activity is being carried on there too.

M. del A. You have just mentioned “Area 51”, you know — I suppose, of course — everything that has been happening on the Island of Puerto Rico for years past. Do you think that what is going on there is something similar to what you have just told us about? Could there be an “Area 51” in the Cabo Rojo or El Yunque areas of Puerto Rico?

Col. D. Not only is it possible but it is highly probable. According to firm data that I have obtained during my investigations, and that have come to me from persons having access to specific information, it seems that one of the places where the highest level of activity is going on and where there is one of the biggest installations of world dimensions, involving inter-action between U.S. forces and extraterrestrial beings, is indeed precisely Puerto Rico.

M. del A. I know that something very serious is happening in the Island and I have said so in various articles that I have published, but I find it hard to believe that part about the *Pact*. The evidence, which is abundant, seems to incline towards that possibility. But could there perhaps not be another interpretation for what is going on there?

Col. D. Naval personnel of Puerto Rico, and of the USA, and extraterrestrial beings, have been seen interacting very closely — *in a very close relationship*.

M. del A. From where does this information come that you can be so sure?

Col. D. From a group of professionals who have full knowledge of all the facts, who are themselves involved in the situation — among them a body of people to whom I shall not refer by name but whom we can mention generally as “COMM-12”.

They are people with whom I am in contact, who have knowledge of all this business, and who are giving

me information. These persons are connected with Naval Intelligence and that is the only thing that I can tell you at present.

M. del A. Referring to MJ-12, which is considered a wild delirium by one particular line of Ufologists — the “Mufonists” — a fraud invented by the CIA in order to *disinform* — and which many of the Ufologists do not dare even to mention, through fear of falling foul of the “inquisitors”, what can you tell me about *that*?

Does that ultrasecret and extragovernmental group of twelve persons, with unclear intentions, who are supposed to be charged with the job of managing and manipulating everything about the UFO phenomenon — *does it really exist*? Or is it on the contrary, just a fraud?

Col. D. In my opinion, based on certain investigations that I have made, I will say that MJ-12 does not appear to be the official name of an agency investigating this business. I can however say that there is a very powerful group — a group of specific individuals — who control this sort of information and who seem to have a big say as regards the political question of the UFO investigation and all the developments arising from the UFO phenomenon, *whatever name you give to it is not important. What is indeed known is that there is a group of persons who have the total control over all this business. This power group is composed of a gathering of individuals from the highest military, economic, and political spheres — on a world-wide scale, and it is they who really control all information and dictate the policy to be followed.*

M. del A. Could we say that in a certain fashion, they form part of those who “pull the strings” of the world?

Col. D. Yes, we could say that. The original group, which was created by the U.S. Government 50 years ago, *actually was composed of twelve people*. One of the initial codenames for those who knew each other as the group was MAJIC. Since then, the number of persons having access to this special information has grown considerably and it is very probable — on the basis of information that I have been able to check — that there are now about 1,000 individuals who belong to this special organization controlling the UFO business. I hope this information I am giving you *does not create any problems for you* — or create negative situations for you, but I am also going to tell you that another of the names for those who know each other as in this special group is P1-40.

M. del A. What does P1-40 mean?

Col. D. I don’t know. We only know that it is some sort of key — in code — but connected with this matter. I think it is very important that you should understand that, if you are going to publish what I am now telling you, and going to get involved with this sort of information, you must understand clearly that at the present time this is the most “*delicate*” business that there is, and that it is the one that, more than any other, endangers the Governmental security of the world.

M. del A. If that’s how things are, then I’ll take the risk. If what you are revealing to me is the

truth, my duty is to inform my readers of your experiences and your conclusions. I don't have any sort of fear.

Col. D. I praise your courage and your efforts to make my words public. In my opinion, this is at the present moment the most important matter, because the human race on this Earth has the right and also the need to know what is happening.

M. del A. Going back to 1963, I'd like you to go a bit more fully into some or other of the cases investigated by NATO to which you had access.

Col. D. I must be very frank with you and tell you that there are specific details which I have hitherto shared with nobody. I intend to include some of these concrete details in my next book, on which I have been working for the last ten years. In it I am going to produce a synthesis of my thirty years of study of the phenomenon and of its historical, theological, scientific, and political implications. I can tell you that the analysis and study that I have been making on my own account, over those thirty years, goes a lot further than what I read at that time in the Report of the NATO Special Investigation.

M. del A. Can you relate — but in greater depth — any one of the cases mentioned in that Study?

Col. D. One of the incidents that I remember best is what happened in the summer of 1961 in Denmark, at a place called Albort. A farmer and his wife were just about to have their meal when they heard strange noises coming from where their cattle were grazing at that time.

Puzzled, the farmer went to see what was going on, and when he got outside he encountered a round machine about 12 metres wide which had landed there. To his astonishment he beheld a sort of little door open and a ramp came out and two individuals who appeared to be perfectly human emerged and, raising an arm as a sign of peace or greeting, invited him to enter and go for a trip with them, as though they wanted to show him something. The story is interesting, because, far from feeling fear, the man accepted the invitation and entered the craft with them.

The door closed, the legs were drawn in, and off they went for a number of hours — several hours. All this had happened before the astonished eyes of his wife who remained there in the house, waiting.

Although he had gone voluntarily, — very willingly — the wife on the contrary was of course alarmed, so she contacted the local police station and they in turn contacted the Military. Meanwhile, while she was there with the various authorities (who incidentally all totally refused to believe what she was telling them, as they all thought she was a "hysterical case") they were all astounded to see the saucer appearing once more. It descends, out come the three legs, it lands on the ground, the ramp comes out, and out comes the farmer as happy as can be, telling them all to just wait and hear what he has seen, and where he has been. But nobody believed any of it. Apparently the two human-looking beings who had carried off the farmer had intended to demonstrate that they weren't hostile, and weren't going to harm him. After that, the Danish military authorities took the

farmer away and subjected him to intensive interrogations, lasting two weeks, in their endeavour to find out every tiny scrap of his experience.

One important detail is that, during the uproar, while the farmer was explaining to the astonished Military and Police and wife what had happened, the two beings stepped back into the craft and quietly departed! According to the farmer's statement — and this was in the NATO Report — they had taken him away from the Earth and he had been able to see the Planet from Outer Space. The man was very happy indeed about his experience. The treatment he had received from the beings was excellent and they had tried throughout to make him feel very safe and comfortable, *speaking to him in perfect Danish!*

Nevertheless, the Danish Armed Forces upset him quite badly with their treatment of him during the exhausting interrogations to which he was subjected.

M. Del A. When situations like this arise, with military authorities subjecting people to this sort of intensive interrogations (debriefing) what techniques do they employ?

Col. D. Usually an interrogation of that sort involves isolating the person and putting him in a controlled place, normally solitary and *incommunicado*, where he is subjected for a certain time to intensive questioning by various different types of personnel. Firstly by military, then by personnel from the field of psychology and psychiatry, whose job it is to check if the individual has any emotional trouble, then by sociologists — all of them of course *military*. If the interrogation is conducted professionally, there is no need to employ specific drugs, narcosynthesis, and the like... But unfortunately there *are* times when all this sort of stuff — drugs, and all the rest of it — is used in order to extract the desired information. In some cases the psychologists try to convince the individual that the event didn't occur like that, and they use all these means of "debriefing" and drugs and psychological tricks in order to confuse the person's mind and get him to say that the experience never happened.

M. del A. According to what we can deduce from the conclusions of this official NATO Study, the beings who are visiting us are not hostile towards the human race. *Nevertheless, all this is in flat contradiction with the other face of the phenomenon.* What can you tell me about that?

Col. D. *It is an excellent question and for me there is indeed a question-mark here. I am speaking to you on the basis of what I myself have read in the Conclusions of the NATO Study, but certainly the facts that you have mentioned cannot be denied. Yes — in many of the cases where that has happened one can already see perfectly clearly that we aren't talking of only three or four races of beings; we are talking of a broad gamut of intelligences from different places, with different origins, with different intentions and areas of interest as regards the human race and as regards Planet Earth.*

In many cases, when the situations are thoroughly analyzed, it has been possible to see that the alleged physical or emotional damage suffered by individuals *was not*

intentional. It appears in such cases to be derived indeed from the experience, *but not intentionally per se*.

We might say on the other hand that an example of what you were commenting on a moment ago *is what happened in Brazil where, in many parts of the country the phenomena are occurring and people are being affected, damaged, or wounded, by a type of being that seems in its behaviour to have not the slightest scruple towards us*.

This has been quite well studied and documented by such investigators as Jacques Vallée, Bob Pratt, and Salvador Freixedo. This *is* going on, and it is something that disturbs me and worries me greatly. Situations of this sort madden and enrage me. *But they do seem to be a species of beings who — I agree with you — do not care in the slightest whether they harm us or not*.

M. del A. I'd like to go a bit more into the question of the four species of beings mentioned in the official NATO Study to which you had access and that we have been discussing.

Col. D. Regarding that, I have to tell you that, apart from the so-called "Greys" mentioned in the Report, *there were also descriptions of a type of being practically identical with humans... of humanoid appearance too, measuring between 6 and 7 feet (1m.20 — 2m.10) and otherwise they were basically human*.

Another class of being described in the Study corresponded to the "reptilian" type — not in the sense that they were like reptiles, with a scaly skin and shaped like reptiles — but that they had a very rough skin like the skin of lizards. The pupils of their eyes were vertical, and that gave them a "reptilian" look. The Study mentioned that many Police and Military personnel had had encounters with this type of creature.

M. del A. Did the Report also contain autopsies of "reptilian" beings?

Col. D. No. Not of that type. The only report on autopsies that I was able to analyze extensively was the one referring to the big flying saucer that crashed in the Baltic Sea area, where there was mention of creatures of the "Grey" type who had no teeth. They had a sort of membrane in the mouth through which they seemed to absorb some kind of food. They had no defined signs of sex... One significant detail that attracted attention was the emphasis laid on the powerful *smell* emitted by the bodies of the small "Greys". The Report said that it was a supremely disagreeable odour... of decomposition...and it caused nausea in the specialized medical personnel and some of them were made ill by it.

M. del A. There is a rumour that those recovered bodies are still being kept. What can you tell me about that? Is it true?

Col. D. Yes. Both preserved in chemicals and refrigerated.

M. del A. Another rumour suggests that the Government of the USA is holding as prisoners some of those beings found alive in a crashed craft.

Col. D. Some years ago it was being said that the U.S. Government had several of those small captured beings held as prisoners. What finally happened to them

was never made clear. On the contrary, the folk who have had access to the deepest levels of "Area 51" in Nevada indicate that they are *not* prisoners — that is to say, that those beings are totally free and are working in harmony with American personnel. In that case, then, the story about prisoners collapses. They are in open camaraderie.

M. del A. You, as a military man, and as one who is familiar with the U.S. Air Force's aircraft, what can you tell me for those Ufologists who believe that the anomalous craft flying in our air-space *are in reality secret craft but terrestrial ones* — as in the case of the Belgian UFO Wave for which the most foolish theories were invented?

Col. D. What I can tell you about those Ufologists — and I am trying to be kind to them — is that they really are misinformed. They haven't done their homework properly. They don't know all the information that is available, and although it is impossible to deny the very probable fact that the USA does have craft that are a prototype of some or other of those machines — possibly secured by means of reversed engineering, copying some type of technology, the actual fact is that the real UFO craft are very — and I say very — far advanced in relation to us and that it will be at least 500 years before we can have the technology that those alien machines appear to have.

Something that I also wanted to mention to you is that the conclusions reached in the NATO Study showed clearly that we were dealing not only with physical extra-terrestrial beings coming from other places in the Universe, but also with extradimensional beings, extradimensional civilizations, and also that one or other of those extradimensional civilizations and beings had the capacity to alter time and space ... to travel in time, and this is the reason why everything involved in this phenomenon is considered so "delicate", owing to the implications that it can all have for various aspects of our life.

We could talk about this for hours, but we would have to ask ourselves — and also your readers — the following question:

"What would the reaction be if it were known that this is true; that it is really happening, and that we have been receiving visits here by a whole series of cultures, a whole series of extraterrestrial beings, for thousands of years past ... and that, at the same time, we are maintaining a certain type of very intimate relationship with one of those civilizations. Even more — that we are a hybrid race, who have been genetically evolved by very advanced beings from other places in the Universe. That we were "sown" here on this Planet, and that our Authorities know all this? This precisely is one of the features that they don't want to reveal to the public because they would not know how to handle the situation!!

M. del A. Have you suffered any threats because of what you know and what you can tell?

Col. D. I haven't been *directly* threatened, but a number of things have happened to me as though "to let me know" that somebody doesn't like what I am doing.

EXTRATERRESTRIAL VAMPIRES IN THE AMAZON REGION OF BRAZIL

The year is 1977. Strange happenings are beginning to produce disquiet in numerous villages and settlements of Northern Brazil. Nobody ventures out of doors at night. The people of the backwoods, (*Caboclos*, the local word for a half-breed Brazilian), believe that beings from another world are at large here, and are searching for human blood. The victims are struck by a mysterious light which can penetrate anything and lets none escape.

The Brazilian Air Force is studying the phenomenon, and is sending teams from the First Air Zone Command (1 COMAR) into the interior of Pará Province and secretly documenting everything. They hear the testimony of hundreds of people, and all tell the same story: about the "vampire light" (*a luz chupa-chupa*).

The book constitutes impressive evidence furnished by doctors, journalists, soldiers, and rural "Caboclos", all describing unbelievable facts and demonstrating that the limits of our "Reality" are far wider than our reason supposes.

The author has selected his material scrupulously, never distorting the reports however strange they might appear to be, and he courageously denounces on the one hand the official policy of "cover-up", and on the other hand the indifference of the so-called scientific institutions in the face of events of this nature — or of anything else that might disturb the world order. An astonishing book about one of the greatest enigmas as encountered by the population of Amazonia.

FOREWORD

The Flying Saucers are the Masters of their own Mystery — an enigma which grows with every sighting and which, in an obscure way, is already having a decisive effect on our world, physically, socially and psychologically.

The principal events described here occurred in 1977 and in a remote region, difficult to reach, compris-

ing the Brazilian Atlantic Coast and part of the Amazonian Forest. Over and along the Bay of São Marcos (in Maranhão Province) and the Bays of Gurupi, Marajó, and Sol (in Pará Province) we shall find focal points for the apparitions of the strange "Vampire Light" — or, as the *Caboclos* themselves prefer to call it, the "LUZ CHUPA-CHUPA".

The panic throughout the coastal and rural inland communities of the entire State of Pará is sufficient for the First Air Zone Command (ICOMAR) to be put on alert. (Until this day their investigations into the phenomenon remain secret.)

This book represents the synthesis of five years spent investigating and studying the Chupa-Chupa Wave. It involved numerous trips throughout the Brazilian Interior, wide contacts with other investigators, broad reading of specialized material, and countless hours of interviewing witnesses. This close contact with the *Caboclos* and settlers of the region who by caprice of chance or by fate had come face to face with the UFOs, gave us the certainty that we were on the right track. But after so many years of research and so much accumulated data, even so, the enigma of the UFOs is still not totally unravelled. Maybe you, the reader, can supply the answer!

CHAPTER I — THE START OF THE PHENOMENON

The long Rainy Season of winter in Pará was over, and it was now sunny July, of 1977. The little town of Viseu, on the banks of the river Gurupi, (which forms the border between the States of Maranhão and Pará) was slumbering peacefully. As the evenings drew on, the families would normally be sitting at their front-doors, and the children running to and fro on the street. Everything would have been as it normally used to be — were it not for the strange lights moving across the sky, lights of various colours, not ordinary lights, not aircraft lights, but silent. Among some of the more religiously-minded locals, the comment was "*Signs of the Times of the End*".....

Next morning, people arriving from the villages of Curupati, Urumajó, and Itacu had news of a powerful

sort of light which, coming down from Space, could paralyze you and "suck out" your blood and your energy. These reports of the "Vampire Light" came to the ears of the man in charge of the local Police Post, Sergeant Sabino do Nascimento Costa who, to begin with, vouchsafed to them no importance or credit whatsoever, though rumour had it that two people had been killed. The mayor of the town, Carlos Cardoso Santos, also greeted it all with a big laugh and gave his verdict: *"All just fantasy...."*.

The Priest of the local church, Padre José Giambelli, alarmed when his flock began talking of prayers to ward off the evil force, took the same view. *"Just the wild imagination of the rural folk! Nothing to it! There was talk like that three months or so ago from the silly people on the other side of the river!"*

Next day there arrived in town the fisherman Benedito Gonçalves dos Anjos Siqueira and his son Simão. Here is Simão's report:-

"About ten days ago we were fishing near Ilha Nova. Suddenly we saw a star moving. Its brightness was very strong, stronger than the rest of the stars, and it seemed to be flashing and it came straight towards us. We remembered what we'd heard about the "Chupa-Chupa", so we paddled for the river bank and hid in the bushes, and we just managed to escape being touched by the light. It was hanging a few metres above our boat and sweeping the whole area with a sort of searchlight, as though probing, seeking. The shape of the object was like a metal cylinder-drum. We couldn't see any windows or openings. In the end it flew off towards the farm of Zé da Granja".

Another man, Anastácio Costa, joined in, and told what had befallen his friend João de Brito of Vila de Piriá:-

"A few days back, João was hunting. It was 11.00 p.m., and he was sitting quietly in a hide among thick bushes, awaiting game. An animal appeared, but sud-

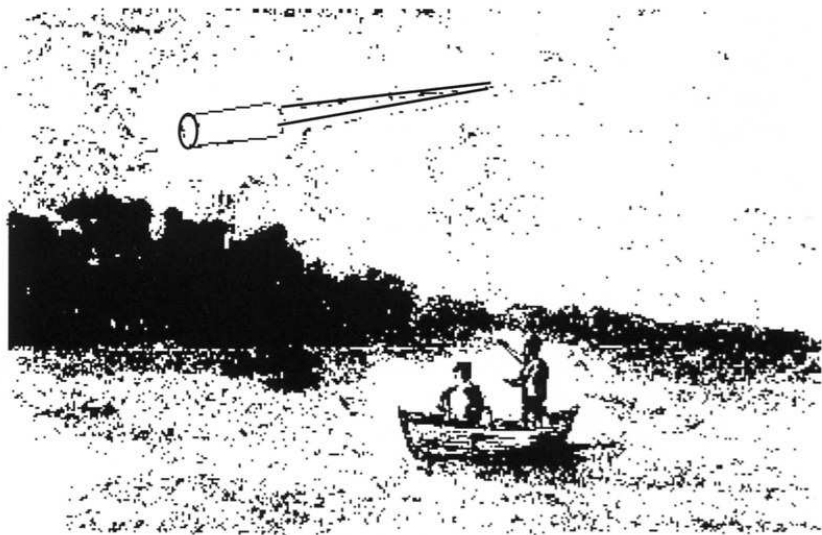


Fig 1. Cylindrical object seen by fishermen over river Gurupi (July 1, 1977)

denly something flying in the sky threw down a beam of light onto the animal, which made off. João himself couldn't escape. He felt the light bearing down on his body and felt his strength being sucked out of him, and was sure he was going to die. The flying thing was shaped like a cylinder, and he could hear voices coming from it, in an unknown language. The thing went away then, but it left him powerless. He seemed to have absolutely no strength whatever, so he ended up in hospital".

These UFOs shaped like cylinders (called "camburões" by the locals) were also reported over the Bay of Marajó (December 1977) and over Vila de Colares (October/November 1977). One of them flew over the house of the woman schoolteacher Maria Goretti at Colônia Nova (inland from Viseu), one night in July, and shone its beam down on the house. Sergeant Sabino of the Police at Viseu interviewed her. Still very shaken, she said: *"The thing was cylindrical and so bright that it lit up our house and the whole area around"*. The Sergeant decided that such testimony, from an educated woman like a schoolteacher, must not be ignored.

By now, nobody in the whole area was venturing out at night, no children were playing out of doors, and fishermen were wary about putting out in their boats. *It is important to note that many local folk felt sure the UFOs came up out of the sea, because they had been seen quite often doing precisely that and coming and shining down their beams on to boats or on to villages. In numerous villages and hamlets in the Viseu area patrols were constantly mounted at night. While some folks tried to scare off the "Vampire Lights" with fireworks, others had recourse to prayer.*

Over on the other side of the River Gurupi reports said the same objects were being seen all over the Maranhão Lowlands, and in great numbers, and there were reports of victims. And during the second week of July the phenomenon had spread further, beyond Viseu. Numerous places in the region of Bragança and Augusto Corrêa (both in Pará State) were thrown into panic.

Sergeant Arlindo Dourado, in charge of Bragança Police Station, as well as the local Deputy to the State Legislature, João Motta, at first refused to believe the reports.

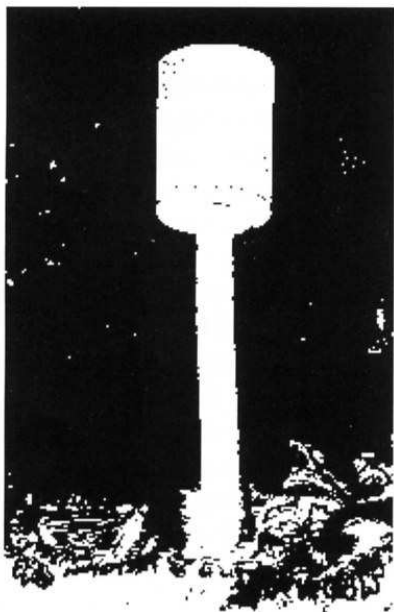


Fig 2. "From the object came down an intensely dazzling beam of light"

And by now rumour had it that markings found on the ground in the Interior and crushed or burnt vegetation and bushes, indicated that some unknown sort of "Monster Animal" was on the rampage. (The real explanation being probably that craft had landed there).

THE "FISH WOMAN"

But, in July 1977, the thing that caused the greatest worry for huge numbers of people in the ancient little town of Bragança was the stories about the "Fish Woman".

As described repeatedly by the local popular imagination, this young woman, described as a sort of "hippie" in appearance, had been seen repeatedly, always alone. For one thing, she had fair hair and white skin — so *obviously a foreigner!* Nobody knew who she was, or where she lived, or where she came from, but some said they knew she lived alone on a little island near Augusto Corrêa.

But the truly fantastic thing was that *she kept buying huge quantities of fish — usually 100 or 200 kilos at a time! — in the local municipal market.* WHAT ON EARTH COULD ONE SOLITARY WOMAN WANT THAT MUCH FISH FOR! *The obvious conclusion of the locals was of course that she was getting the fish as food for the occupants of the UFOs.*

Some of the rumours said that the island where she dwelt was Cajueiro, near Augusto Corrêa, in Pará Province, and that "queer things went on there too". Some fishermen who had ventured near there, had seen her "walking on the water"! And the house where she lived had "queer lights" every night.

One person who claimed to have actually met her and talked to her is Margarida, the stepdaughter of the Controller of the Bragança Airfield. Walking one day along a lonely road, she suddenly came face to face with a pretty woman, dressed entirely in black, whom she recognized as the "Fish Woman".

The latter was wearing a blouse with tight-fitting sleeves right down to the wrists, and her hands were encased in gloves. Enhanced by her long blonde hair, her face seemed to probe into Margarida's very soul. The woman asked Margarida what she did, and how many children she had, and also asked: was she not afraid to walk alone in that place? And then, suddenly, she vanished from sight as though by magic! Shaken and perplexed, Margarida went home, with a severe headache.

Several of the main newspapers in Belém carried short reports about the "Fish Woman": in particular *O Liberal* (July 10, 1977) and *A Província Do Pará* (July 11, 1977).

Subsequently, agents of the Brazilian Air Force Intelligence and Naval Intelligence turned up in the region and began investigating the story of the "Fish Woman". At first it was felt by everybody that, because of her huge purchases of fish, she was bound to be mixed up in something shady — probably the smuggling of arms, or espionage. But apparently the investigators never got to the bottom of the mystery. In the solitary little

cabin where she had been living — by then totally abandoned — they found a small airmail envelope (coming from France) addressed to "Elisabeth".

In the opinion of many folk however, she was connected with the UFOs, for when they vanished from the area, she vanished too.

And here comes the really intriguing bit: According to a statement made by Sra. Wellaide Cecim Carvalho, a Brazilian woman doctor working in that part

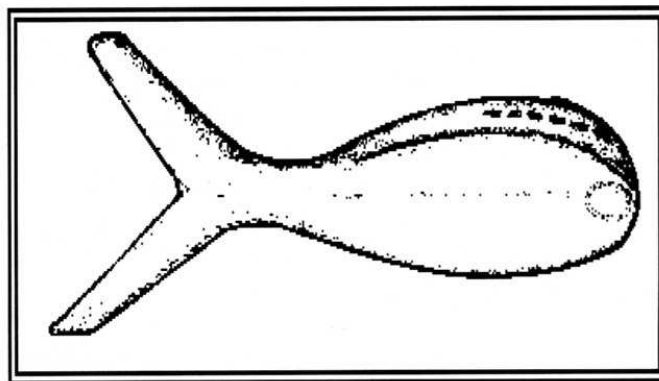


Fig. 3 Object seen by people of São Bento (area of most intense UFO activity)

of Brazil, and according to a similar statement made by a farmer named Manoel Mattos, living in Santo Antônio do Tauá in Pará Province, *singularly beautiful white women with fair hair had been seen aboard the UFOs.*

(NOTE BY EDITOR, FSR. And — even more important — I know that I still have on my files, still untranslated, a report from our German doctor correspondent in Rio de Janeiro, Dr. Walter Bühler, in which he mentioned that local Brazilian officials in this very same part of N.E. Brazil had also been talking of tall, white aliens from UFOs — and that was at least fifteen or twenty years ago. I will now seek out that report and translate and publish it!)

CHAPTER II — ENCOUNTERS IN THE STATE OF MARANHÃO

In due course, the wave of cases of "vampire lights" over the region of the river Gurupi turned out to be the greatest "UFO Wave" ever recorded in the whole of Brazil.

On July 17, from Pinheiro, the newspaper *O Estado Do Maranhão* reported:-

"The appearance of an Unidentified Flying Object in the skies over Pinheiro is producing suspense and panic among the population and has stimulated imaginations to such an extent that some are even saying that the object approaches people and then stuns them with a beam of light and extracts their blood. The presence of the craft here has been established as certain. It was filmed here recently by a cameraman from the TV Station, and viewers in São Luis (the State Capital) will soon have an opportunity to see the film. The object, seen by many thousands of people around Pinheiro and São Bento, is shaped like a "Y", and emits a flame from its base. There is general terror throughout the region, folk fear to go outside at night, because of rumours that when the UFO comes down near the ground it emits an

extremely hot luminous beam that burns peoples' skins."

From the mass of reports at the time, it was clear that the UFO's beam would first immobilize the victim. Then he would feel intense heat and would collapse, some fainting totally. In general, small rural settlements were being mainly victimized, *the victims single, isolated persons, or small groups of persons.*

Again, on July 20, the newspaper *O Estado Do Maranhão* reported:-

"The mystery object was seen by the cultivator Vicente Gomes. According to him the time was around 3.00 a.m. on July 14. He was on horseback, travelling along a road at Guarapiranga, in São Bento municipality. Looking up at the sky he saw a light shaped "like a parrot" coming towards him. He said the light from it was so powerful that it dazzled him so that he fell into a swoon.

"In another case, at noon on July 8, Raimundo Corrêa, (known also as R. Socó) employee on the Ariquipa Ranch, was burned by a mysterious glowing thing like a torch, leaving him with lesions. He said the thing was like a great fiery ball.

"In another case, at about 8.00 a.m. in the municipality of Bom Jardim, a woman was attacked. Sra. Coucima Gonçalves da Silva, resident in the Boa Vista area of Bom Jardim, was in her back garden when she saw the fiery ball. A beam from it struck her and knocked her down. After that, she had no knowledge of what happened. Her family found her lying unconscious, and when they took her into the house and she recovered consciousness she was babbling nonsense. She was sent to the Santo Antônio Hospital, at Santa Inês, where, thanks to the care of Dr. Pedro Guimarães, she recovered. There was no record of any burns found on her; she suffered only amnesia and psychological disturbance."

OFFICIAL ALERT

By now such were the fear and panic in Maranhão that the Third Air Defence Zone was put on the alert, as well as all municipal authorities, police stations, and mayors. On July 31, the newspaper Estado Do Maranhão spelt it out bluntly: "The strange luminous object is real, and it is intelligently controlled."

One night a Military Police patrol of several men saw the object when they were travelling from Paca to Pinheiro. Mario Pontes, one of the party, said they flashed their lights at the object and it flashed back.

Over and around Pinheiro the sightings were so frequent that an urgent call went out from the mayor for help from the Air Force. The request went on at once, via the Recife Air Command, directly to the Air Minis-

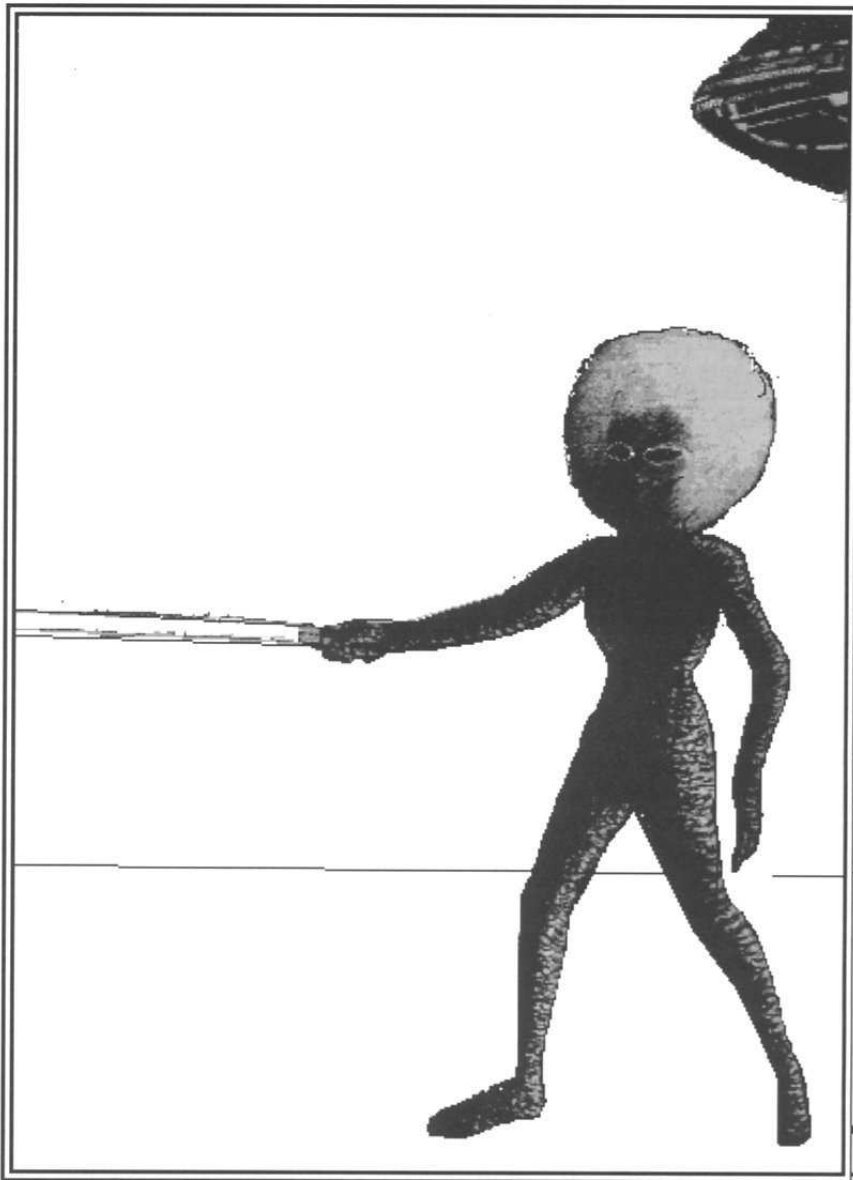


Fig. 4 "Entities in tight-fitting overalls with shining scales like reptile skin carrying devices like torches and sometimes wearing helmets such as divers have"

try in Brasilia.

Edgar Sales, Commissioner of the Third Police District, saw a UFO near Barreira do Pascal Lake, on his own property, at São Vicente do Ferrer. And José de Ribamar Mendes, Chief of Police at São Vicente, saw one over his house and tried to shoot at it with his revolver but was dazzled by the powerful glare.

MYSTERIOUS DEATHS

During that same period (July 1977) there were strange rumours that agricultural workers had been found dead in the municipality of Bequimão. Lying close by the bodies were 500-Cruzeiro banknotes. The bodies, it was suggested, might have been in some way connected with three "foreign-looking men" who normally spent the greater part of the day inside the Bequimão hotel, sallying forth then at night, in a motor-car of unknown make, on who knows what "secret" activities?

Similar rumours were current in the Parnarama region of Maranhão and in Sobral (in the nearby State of Ceará).

According to Sr. Reginaldo Athayde, Coordina-

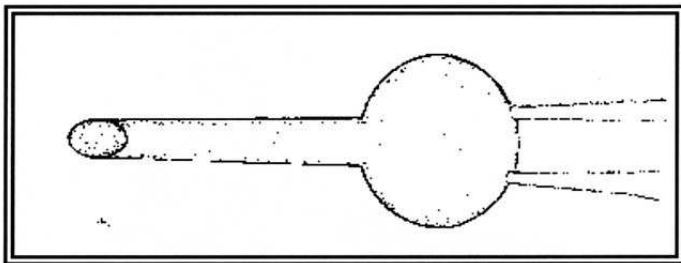
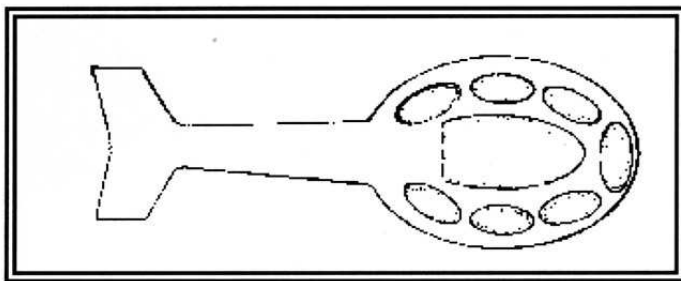


Fig. 5 Craft seen over Vigia and Isle of Colares (1977).

tor of the UFO Investigation Group in Fortaleza, “*dollars with strange perforations*” were found near the bodies.

(NOTE BY EDITOR, FSR. The State of Ceará, and its principal city, Fortaleza, were part of the vast Consular District of North-Eastern Brazil which was my “bailiwick” when I was stationed there from 1948 to 1951. And Parnarama is the very place where reportedly hunters were killed at night by UFOs in the forest and drained of their blood. (See Bob Pratt’s report published in FSR some years ago, and also Jacques Vallée’s subsequent confirmation and report on his visit to the area and his meetings with local people. Incidentally Vallée is mentioned in this book and the author of the book met him during his visit. G.C.)

SIGHTINGS OF HUMANIDS

Mentions of actual sightings of entities in 1977 were few and also vague. However, the newspaper *O Estado Do Maranhão* carried one report of notable interest. João Batista Souza, owner of the Nova Melia Ranch at Barra da Corda, in the Interior of the State, was strolling on his property early on the morning of July 17 when he saw a “ball of fire” flying along about 200 m. from him. Terrified, he hid behind a mound, and watched the glowing sphere land. As it did so, its brightness abated, and he could now see that it was “shaped like a straw hat”. And he saw a door on it open, and a small being about 1 metre in height, emerged, carrying in its left hand a sort of torch emitting a reddish light, and with something else, not distinguishable, in the other hand. The face could not be seen, being encased in a helmet with “antennae”, but the rest of the entire body was “covered with hair”*. At that point the rancher appears to have lost consciousness. Members of his family eventually found him lying there and carried him into the house where he remained in bed for several days, too weak to get up.

CHAPTER III — OPERATION “CHUPA-CHUPA”

October-December of 1977 was a period of special alarm and panic in the towns and settlements near the Bay Do Sol, nobody venturing forth alone at night for fear of the blood-seeking “vampires”. Notable reports of sightings also came in from the town of Ourém (Pará State). Also from the town of São Domingo Do Capim in the same State — where the Air Force managed to photograph UFOs on various occasions.

By now some of the rumours and popular theories were more fantastic than ever, *the most astonishing being the idea that the UFOs were part of a secret Japanese plan for contraband trafficking in human blood!* Many folk on the other hand had no doubt whatever that the UFOs were from other planets, and there were reports that one had crashed near km. 36 on the highway between Acará and Moju, but no proof of any such crash in N.E. Brazil was found by the author during his five years of investigation in the region, and the newspaper *O Liberal* of Belém, Pará State (November 4, 1977) dismissed it and similar crash stories at the time as pure rumour and nothing else.

PANIC AT SANTO ANTÔNIO DE UMBITUBA

The hamlet of Santo Antônio De Umbituba, in the District of Vigia, consists of just a handful of families, who live by fishing and agriculture.

The first reports marking the start of the next phase came from here, and on October 8, 1977, the newspaper *O Liberal* carried a detailed report (under the headlines *MEN AND WOMEN ATTACKED BY CREATURE IN VILLAGE IN VIGIA*) regarding surprising happenings in Umbituba. These reports, from many of the residents of the place, spoke of flying craft with beams of light capable of penetrating right through any obstacles, such as the roofs of houses, and of targeting people and paralyzing them temporarily.

In October the same paper carried further reports along the same lines, and now, *for the first time, we see the term “CHUPA-CHUPA” mentioned.* In Umbituba, as elsewhere, nobody was now venturing out alone at night, as it had already been noted that the UFOs apparently preferred solitary victims. Here too, as elsewhere many men were now out at night, but banded together in patrols, and equipped with firearms as well as crackers and fireworks for scaring off the intruders!

A Colonel Oswaldo Pinto de Jesus, aged 45, from the small settlement of Coração de Jesus, in the municipal area of Vigia, made the following statement:-

“There was a lot of talk at that time about the “chupa” in Santo Antônio de Umbituba, and later also in Coração de Jesus. One day, in the early morning, my mother, Maria Assunção, saw the thing, and called to us to see it. It was flying slowly and quite silently, not very high, and seen from below it looked a bit like a helicopter. It had lots of coloured lights along the sides

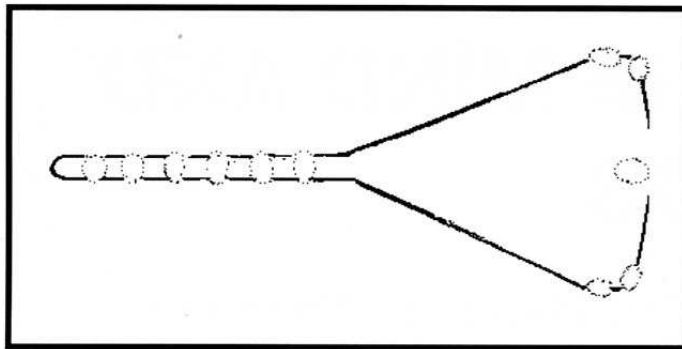


Fig.. 7 Craft seen by J.F. da Silva near Vila de Colares (Nov. 11, 1977).

of its tail, and a powerful searchlight at its tip. It suddenly seemed to be aware of our presence, and all its lights went out and it disappeared in the murky early morning sky."

All along the coast, from the Maranhão Lowlands as far as the Bay of Marajó (in Pará Province) the reports were the same. *There were "luminous balls". And there were also craft rather like helicopters or shaped like ray fishes.* (See Figure 3).

NOCTURNAL LIGHTS OVER VIGIA

Right at the centre of this main zone of fear and unrest was Vigia, an old town of colonial days, and focal point for Umbituba, Cumaru, and other places round about.

At 6.45 p.m. on October 18, 1977, the inhabitants of Vigia were sitting nervously in total darkness, awaiting the electricity, which should have come on at 8.00 o'clock. One or two bold souls who had ventured outside to peer up at the sky, observed at least six points of light shooting rapidly overhead, and, minutes after the last one was out of sight, the electricity came on again. (No explanation in the delay of the power supply was ever forthcoming, but the populace had no doubt as to what had caused it and pronounced it a "blackout".)

On October 22, the newspaper *A Provincia Do Pará* reported:-

"Mayor José Ildone of Vigia will today be sending to the Regional Headquarters of both the Army and the Air Force, in Belém, an extensive account of what is happening in Vigia, Santo Antônio do Tauá and, in particular, an account of the terror being experienced by the people of Umbituba. The decision to do this was taken after the mayor had discussed the matter with Vigia's Chief of Police, Alceu Marcílio de Souza."

(In Chapter VIII the reader will be able to learn in greater details about certain aspects of the Air Force's secret plan of operations to cope with the phenomenon.)

THE CLAMP-DOWN

The city of Belém (this is of course the Portuguese form of the name BETHLEHEM) — also known as Pará — is the Capital of the Amazonian State of Pará — and occupies an important place both geographically (at the mouth of the mighty River Amazon) and in the

history of the development of Brazil. And it so happens that, every year on the second Sunday in October thousands of pilgrims come streaming into the city, from far and wide, to view the great religious ceremony of the Procession of Our Lady of Nazareth (*Nazaré* in Portuguese). In October 1977 this meant that folk from all over Amazonia were bringing in fresh stories about the terrifying "chupa-chupa", and inevitably this greatly worried the City Authorities and the Armed Forces. Moreover, it seems that probably a great deal of exaggeration had by now coloured many of the stories, for folk were talking of "vampires that came down sucking human blood, and especially from women's breasts".

(NOTE BY EDITOR, FSR. I recall also that years ago — probably about this same date, 1977 — a member of a British Pentecostal group sent me the texts of a number of intensely "lurid" "vampire" reports from much further up the River Amazon — namely from Manaus, the Capital City of the entire vast region. These reports said that the women in the towns and villages of Amazonia were being subjected to what one might term "long-distance rape", inasmuch as they were allegedly being directly inseminated, as they lay in their beds, by means of the UFOs' light-beams penetrating roofs and walls and ceilings. I was careful not to make any use of so alarming and so unsubstantiated a story, but I admit that this book by Giese is now beginning to make me wonder exactly how false those stories from Manaus were! G.C.)

Anyway, to put it in a few words, these fresh stories about the ladies' breasts were enough to "put the lid on everything". As the tales ran like wildfire through Belém, women were all growing hysterical. Immediate action was needed. And the Authorities acted.

Instantly the local newspapers, which up till then had been reporting, very objectively, everything about sightings of the chupa-chupas and about their victims, *changed their tune overnight*. The newspaper *O Estado Do Pará* had proclaimed, on November 19, in great headlines "*Vampiro Interplanetário Só Gosta De Mulher*" (*The Interplanetary Vampire Only Likes Women*"), but one day later (November 20) the same paper's headlines screamed "*CHUPA-CHUPA E SÓ FANTASIA*". (*THE CHUPA-CHUPA IS MERE FANTASY*)."

And that was the end of all the talk about the CHUPA-CHUPAS in the newspapers of Amazonia. Never thereafter was a word written about them.

The curtain had descended. *At least, of course, so far as blood-sucking vampires was concerned.* Meanwhile the UFO Phenomenon went on throughout Brazil, as before.

POWERS OF THE MIND AND UFOs

In FSR 37/3 (autumn 1992), with his article *Are UFOs Compatible with "Our" Physics?*, we introduced a new FSR Consultant, Ron Pearson. And we present him again now, with the following article, containing some remarkable new ideas and suggestions which we hope may be of interest.

As every FSR reader knows, I have not had a scientific formation myself, and I therefore do not claim that I fully understand what is written by FSR's scientific Consultants. I do not. Everybody knows that I do not. But I have gleaned the impression that Russia has many bold and imaginative seekers and researchers in the scientific field, and I have seen evidence that some of these Russian scientists have a high opinion of R.D. Pearson, who has been a delegate to two very interesting scientific conferences in Russia recently.

From September 9 to 14 in 1991 he attended, in Lenin-grad, the Second International Conference on Space And Time Problems in Contemporary Science, under the chairmanship of Professor Maiboroda. Then, in March of 1992 he took part, in the same city now re-named Saint Petersburg, in the International Scientific Conference to celebrate the 350th anniversary of the birth of Sir Isaac Newton.

And — to the great astonishment of the Russians — he was one of only two countrymen of Sir Isaac Newton to attend! Furthermore it is my understanding (but of course I stand open to correction) that not a single British newspaper or periodical or journal has published a word about either of these Conferences. If that is so, then it is a remarkably interesting fact, and it tells us a lot about our country, and about the forces that control it today.

I asked Ron Pearson to explain to me something about the background to all this, and he then told me that for the past four or five years he has been vainly attempting to find an entry into the media here for discussion of some of his ideas on Gravity and several other topics in Physics. Result: NIL. Only one British newspaper so far has even deigned to grant him the courtesy of a reply. This was the *Independent*. And do you know what they told him? They told him that his ideas had caused a considerable stir in their office, but they were very sorry that they couldn't publish him!

Fascinating, isn't it? Here we see the signs of the Mafia-

like strangulating grip which is being exercised in every sphere and realm in our country by the powerful Controlling Interests.

One of Ron Pearson's many crimes is that he is known to accept the evidence for the presence here of alien craft and their alien occupants. That's enough to get anyone banned from being able to exercise the right to free speech.

But in Russia, Ron tells me, many of the scientists talked to him freely about the massive enigma of the UFOs. And — worse still it seems, over there in Russia they even like some of Ron's views about Physics in general! For example, they agreed wholeheartedly with Ron that some of the ideas of Einstein have now been shown to be badly flawed. In fact it seems that, at the end of the week of discussions, the Russians turned to the question of the future Physics syllabus that they propose to adopt for teaching in their own universities, and it was unanimously agreed that they would now drop Einstein's theories of Relativity altogether, and replace them by what they term the new "advanced Newtonian principles"!

Is this why we have seen no reports anywhere in Britain about the St. Petersburg Conference on Isaac Newton?

In future issues we shall publish some further material from Ron Pearson, and maybe, when we have the time available for doing it, we will try to assemble some of the evidence which goes to show that throughout vast areas of our world, including Britain and all western Europe and the USA, total control lies in the hands of an interlocking group of "Mafias" that are determined to see that the "man in the street" does not get too near to knowing the truth about a whole lot of things — including of course UFOs, but also a great deal besides, such as questions about death and the after-life, religion, parapsychology, medicine, etc., etc. In other words, we are to be kept in blinkers and not permitted to know what our true situation is, and what it is that runs this entire business of our existence.

In addition to the full text of this article, which is not only lengthy but also calls for an awful lot of digesting by anyone as inept as myself in scientific matters, Mr. Pearson was thoughtful enough to provide a Summary. I am therefore publishing this Summary first. Those who are bold enough can then go on to study the full text, which follows immediately afterwards. EDITOR.

(A) SUMMARY

A new unifying principle has appeared as a result of theoretical analysis. It was shown in a paper presented by the author at the 1991 Scientific Conference in St. Petersburg that, in order to obtain a paradox-free theory of quantum gravitation, space had to exist as a balance of particles made from both positive and negative energies. These are the ultimate particles, the "*cosmons*", from which all else is constructed, and forming a sub-quantum fluid.

Half of all cosmon collisions are between opposites and from these an astonishing result is predicted. To satisfy the basic conservation laws of energy and momentum it was found that cosmons breed like the two sexes!

The pure creation taking place is balanced by annihilation centres. These form a tangle of filaments each terminating in a switch-like junction complete with its own power supply. The whole develops into a neurone-like matrix to be called the "Grid" extending throughout space, yet the mesh size is so small that more junctions exist in the core of each tiny electron than there are neurones in the human brain!

Switching-waves are generated which provide a self-organising feature so that the entirety of space evolves a computer-like capability. Small regions super-organise to develop consciousness and then deliberately use switching-waves to build and control the sub-atomic particles from cosmons for creation of a nesting

set of universes. Their matter-systems provide temporary environments for housing minds. On release from one matter-system the consciousness of such minds is transferred to another tuned to a different switching-wave frequency.

Not only does this explain why our bodies seem to be made from vibrations, a theory arises which predicts that mind is at the base of reality, being in full control of matter. This control is deliberately inhibited for Earth-dwellers so that the illusion of solidity is preserved. For more advanced life-forms, however, this inhibition would be relaxed. This makes possible the voyages of UFOs across millions of light years from the depths of space by the use of mind-power.

More evolved minds should be able to program the grid by thought alone. They would cause it to copy the switching pattern within a given volume enclosing the space-ship and personnel to be read out at the specified destination. On read-out the UFOs would appear to instantly materialise. They are probably built from the next-higher frequency matter-system because ours could not withstand the high accelerations which have been reported from radar observations. One case from Belgium shows that they can achieve accelerations greater than 700 times that of our gravity, a figure which would instantly crush us to death. (Fully described in a pamphlet of same title, £1 inc. p. & p., from Michael Roll, 28 Westerleigh Road, Downend, Bristol, BS16 6AH.)

(B.) POWERS OF THE MIND AND UFOS (FULL TEXT)

Positive and negative energies interact at a sub-quantum level to generate the "ether". This forms the base supporting the reality we perceive. Mind spontaneously arises from initial chaos as a highly structured part of this ether, which is why it possesses vast powers as yet lying mostly untapped. These powers explain the whole spectrum of the paranormal yet dovetail with the known laws of physics. There is no choice because the mathematics of positive/negative collision dynamics dictate the outcome. A spin-off from it is a possible way in which UFOs might achieve interstellar travel.

I answered the telephone to find myself connecting with the excited voice of a stranger from the Isle of Man. "You've cracked it", he said, "you've cracked it!" A friend of mine had just sent him one of my new pamphlets. "Ever heard of 'Radionics'?", he continued. "No", I answered, "What is it?" "It's a method of medical diagnosis discovered by Dr. Albert Abrams⁽¹⁾ early this century. It provided an effective method of medical treatment. Then it advanced to provide a fantastically effective means of pest control in agriculture. But because it conflicted with strong vested interests and because it could not be explained by the known laws of physics and seemed to defy common sense, the method has been almost hounded out of existence. There is no doubt that it is connected with unknown powers of the mind and at last somebody seems to have come up with a theory to give it support."

He then sent me a book, now out of print, entitled "*Report on Radionics*" by Edward W. Russell.⁽²⁾ It made

fascinating reading and indeed demonstrated hidden powers of the mind. In turn it gave convincing support for the new theory about to be described.

A correspondent, Pat Davies, triggered the whole new train of thought when she put me in contact with Alexander McRae in Skye. He wrote and included a problem he had been thinking about for many years. "What happens", he asked, "when a mass made of positive energy hits a mass made of negative energy?"

The reader may be excused for wondering what this could possibly have to do with mind, but it is crucial as will become clear in due course. Before going further, however, it is necessary to describe the various "levels" of reality. The lower the level, the greater is the degree of scale-up needed for its mental visualisation.

THE LEVELS OF REALITY

What we observe directly is the "macroscopic level" of gases, liquids and solids. Gases like air, or vapours like steam, are tenuous fluids which can condense by cooling to yield dense fluids like water. On further cooling they crystallise out into solids. At the microscopic level, gases, vapours and liquids turn out to be a seething mass of discrete particles constantly bouncing away from one another due to high speed impacts. These particles are atoms and molecules. Also at this level crystals of the solid state arise from the shapes formed when atoms stick to one another to make molecules.

In these two realms the physics of Galileo and Newton reign supreme. Particles need a "force of action" to be impressed upon them to make them accelerate to a different speed, otherwise they maintain a uniform state of motion in a straight line. Then every force of action is balanced by a force of "reaction". Newton assumed the former to be in the same direction as the resulting acceleration and then defined all associated energy forms to be positive. By "energy" is meant the kind needed to throw a ball. To speed it up, energy has to be imparted, which is called "kinetic energy". It is positive when the force of action is in the same direction as that of movement during the push given to the ball. But Newton seems to have missed two important points.

Firstly when the forces of action and reaction are both reversed in direction, exactly the same responses of objects are predicted by Newton's laws modified in this way. Hence it is impossible to determine which direction is correct. There are two alternative options but in the new case just considered all the corresponding energy forms turn out to be negative. So which is correct? In a new gravitational theory published by the author it is shown that both must exist. Positive and negative kinds of energy co-exist in balanced amounts, as the "*Yin*" and "*Yang*" of creation, for otherwise the Universe could not exist. If we assume our observed Universe to be of positive energy, then the negative sort is there as well, but lies behind the scenes so to speak, being hidden from our gaze.

The second point is that starlight falls like matter in the gravitational pull of the Sun, and light is entirely

kinetic energy. Hence matter and energy must be equivalent. This equivalence, given by the famous equation of Einstein, $E = m \cdot c^2$, can easily be derived from Newton's equations alone. Then the two forms, the "mass energy" which is the energy from which an object is made, and its kinetic energy, need to be added together to give the "total energy" of an object. There is, of course, an equivalent "total mass". When the latter is substituted for "mass" to correct Newton's laws, they yield predictions, already confirmed by experiment, exactly matching those of Einstein's Relativity theories inclusive of gravitation. There was no need after all to replace Newton's ideas by the curved space-time geometries which Einstein introduced.

The author presented this new theory of gravitation at the "Second International Conference on Problems in Time and Space" held in St. Petersburg in September 1991. There it transpired that physicists from all over the world were in agreement that Einstein's theories of relativity were falsely based. Indeed only one delegate considered Einstein to be right! However, a general complaint was the impossibility of getting alternative theories or critiques of Einstein published in the scientific journals. These would only accept articles in support of the established view. The unexpected new outlook was altogether very encouraging to me because Einstein's theories, the bedrock of the much vaunted "New Physics", are incompatible with the very existence of any ether, which is why this hypothetical medium fell out of favour. But another physicist, Silvertooth, brought back the ether with a bang in 1986! He carried out a very sophisticated experiment which showed that the Earth moves through the ether at the enormous speed of 1,300,000 km/hour -- and Einstein's relativity theories depend on this speed being zero. Marinov later gave a

similar result obtained by a totally different experimental method. So it seems that established physics went wildly off track early in the century. A fresh start is needed.

But now let us penetrate to deeper levels

THE QUANTUM LEVEL

We are now moving into the quantum level which describes the atomic structure. The atoms themselves are built up from sub-units -- the sub-atomic particles. And now things are unexpectedly different from those observed at higher levels. The apparent solidity of the iron bar gives way to an unimaginably tenuous structure of dancing sub-atomic particles taking up less room, relatively speaking, than planets do in the solar system. The atom's "sun" is the nucleus, itself made from sub-units, the "neutrons and protons", and each of these is made from three "quarks" with an elusive "strong force" pulling them together. And this nuclear sun has its planets. These are the minute "electrons", bound by electric forces to the nucleus yet held at a distance.

Furthermore, sub-atomic particles do not move in the manner one would expect. They appear to have a dual nature, sometimes moving like little billiard-balls, which expresses their particle nature. At other times they act like ripples on a pond. They are then expressing their wave-nature. This discovery was termed "wave-particle duality". It explains why people speak of matter existing as vibrations. Shorter waves mean higher frequency vibrations. Other worlds, invisible to us, could co-exist with ours by being tuned into higher frequencies than ours.

Wave-particle duality is the basis of quantum theory which provides a perfect calculation procedure for atoms and molecules. It provides chemistry with a mathematical base including that of complex life-forms. But wave-particle duality baffled scientists worldwide and even today no consensus about its interpretation has been reached. Of those theories proposed only one makes sense to me, yet this seems to have been abandoned. It assumes "pilot waves" arise from a sub-quantum level which then guide sub-atomic particles. The idea of pilot waves was first proposed by De Broglie and Bohm, and a similar scheme was proposed by the author quite independently owing to the obscurity of this early literature. And this leads us to delve even deeper -- to the sub-quantum level.

THE SUB-QUANTUM "COSMON GAS"

A new concept of relevance also emerged at the Conference held in St. Petersburg. Adolphe Martin described a theory for the sub-quantum level based on minute particles he called "cosmons", which consisted entirely of kinetic energy. He showed that sub-atomic particles could be created by the total effect of flow patterns arising from this fluid.

An electron, for example, then appears as a spherical core body of fluid moving through the remainder and spinning as it goes. But that is only half of the particle. The rest is the disturbed flow field extending to infinite distance, as illustrated in my sketch. All other particles,

like the quarks of the atomic nucleus, had a similar explanation. Martin's theory also successfully predicted the electromagnetic force and the strong forces within the atomic nucleus. Yet at the sub-quantum level the only forces existing were those caused by the impacts of one cosmon upon another! No cosmon was aware of any control by pilot-waves and so Newtonian mechanics became applicable again.

The concept is especially exciting when combined with the new gravitational theory of this author which also depends on the existence of a sub-quantum fluid. In fact it will lead us to deriving what seems the ultimate nature of mind itself. The name "cosmons" is highly appropriate and will be retained.

THE SUB-QUANTUM STRUCTURE OF ETHER -- THE BASE OF REALITY

The fluid now, of course, has a negative half intimately mixed with the positive half. I had not ventured to consider the interactions between particles made of opposite kinds of energy until recently.

I had imagined they would mutually annihilate and so would require continual regeneration by some kind of permanent grid structure present in space. I had already deduced that such a structure was needed to act as a computer for generating the pilot waves. So it had to pervade the whole of matter and space. But I could not see how such a computing base could arise. Nor could I see how it could work. But this was before I responded to the challenge from Alex!

I looked then, not only at Alex's problem, but also at all the ways such particles could interact when they hit each other coming from all possible directions. I will not dwell on details but it turned out that the need to conserve "momentum" (mass X velocity) prevented energy from being lost. This was so when each cosmon, in order to accord with quantum theory, consisted of the minimum possible package of energy. Near-head-on collisions, in fact, demanded an energy gain for both colliding particles. But these gains were of opposite kind and so cancelled out. This means that both kinds of energy arise together from pure nothingness without contradicting the laws of physics. Yet sometimes four particles now emerged from the collision of only two. The end result was that, on average, 1.18 particles emerged from each positive/negative collision. They were breeding! From a minute number of cosmons originally present, growth would spontaneously occur to provide a new explanation of creation by a "Big Bang". A greater than exponential increase in the number-density would arise everywhere in a growing ball of what was initially almost empty space.

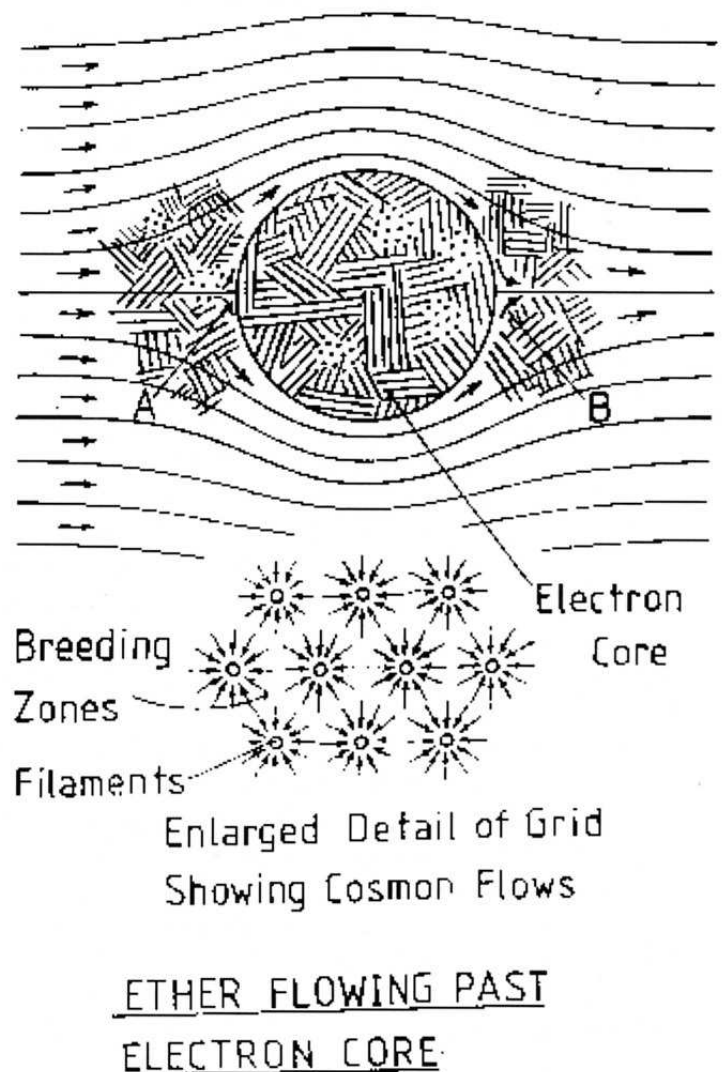
Only when three or more particles collide simultaneously can annihilation occur, a situation which can only predominate when a very high number density is achieved. Hence an explanation is automatically provided for the enormous energy density of the "space" predicted from quantum theory. To explain the force of electromagnetism a value of 10^{45} J/m³ is needed! It can only exist stably near this value. In the new theory, however, a negative half of space is generated

simultaneously with the positive half so that the net energy density of the two taken together adds up to zero, the same value as the initial nothingness from which it arose.

As the density grew initially, a critical density would be reached at a huge number of isolated points within the growing ball. At each point annihilation would suddenly occur leaving holes. These would provide sinks for surrounding breeding zones, so relieving the pressure.

Flows would arise as particles streamed radially inwards from all directions as if to fill the sinks, as illustrated in the detail given in my sketch. But there they would implode against one another with great force in the multi-particle collisions ideal for annihilation. Because a minute but finite time is needed for this process, a solid mass will always be present consisting of positives and negatives as they merge into one another, building up on the outside as fast as they are destroyed to create a permanent composite object of unchanging shape. These centres can be spherical or of cylindrical form. In fact, if a short cylinder forms it will be a composite of these two shapes. The ends will be spherical, forming growth points, so that a filament will grow until an obstruction is encountered. And each filament will be clothed with its cylindrical breeding region of space. The rate of annihilation at each filament is exactly balanced by the pure creation taking place in the surrounding cylinder after a stable steady state has been reached.

Many filaments can pack to form a structure with



their centres forming the corners of equilateral triangles. They are then fed from prisms of hexagonal shape which is as close to the ideal cylindrical form as is practically possible. Since they form at random on the larger scale, like the crystals solidifying from a melt, filaments will form criss-crossing in all directions. They will all terminate at both ends in tee-junctions with other filaments. And here we have switching means arising by chance. At any such junction a gap may or may not exist. If a gap exists a hemispherical end will be opposite a cylindrical surface, so creating an asymmetry of curvature between opposing surfaces.

But only a dead grid and nothing else could exist unless a further asymmetry were present to provide a driving force.

A slight asymmetry in the properties of positive and negative energies, however, also needs to exist to account for the force of gravitation according to the author's earlier publications. This is also required if the grid properties needed for pilot-wave generation are to arise. It means that there must be a slight difference in the rest energies of positive and negative cosmons even though their total energies are balanced.

The importance of the asymmetry for the present argument is that a slight separation of energies will arise when account is taken of random surges in the creative process. One filament of an open junction will acquire a small "charge" of positive mass with the other acquiring the negative kind. This completes the essentials of a computing system by providing the power supply. When some shock causes a gap to close, a mass current will flow until any imbalance has decayed. Furthermore the circuits can be changed by shocks and so the potential exists for grid organisation to arise from initial chaos. Waves will tend to build up as the closure of some switches triggers the closure of others in the same way as brain waves arise. If the wave-organised surges are large enough, even the filament structure will be modified. Hence waves tend to organise the switching action into a coherent effect of larger scale and this will feed back to organise the filament structure. Ultimately a grid having a computer-like power could arise spontaneously. Then organised waves can be generated. These are the pilot-waves which control sub-atomic particles!

A structure similar to the model "neural networks" now being built by scientists has emerged. These networks have been shown capable of learning and memory retention. Our structure, however, has an unimaginably small mesh-size. Furthermore, although only a chaotic mass of switching circuits was originally present, a high degree of organisation would gradually develop. It is known, from the brilliant mathematics published by Professor Penrose and others, that beautiful highly organised structures can automatically develop from initial "chaos". Hence a primordial mind of huge size could arise spontaneously.

It could then divide into a multitude of sub-minds by enclosing portions of itself within information barriers. These could be formed by deliberately programming thin barrier layers of the grid. The total volume of

conscious minds would be but a minute fraction of the total volume of space. The remainder would operate machine-like as a mindless computer though programmable by thoughts emanating from the conscious fractions.

MATTER-SYSTEMS INCLUDING THOSE OF UFOS

Clearly disembodied sub-minds would need some kind of environment so that they could interact in meaningful ways. The existence of consciousness within a totally featureless computing system of vast size would be totally frustrating. Hence matter-systems needed to be created and the only way this could be achieved was by organising cosmons via the only available means -- the switching waves. Hence what appears to us as matter has to be a contrived organisation of the ether, the mind building matter upon its own back as it were by making use of the incredible computing power existing within this grid-like ether.

A simple yet wonderful reason has emerged to explain the puzzlement of the famous quantum physicist, Richard Feynman. Talking about wave-particle duality he said, "It's crazy, but that's the way the Universe works!"

The fact that "mind over matter", telepathy, and other aspects of the paranormal are not more in evidence needs to be explained as a deliberate inhibition. Without this the Universe would not seem real. It may be that these inhibitions are relaxed when people become more evolved, and then enormous mind-powers, seeming totally magical to us, might be released.

Mind-power could explain UFOs⁽³⁾ by showing how they could reach us from the depths of space: impossible feats according to present technology. Any object, even a life-form, will be represented as a switching pattern of the grid. It might move itself complete with surrounding objects by first programming the grid to copy the entire switching pattern within a prescribed volume. Then this pattern could be read out at some other place prescribed by co-ordinates. After checking to correct any errors the original could be deleted and then almost immediately a UFO complete with occupants would appear to materialise from nothing having jumped from perhaps millions of light-years away. This explanation cannot be rejected as impossible because it also explains the "apport" of objects frequently reported in association with poltergeist phenomena.

But this is not all. The theory outlined permits other matter-systems to exist tuned into other wavelengths from ours. Their sub-atomic particles need to be organised by switching-waves which do not interfere with ours. Then they would be normally invisible to us and could pass right through us without our awareness. Their positive-negative balance could be adjusted to make their inertia, their resistance to acceleration, much smaller than ours. Indeed some reports appear to show that this is indeed the case. It has been reported that on 30/31 March 1990 a UFO was observed by radar at Glons and Semmerzake in Belgium and F-16 fighters were sent up to intercept. They observed a rapid change in the altitude

of the UFO from 2000 to 200 metres in only one second. At the very minimum this works out at an acceleration of 730 times that of gravity. Another report from the USA says a UFO climbed from 21,000 feet to 44,000 feet in 3.5 seconds. This corresponds with an acceleration of 117 times gravity. Only people from a different matter-system could withstand such accelerations.

Hence the advance in understanding achievable from an enlightened physics does not preclude the existence of UFOs. Indeed the mystery of our very existence no longer seems so inexplicable. Our bodies exist as a consequence of our own ethereal minds seeking means of expression. UFOs could exist for a similar reason. (R.D.P., July 30, 1992)

FOOTNOTES BY EDITOR, FSR.

(1) and (2) I have in my own library most of the key books regarding *Radionics*, including both *Abrams' Methods of Diagnosis and Treatment*, the original British publication on the subject by Sir James Barr, CBE, DL, FRSE, LLD, MD, FRCP, who in his time held most of the top positions and honours in British medicine, and was Honorary Physician to H.M. King George V. It was published in London in 1925 by William Heinemann (Medical Books) Ltd., and is today exceedingly rare -- no doubt because the usual steps have been taken to "make it rare." I also have Edward W. Russell's *Report on Radionics: Science Of The Future* (pub. by Neville Spearman, London, 1973), and Langston Day's and George de la Warr's *New Worlds Beyond The Atom* (published by Vincent Stuart, London, 1956)

George de la Warr, Abrams' first British follower, was, as many readers will know, persecuted and financially ruined by the controlling British "medical Mafia", just as, in the USA, Wilhelm Reich and Abrams' follower Ruth Drown, were destroyed -- in fact actually killed -- as a result of the action taken against them by U.S. Government departments operating on behalf of the Control Mafia.

didly speaks about the *Phobos* failure. He explains that the eventual loss of both spacecraft was almost a certainty. He claims that, "We actually built in failure from the start... The primary cause for their demise was that the designers had less than 3° years to complete the space craft... At least 6-7 years are required to prepare for such a complex and unique project. The rush to complete the *Phobos* spacecraft placed scientists, engineers, and industrial contractors under tremendous pressure... I am convinced that both were lost due to various defects in the design... and to low survivability." The loss took place when the spacecraft turned to photograph *Phobos*, this is when it broke its radio link with Earth. He concludes that, with hindsight, an additional independently steerable antenna might well have saved the mission.

Regarding Dr. Popovich's colossal cigar-shaped UFO, again,, we find plenty of room for a conventional explanation. On March 26, 1989, the day before a computer malfunction doomed *Phobos 2*, the probe made a limb-to-limb scan of Mars' surface. One of the high resolution pictures taken shows a cigar-shaped object with the 'tails' on the right side of the images being artifacts caused by Termoskan's scanning method (the photographing/scanning unit on the space probe*.

Is this Dr. Popovich's UFO? If so, it is regrettable

to note such a lack of research and objectivity in this case, particularly from someone who claims to have reliable contacts in the Soviet Politburo and to know the essence of both Presidents Gorbachev's & Bush's conversation during the Malta Summit!

STOP PRESS

Will readers please note two important points:-

(1) In FSR 39/2 (p.20) we reproduced a warning about possibly faked photographs from Puerto Rico. We have now received a further report from Sr. & Sra. Freixedo (in whom we have the most complete trust) assuring us that this charge of hoaxing is simply part of a vicious campaign of defamation now being mounted by unscrupulous folk in Puerto Rico against the well-known and highly experienced UFO investigator Jorge Martins. My provisional estimate is therefore that we should treat the charges as quite unproven, and await further developments.

(2) Also in FSR 39/2 (Mailbag) we printed a letter from Lawrence Fenwick of C.U.F.O.R.N. about "a metallic alien implant" allegedly found in the Canadian lady Betty Stewart Dagenais. Mr. Fenwick has since written again to say that there were certain errors in his original report. It seems that a metallic implant was indeed found in her, but it was not examined by x-ray. We must await further developments, but in the meantime I quote part of his letter of September 1st, which is as follows:-

"(1) The actual x-ray examination of the implant was done by a student and not by the Chairman of the University of Toronto's Metallurgical Dept.

(2) The implant was not examined — only the tissue surrounding it. The Chairman said that, if we tested the metal part of it, it would be warped or destroyed by the heat from the x-ray machine. When Betty Dagenais heard this (and she was present then), she said that she did not want the metal part tested — but just the surrounding tissue.

(3) The date of implanting was 1961: the date of its removal was March 7, 1988 (not 1989); and she was 72 when she died, not 74.

We shall try to get the use of an x-ray machine which will not destroy or damage the metal implant, and will publish the results and will send you a copy of our report.

THE LOSS OF THE SOVIET "PHOBOS II" PROBE TO MARS AND PHOBOS IN 1989

In Zecharia Sitchin's article *Are We Alone?: The Loss of the Mars Observer, and the Lessons of History*, (FSR 38/3), reference was made to the strange fact that in 1988 the Soviets had launched two probes towards Mars and that both of them had also come to grief in some way.

FSR reader Victor J. Kean in Berlin has long taken a particular interest in the problems of Mars, and in the course of my routine correspondence with him I suggested — in March 1992 — that he might like to give us an article on the subject of *Phobos II*, and here it is. We have had it in our files since October 1992 and I have not managed to slip it into FSR until now. Victor Kean regretted that he could not offer more "substance" and I admit that as I have not myself been able to keep abreast of all these matters it may well be that by now some or most of what he says is out of date, in which case I proffer my apologies. However, the statements of the Soviet woman cosmonaut Marina Popovich are surely of importance and of permanent value, and as we have just published the Sitchin article I think the present is a good moment for us to put Mr. Kean's piece on record too. EDITOR, FSR.

Having heard that Jim Melesciuc, the editor of ORBITER (Reading, MA, USA) had published an article about the Phobos II affair, I wrote to him and asked for a copy, which duly reached me in April 1992. He also sent me copies of two photographs which he had published in SKY AND TELESCOPE for February 1990.

In his article, which I reproduce below, Jim Melesciuc says that all that was seen was "a giant shadow on the moon of Mars", and he gives an explanation for it.

However, those photographs of Jim Melesciuc bear no resemblance whatsoever to the photo that was given to Don Ecker by Soviet woman cosmonaut Marina Popovich, which showed a cylindrical object in a vertical position beneath the satellite Phobos. (I think that we can take it that this photograph is the one used by Zecharia Sitchin and reproduced by us as figure 1 on page 3 of FSR 38/3. ED., FSR.)

On April 25, 1992 I wrote back to Jim Melesciuc enclosing a drawing taken from my video copy of the original CNN programme, and asked him for his comments. However, he has not replied — presumably because he now realizes that his article was based upon the wrong photographs. This leaves me with very little of substance on which to base a possible article by myself.

However, what Jim Melesciuc has to say about the Soviet woman astronaut Maria Popovich, who is extremely well known for her long-standing involvement in Ufology, will always be of interest, so I enclose his article herewith.

PHOBOS 2 & MARINA POPOVICH'S UFO?

On May 27, 1991, Dr. Marina Popovich (Soviet Air Force Colonel — Retired) appeared on the CBS television program *Hard Copy*. The program gave a general overall view of Soviet UFO reports, ranging from photographs of aerial anomalies to a Kremlin/Washington coverup of the phenomenon.

Dr. Popovich, in one segment of her interview, spoke of a 1989 launch of two Soviet space probes to the planet Mars. These two probes were to take pictures of the red planet and transmit them back to Earth. She states that the first probe was a success but something strange occurred when the second probe, Phobos 2, passed close to the Martian moon — Phobos.

In the *Hard Copy* interview Dr. Popovich states, "when the probe passed close to Phobos, a satellite of Mars, it shot one picture and next to Phobos, close to Phobos, which in itself is 17 by 29 kilometers, there was a huge object that was 25 kilometers long and about 1° kilometers wide. It was a cigar-shaped object." (Ed. Comment: The *Hard Copy* program animated this event by showing a huge object covering the Martian moon from one end to the other. The object was viewed as the typical cigar-shaped object commonly seen throughout UFO literature). She added that the Russian probe shot one picture of a giant shadow on the moon of Mars and then it vanished. Furthermore, the Russians didn't say the spacecraft stopped working or it broke down. They say it just vanished.

Toward the conclusion of the interview, Dr. Marina Popovich emphasized that her sources in the Soviet Politburo confirmed her claim that, at the Malta Summit, Presidents Bush and Gorbachev had talked about what had happened near Mars.

So what are we to make of all these exclusive/sensational claims from a Soviet Air Force Colonel (Ret.)? Is there room for conventional explanations?

Amusingly, we find Dr. Popovich's claims are inconsistent with those of Roald Z. Sagdeev, scientific director of the Phobos mission. In an interview he gave to the Soviet general interest science journal *Priroda* he can-

AN EAST COAST ENCOUNTER

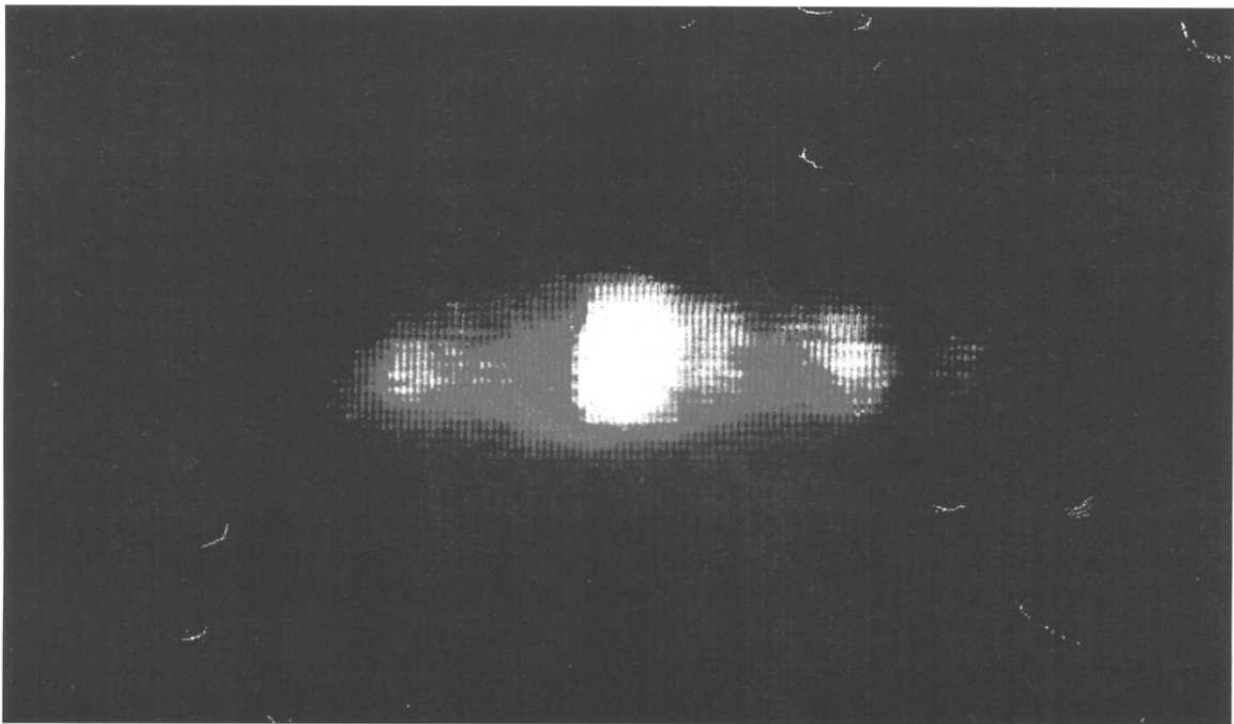

AUSTRALIA'S ABORIGINES HAVE LONG KNOWN ABOUT UFOS

Dear Mr. Creighton, — In the Spring 1992 edition of *Flying Saucer Review*, on page 24, you published an article entitled "*Tractors of the Gods?*" referring to earthworks in Northern Australia photographed by Dick Smith.

As an anthropologist who has done extensive site work on Aboriginal sites in Western Australia I would like to make some comments.

In the first paragraph the patterns are described as "new". Now I don't know whether the author means new in a diagrammatic sort of way or new in the sense of having been newly made. I would certainly dispute that they are newly made and the photograph provides no evidence of them having appeared recently.

Earthworks in Australia are always known by the Aborigines and are significant to them. The Dreaming tracks of the ancestors cover the whole continent and take in all sites. That means that all sites such as these earthworks have meaning and importance in terms of Aboriginal religion. In fact, whoever created them, ancient sites are Aboriginal sites. Under the Aboriginal Heritage Act many are kept secret, and it is against the law to publish photographs of such sites.

I showed this photograph to an Aboriginal friend who knows the North well. He told me of another place where he has seen similar earthworks, (they can be seen for what they are from a hill). The area he spoke of would be for secret ceremonies such as initiations. Such areas should not be entered except with permission and in the presence of the local Aboriginal custodians. To ignore these rules would risk offending the Aboriginal Elders and doing a disservice to future researchers.

The Aboriginal Law men tend to keep very silent about such places and would not want public discussion on them. Certainly the sites are not to be seen by the general public and publication of photographs can cause trouble.

I hope to be in the North again soon and will make some enquiries about the earthworks.

TRIP TO NORTHERN TERRITORY

One of Paul Norman's regular research summaries on Australian sightings, "*On the UFO Trail*", contains a report about a sighting over an Aboriginal community in the Northern Territory. The community concerned lives in a very remote area. This report was something new. Not surprisingly, when Paul heard about it he decided it was one that must be investigated and accordingly he organised to do so.

Having worked with Aboriginal people over a period of many years I was also keen to follow up the report. From talking with the people and looking at their art I had previously come to the conclusion that over the tens of thousands of years that they have lived in Australia, Aboriginal people are likely to have been visited by extra-terrestrials. A reflection of these possible encounters can be seen in their culture.

A fairly well-known example of this is the Wandjina figures of the Kimberley region. These figures, sometimes bigger than life-size, are painted on rock walls. The Wandjinas are said to be spirits who came out of the clouds and are able to control lightning. (Fig. 1).

The paintings depict them looking like extra-terrestrial travellers dressed in space suits, often with radiating lines or rays emanating from their heads.

Some of the Aboriginal art forms cannot be looked at or reproduced by us. They are only to be seen by the old men, the Elders who are the custodians. These representations are respected as sacred and secret, an important part of a very spiritual culture.

From a more southern area of Australia, an ancient Aboriginal story tells of a man who came to Earth from the Moon. While on Earth he lived in a cave. Eventually he returned to the sky, departing from his cave through a hole in the roof.

On the wall of this cave where he lived remain aged and faded paintings. From these, one can still make out a circular object with rays coming out from one side. (Fig. 2).

Aboriginal people are well aware of what we term as "unidentified flying objects". From the snippets of re-

ports that we have heard in the Territory, some people may have experienced encounters that have left them fearful. The Aboriginal lifestyle is an outdoor one, and the people frequently do not have the same sort of secure housing that whites enjoy. So it is no wonder that the sight of a UFO hovering above a camp might cause concern.

Paul's article relates that a silver elongated-shaped object hovered above a community, departing only when an aircraft arrived. We looked forward to talking to these people about their experiences, but were disappointed

to find that we were not to be permitted to visit the community at this time. The reason was not explained to us by the administrative officers.

We were now at a loss but set out again. After travelling east across Kakadu National Park we were at the border of Arnhem Land. The landscape is dramatic and I wondered whether the ancient rocks, dignified and majestic, perhaps hold secrets of momentous events in the life of humankind from the long distant past.

Early in the morning I walked down to the river. A small group of Aboriginal people sat there and welcomed me to talk to them. Paul had brought photographs

of UFOs and ground circles from different parts of the world including Australia. These I showed to the people and they were very interested.

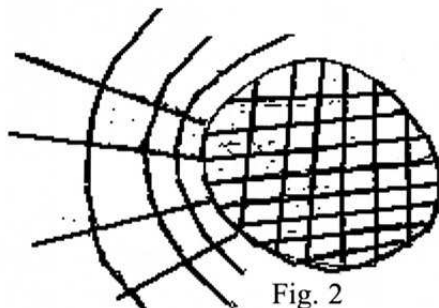

One young man said he had seen a television programme on the subject. The old man present waited for the younger people to have their say as some were boisterous and noisy. Then he took me aside and asked me to show him the photographs again. If he had an intention of telling me about sightings there was no time for it. A white ranger arrived ordering the people to pick up their things and move. He seemed very surprised to see me talking to the people,

went off and returned a few minutes later with more rangers in another vehicle. The people prepared to move away as instructed.

Later in the day I talked with an important local Aboriginal Elder, Joseph. He talked first about the dangers both to his people and to the Earth itself, caused by uranium mining in the area. Their knowledge of what they call the "sickness country" goes back to times earlier than the white man's mining. Aboriginal people fear that sickness and death will result from such massive disturbance of the earth.

I showed the photographs of flying objects to Joseph. He was familiar with the idea of UFOs and had himself seen strange lights moving in the sky at night. Joseph informed me of a community to the south-west who had experienced an encounter with a UFO which caused them to run. Then, with deep concern and sadness in his voice he told me that in yet another place aliens had abducted a two-year-old child. The child had not been returned.

Travelling further south we came to the community Joseph had mentioned. This was also by a river and isolated. Talking with a group of people I quickly found a man who had been witness to the landing of an object. This encounter had occurred years ago, when Steven was a boy on a station in the area. From his account the aliens had wanted to abduct a woman and made their intention known to her telepathically. The station manager had come out with a gun and the craft left without the woman, leaving a circle on the ground which Steven said could be seen to this day. Investigations are continuing on this story.

Distances are long in the Northern Territory, and our time there was coming to an end. We had to leave but the research continues. The talks with Aboriginal residents had confirmed our belief that sightings of UFOs and alien encounters are not culturally confined. They happen for all nationalities and all over the world. ■

For example, various individuals have come up to me and made certain insinuations about my work, and I get telephone calls to my home and there's nobody there at the other end of the line — just weird sounds, strange noises. On one occasion a person called me and said that I was talking too much. Shots have been fired into a shed that we use for storage, and shots have been fired into my tyres. Frequently black helicopters fly over my house. But I can see it all very clearly, I'm mature. I've lived a long time, and I know that if they wanted to injure me or eliminate me physically, *they'd do it*.

All the same, I repeat, I'm very clear about it and well satisfied with what I'm doing and I'm very sure about it too. No — I'm too old to go around feeling scared. ■

UFO WITH OCCUPANTS SEEN TO PRODUCE CROP-CIRCLES IN ROMANIA

Whereas, for two decades past, Britain, Western Europe, and other parts of the world have had countless reports of crop-circles -- always without evidence of a causative UFO -- it now seems that -- for the first time -- our country, Romania, can claim a crop-circle case in which not only a causative UFO but also entities aboard the UFO were seen, thus providing proof of a close linkage between what so many folk have tried desperately to convert into two completely separate phenomena!

DETAILS OF THE CASE

The scene was near Arad, a regional town in the N.W. near the Romanian/Hungarian frontier, and the occurrence happened at about 4.00 a.m. on Monday, June 20, 1994, but it only reached the media on June 29, when the matter was reported and the crop-circles were shown on the National Romanian Television News programme.

Peter Leb, Cornelia Nemes, and Mircea Aries of the Romanian UFO Investigation Group, RUFOR (based at Mures, in Central Romania) set out for Arad to investigate and were joined there on July 1st by the two local journalists (of the newspaper *Adevarul*) Doru Sava and Serin Ghilea, who had sent in the first report to the Capital.

No radioactivity or magnetic anomalies were detected at the site by Army specialists from the Arad Garrison who came out with their equipment. The radiation laboratory of the local Preventive Medicine Centre also checked soil samples and found nothing notable.

THE CROP CIRCLES

These were two in number: a small central *roundel* 6 metres wide, within a larger ring 42 metres wide. The width of the actual band of this outer ring was mainly 4 m. wide, and 6 m. wide over a 70° section. The corn-stalks in the *roundel* and on the larger *ring* were all heavily pressed down onto the ground, and close to the ground, and swirled in an anti-clockwise fashion. In the outer areas the stems of the corn were interwoven or "plaited" with each in a "whirlwind" fashion.

Witnesses Found

The investigators made enquiries at once of the villagers round about, and found several eyewitnesses. All of them told of something "terrible and terrifying". But several were too frightened to give any statement at all.

All the statements were tape-recorded.

A. Testimony of Witness, Mr. Ioan S---

"I've never experienced so terrible a thing in my life. I was scared to death. Suddenly the entire wheat-field was lit up, and I heard a terrifying whistling, and over the entire field the corn was "rippling" and bent double.

B. Testimony of Witness Catalin P---

"It was a nightmare. I've never experienced anything remotely like it -- except in Science-Fiction films!"

C. Testimony of Eyewitness I. Ungur

"I saw strange lights, but had no idea what was going on. I was so scared that I dared not look any more.

D. Testimony of Muela, wife of last-named Eyewitness Ungur

Seeing that her husband was too frightened and disturbed to talk, his wife said:-

"My husband was close to the field, and suddenly he heard a terrible whistling that made the entire field of wheat tremble. But there was no gust of wind with it!

"And then he saw a light that was flashing on and off, and he fled back into the house, terrified."

E. Testimony of Eyewitness Traian Crisan

This man spoke more openly than any other. Aged 48, and known as a very honest fellow. Never for one moment did any of the investigators and journalists have the slightest doubt as to his veracity.

This man's flock of sheep were at a distance of some 150 m. from the wheat-field. Here is part of his statement as it was published in the *Romanian UFO Journal* RUFOR No. 9/1994.



"I don't know what that thing was, because it didn't land. It just stayed there in the air, 3 metres above the field of wheat. I guard my sheep at nights and sleep out myself with them. And it happened at about 4.00 a.m. on Monday, June 20.

"Going over to see how my sheep were, I saw a light approaching -- a light *like the Moon -- only much bigger*.

"I went back to my hut, and then, just as I was getting ready to eat, the light appeared again over my hut, and all the sheets of the corrugated roof and the walls shook.

"I went outside again and I was standing there, about 5 m. from my hut, when a powerful blast of wind blew away my hat and my rain-cape. The blast was so powerful that it knocked me flat on my face, and I lay there clinging to a bush.

"The object was completely round. On it I could see a small open door, and two individuals standing in it. They stood there holding what looked like tubes of some sort. They had beards and moustaches, and I saw them just as clearly as I would be able to see you at a distance of 30 metres.

"They were no taller than I am (about 1.65 m.) One of them seemed to be a man aged 40. The beard was long, like the beard of an Orthodox Church priest. His face was thin, he wasn't thick-set, and his eyes were like the eyes of a Chinese (as shown by the sketch made by this witness).

(We do not have a copy of sketch. ED. FSR.)

"The noise made by the thing as it passed overhead was like the sound of a factory whistle, and the blast of wind was like the wind in a storm. (And the sound of the vibration of the metallic high-tension wires near by).

"The thing stayed there motionless in the air for two minutes or so, 3 metres above the wheat.

"When the men saw me, the thing moved away a bit. My sheep had fled, and were scattered all over a field of maize, and the dog, terrified, had fled into the shed and hidden himself, whimpering.

"When it went, the thing just vanished in a fashion such as I've never seen in my life and I don't think anything else like it can exist.

"After the lapse of two minutes or so, from its under-part -- in fact right from the middle of its under-part -- there came a bluish flame that looked like a thick rod about 1.5m. long and as wide as my milking-bucket.

"Then the thing shot straight up into the air like an arrow and its lights went out.

"The men were wearing things like earphones and had instruments in their hands. One of them was speaking into something that he was holding and I could hear his voice, but don't know what language it was.

"Just in front of the door to their big dome there was a sort of balcony. One of them was holding on to the rail of it with one hand and holding in the other hand the thing with which he was speaking.

"On his right shoulder he had something white, a triangle. But I was too scared to go closer.

"As regards size, I think the thing was maybe bigger than the larger ring in the cornfield. If they had landed, I think they would have broken up the rings which were still swirling beneath them.

"The dome was of glass or of plastic. Inside the dome, there was a powerful white light.

"When it took off, it went straight upwards. It made a noise like a cannon being fired, and went like the wind.

"The circles in the field were only produced just as it began to rise, and I was the very first person to see them.

"My neighbour says *he* was the first person into the field

because in fact he was already there, guarding his crop. *But he doesn't want to talk!*

"I have never read anything about UFOs.

"I had seven years of school. I've been a farm tractor mechanic for 22 years and I have a daughter who works in a textile factory. So I do know a bit about mechanical things, but what I saw isn't like anything that I know of.

"Since that night, the sheep won't sleep here anymore and I don't know what has got into them. They sleep anywhere else now -- in various places.

"When my dog hears a car coming up the road, he flees."

The statements of this last witness, who has lived through some terrifying moments, are confirmed by the brief accounts given by the other witnesses. Also by the strange big round circles in the field. All these features make this Romanian case a very important event in Ufology. *For, at last, people have observed -- directly -- the fact that UFOs are the real "agents" that cause the strange crop-circles in the fields**

Moreover, this case has proved the correctness of the view, expressed by experienced Ufologists, that the pressing down of the wheat stalks into these circular shapes is produced by UFOs overhead as they take off and shoot upwards. For example, -- this opinion was expressed by Gordon Creighton in his discussion on page 12 of FSR Vol. 38//4 (1993).

AN EAST EUROPEAN UFO WAVE?

This summer, it looks as though Eastern Europe has been visited by a veritable fleet of UFOs leaving their rings in the cornfields.

On August 10, 1994, the Romanian press carried a brief report from the Czech News Agency (CTK) about other similar cornfield rings in the Czech Republic. Here is the text of that Czech account:-

"Mayor Jan Prikop of Zihobce has reported that two concentric circles have been found in a wheatfield outside that town. Inside these two circles the wheat stems were pressed down in a counter-clockwise fashion. The two circles were perfectly formed, with radius of 12 m. and 10 m. respectively. Within each of them there were also four more small circles of 3 to 4 m. diameter. These small ones were disposed in the cardinal compass positions. But, nevertheless, the wheatfield bore no other mark or traces (paths).

Jan Prikop also declared that, a week earlier, in the same region of the Czech republic, outside the village of Kolinec similar circles have also been formed.

NOTE BY EDITOR, FSR. * I should have thought that anybody but a complete fool would be been capable of perceiving this long ago! And, in any case, we have just had a very clear case in Puerto Rico, where two men, Rubén Pérez Vélez and Juan Caballero, claimed that they had witnessed the arrival of a "tornado" over a field and the sudden production of a "circular flattened area" on to which another man was instantaneously thrown down. This man has testified that he had just been kidnapped at Adjuntas, while driving in his car to Ponce, by a smallish species of aliens ("not much shorter than us"), carried off in a UFO to somewhere else and finally cast out again as described by the two eyewitnesses who, however, apparently did not perceive any craft from which he was thrown. (See FSR 39/1, pages 4-6). As we all know, it has long been maintained that UFOs can be *invisible*. Naturally of course there have been "other and far better explanations" for this Romanian case at Arad -- the favourite one being that the two men seen standing in the doorway of the UFO were none other than Doug 'n Dave, now equipped with Slavic beards acquired during their recent Russian visitations.■

Unpleasant Visitations

Dear Mr. Creighton, — Having only just begun to subscribe to FSR and having been very much impressed with the first two issues, I have now also asked for and received a lot of back issues too, and I found that No. 33/3 related very much to certain experiences that I myself have had. The issue in question contains Ann Druffel's article *Can We Battle These Entities?*, and what she describes has made me realize that what I myself have experienced was not my imagination or dreams.

It started in 1989. I was aged 23 at the time. My first experience was at about 4.00 a.m. in the early morning. I had the distinct feeling that "someone" was pulling the bedclothes off my bed. I felt that the presence was *female*. Nothing else happened so far as I am aware, but when I awoke I found that my bedclothes were indeed precisely as I had seen them in my 'dream' — pulled off the bed.

The second incident was about a week later, and was more graphic and more frightening. Once again I awoke in the early hours of the morning and found myself *completely paralysed*. And I felt as though my face was being pushed down into the pillow by two unseen presences. I knew that I must move myself if I was to avoid trouble, but it seemed to take just about all my mental strength simply even to *think* about moving!

Then I began to break the paralysis and to come out of it. All this time up till then I had had the impression that I *must not* open my eyes to see what was causing my predicament. That was the end of the second incident.

A few days later I returned home at 6.00 p.m. from work feeling very tired, so I lay down on my bed and drifted off to sleep. Then — instantly it seemed — the next moment I was floating up above, with my back touching the ceiling of the room, though in order to be where I was my legs must have had to pass through a wall! I didn't find this O.B.E. very pleasant, and the next thing I knew was that I was back in my bed and waking up.

The next incident came a few days later. Once again I was paralysed. I could hear a distinct humming sound or vibration in the room. And again I had the feeling that "something" was organizing all this. This time I felt I had had enough of this sort of treatment and I managed to break out of the paralysis and aim a punch at what I perceived to be the cause, and my punch landed in thin air.

The feeling of dread left me at once, but I was now thinking that I must be 'going crackers.'

I told my family about these happenings. Some of them thought they might be real experiences, while others felt I had been dreaming. Personally I don't believe for one moment that I was dreaming. To me it was all

a very real, cold, stone-sober experience.

The occurrences then stopped for a while. But I went to Australia on holiday and while there, at Surfers' Paradise, the nocturnal problems came back again, and I had another O.B.E., but this time there seemed to be no malevolent side-effects.

Then came a gap of several years, in which I had no similar experiences. Then, on one occasion, while lying in bed, I had the sensation of being pushed upwards by my arms. It was as though a current of energy was pulsing through my body. I put aside my fear and let this sensation proceed. It was a very pleasing sensation, as though my body was being "charged up".

Once more I must emphasise that all these events were totally unlike normal dreaming, and very real.

The latest manifestations came in January of this year. For a number of nights I had a tingling feeling come over my face, just like a very light touch or a brushing effect. I put it down at the time simply to 'facial twitches' etc.

Then, one night, I was awakened by a noise in the room. I looked over towards my right-hand side in the bedroom, and I could just make out a face staring back at me. I could only see a face — no body or form. This face seemed humanoid — impassive — just looking straight back at me. It had large almond-shaped eyes — over-large in proportion to the face — no nose or very little, and a slit for the mouth. In other words the typical 'Little Grey'.

By now I had become fully awake. I was not frightened. Just surprised. Then the face faded away.

I don't know what all this means, but I will say that since 1989 I have become more 'spiritually aware'. It is as though I am finally becoming 'awake' and finding out that there is more to us human beings than meets the eye.

I believe we have a very great potential, and we can do unlimited things once we have become spiritually fully engaged. May be then the other so-called unknown or unused 90% of our minds can come to the fore.

But I believe that we have influences here on Earth that do not want us to 'discover ourselves' and have our full potential.

My personal belief is that the Devil is encamped here on Earth and is directing "operations" himself, or itself, in bringing about the moral decay of our species and the destruction of our environment. As you yourself say, he uses many channels — drugs, the media, corruption in the business world, corrupted governments, corrupted and infiltrated religions — you name it! His hand is behind all these situations!

My sister and her family are Mormons. But she says that even in that church

the youngsters are leaving on a massive scale. She says "the Devil's main target is the teenager, and he seems to have the upper hand — *at the moment!*"

Unless we realize that we are being misled and lied to about many, many things, we will never be capable of addressing this threat. *But we could turn the tables if we wake up!*

I firmly believe that we are in the middle of a great war. And this war is over us, about us. It is being fought every day, in the human heart, soul, mind, but we can't see the wood for the trees.

I will end this letter with a quotation from a North American Indian prophecy about the near future:-

"The transition is to take place over a twenty-five year period which began in 1987. The Bird Tribes refer to this as the 'Day of Purification' — a short but essential cycle of division that will separate those who promote fear from those with the will to love".

Thank you for your time, Mr. Creighton. Any comments or advice you could give me on these happenings that I have described would be very much valued and appreciated.
