

to collapse, or in the case of night sightings – disappear. Separation of this column is almost predictable, as the height of the UFO above the water and the size of the UFO (governing the width of the field) itself, probably determines how much water weight the vortex can sustain. It would be interesting to compose a table with these figures, however due to fright or awe on the part of witnesses, most of the time these details are lost:

07-17-1992 Taking on Water They pulled their sail down to slow their boat to avoid a collision, but when the ship approached their boat they realized it wasn't a ship. It was a UFO with a lot of lights on it. It was sucking water up into it and passed slowly within twenty meters of the boat, but the fishermen don't think the UFO saw them. It just went by them about six meters above the water, sucking up a column of water almost as wide as the UFO. The water didn't fall back into the ocean. The UFO went past them and disappeared in the distance. This reference: UFO Danger Zone, by Bob Pratt, Published 1996, pp. 231-232.

04-26-1994 UFO "TAKES A DRINK Below the UFO the water began to churn. Mist swirled into the air. A center plume of water shot up to the bottom of the UFO. It was a waterspout. The UFO moved slowly to the left and I aimed the camera and took Photo 49. (See case 04-26-1994 – CF-) Ten to fifteen seconds passed while I stared at this amazing scene. Suddenly the waterspout collapsed. The UFO angled off to the left, climbed at a sharp angle, and disappeared into the hazy sky. A FUNCTION OF HEIGHT?

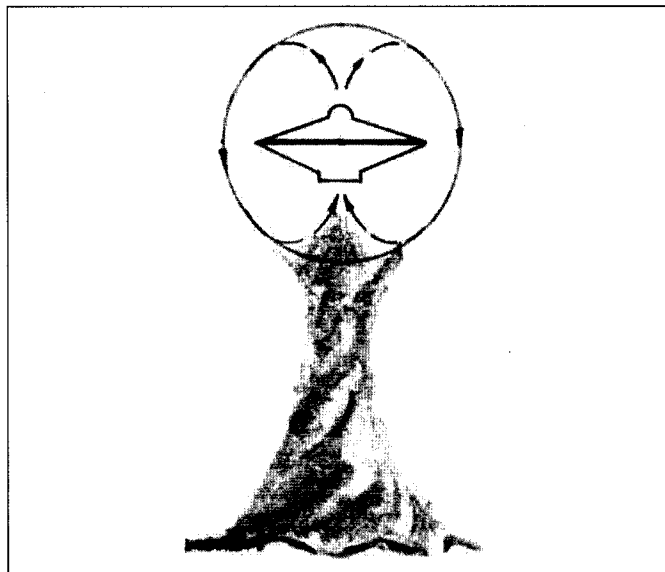

These cases of witnessed effects on water inspired the idea that these effects might be tied together in relation to each other. Some of the cases are of a UFO apparently "taking on water" not by means of tubes, pipes or hoses (as is the case in several reports), but by a column of water lifted by an unseen force directly to the craft. In the other scenario the UFO causes an observed "indentation" of the water. It would appear that these reports are contradictory of each other because of the differences in the effects; however, I believe that the differences are only the result of distances between the field of the UFO and the water.

In figure 5, we have what could be an illustration of the complete steps of the UFO's exit from a body of water, and the water's reaction as it does so.

These craft operate by physical principles! Though the details behind their operations are unknown to us, they should not be considered beyond our understanding. Excusing the craft's functions as paranormal, or that of holographic projections, or the result of some other impenetrable obfuscation is not the way to understand the physical principles governing its technology. We should concentrate on the craft's mechanics – because it is clearly **a machine.**

Another Missing Week long Abduction, this time from Portsmouth England

During the summer of 1989, a young man called Paul, 17 years of age at the time, was walking home after an evening out with some friends at the fairground and arcade situated on the sea front. As Paul neared his home, (which was just round the corner from the busy main road which he was walking down), he became aware of the familiar figure of another friend of his, just across the road from him. His friend was waving frantically, as if to gain his attention, but Paul soon realised that it wasn't his friend at all as the person

suddenly shape-shifted into another image altogether. As he looked on, the figure suddenly levitated about 8 inches from the ground, with its feet pointing downwards in the air as if on tiptoes.

For some reason Paul felt no fear. The figure floated and fluttered across the road towards Paul, then it started to make some weird hand movements for about four minutes. It was at this time Paul became aware that everything around him was totally silent. It was only

11.30pm, and still relatively early for a busy seaside town such as this. The road and the paths should have been thronging with holidaymakers and traffic, but it was totally deserted. This "being" held Paul's gaze, just looking at him, as if staring right into him; then all at once he was hurled into a bush near a driveway. Paul said whatever force was used to throw him was incredible, as he is physically a very strong person.

Picking himself up, Paul looked around and began to get a better look at the figure. Clearly this was in no way human, for it was very thin with an over-sized head, skinny arms and legs and huge black almond eyes... something akin to what we now know more popularly as the "Grey Alien". Paul said the next thing he experienced was the "Grey Alien" plunging a needle-type instrument into his neck, which made him pass out.

There is no memory after this, but he woke up in the same place where he was injected, and he thought perhaps only two hours had passed: So he quickly ran back home, just a few minutes away, and banged on the front door with all his might. A very worried and angry father greeted Paul, saying "where have you been for the last week?" to which Paul replied, "very funny!", as he thought his Dad was joking, but when Paul looked at the date on his watch, he got a further shock as he realised that indeed, 7 days had passed since he left home! Then just as his dad was speaking, Paul heard a strange, electrostatic-type crackling sound in the air, which stopped his father in mid-sentence. His dad began to stagger and shook his head, and then he changed his emotions completely, and now became convinced that Paul had in fact only been out for the night. Paul's mother was also convinced that Paul had been out only one night, even though he came in with a good growth of stubble on his face, which indicated he had been gone much longer.

It seemed almost as if his parents had twice been programmed not to pick up on this situation, as the police had not even been informed during all that time and Paul knows full well how his parents would have gone barmy after a just few hours absence, never mind a whole week. Things just didn't add up in Paul's mind as all. Very quickly it seemed as though nothing had ever happened; as if a mind-erasing exercise had been performed on all of the family and the whole incident was quickly forgotten; until that is, Paul started getting mental "flash backs", memories of what had really happened to him, some six months later. What he was now recalling was a brilliant white light, and in that light was between four or five "aliens" holding him down on some kind of bed; all Paul remembers is the smell of burning flesh, making him feel nauseous.

After the abduction Paul suffered from various levels of depression for quite some time, and to this day suffers from an intestinal disorder as well. Paul has since had a number of UFO sightings around his location; some involve other witnesses. For instance, one evening, coming back from the Cosham area on the back of his friends motorbike, both of them saw a huge triangle coming across Portsmouth, gliding over the old fort on the hill going towards Waterlooville.

FSR Comment: This Portsmouth case carries huge importance as it contains a witnessed incident of mind control in operation. The witness noticed an electro-static crackling sound which happened as his parents fell under an unseen hypnotic influence. In this way his week long absence was successfully concealed from them. This un-nerving theme of mind control also occurs in the initial appearance of his captor who mentally projected himself a disguise; the image of a close friend. An unpublished London abduction from the early 1990's involved a similar level of manipulation; the abducting entity being led into the family home by the victim's father who was holding him by the hand. The father said "there's someone here to see you, he says he knows you." Then on seeing the alien visitor the abductee suddenly felt a wave of great fear and lost consciousness.

A reported attempted abduction in New Orleans in the USA in 1961 illustrates our innate human capacity to fall under total mind control by UFO entities. This case comes from the excellent UFOevidence web site. The account begins one month after three teenage witnesses observed a fifty foot ring of lights inside a construction site of newly built tombs in a cemetery. Small four foot figures with lights were observed, the story continues:

Something woke me up at exactly 3.00am and I heard a voice calling me to the window. At this time I was living at my parent's home and the front of our house including my bedroom faced a large lake. One of my walls was completely glass. I got up and went to the window and looked out. I saw nothing. But again I heard the 'voice', I knew it was not aloud but in my head. The voice was adult male and told me that they were coming to get me to take me 'home'. He said they would be there shortly. I told him in my head, that I was not going unless Joe and Ida were going too. He said they were coming. I felt strange, like I was responding to an unheard voice in what I did next. I went into my closet and took out a suitcase and started packing. It was like I knew what to pack without thinking about it. Then I wrote a goodbye and thank you letter to my parents telling them I was going 'home.' In this letter I mention what of my possessions should go to whom. Then I sat on my bed to wait.

It seemed like a long time went by before I heard the man's voice again. Again he instructed me to come to the window. He told me that plans had changed for now and they couldn't come but that they would be back for me at another time. The next day after school, I called Ida and asked her if anything unusual had happened last night. She told me that she was awakened by a man's voice telling her he was coming for her and that Joe would be there too. She laughed and went back to sleep. Then I called Joe and he related the same thing. Neither Ida nor Joe said they heard a second message about them not coming. When I looked in my suitcase I had the strangest assortment of clothes for all seasons, and I still have the letter I wrote but it is undated.

The Return of the Spacemen, British Encounters with Suited Humanoids.

The classic reports of the flying saucer age provided us with vivid descriptions of "the spacemen" that were considered by many as convincing evidence of our visitors' extraterrestrial origin. The front cover of this issue of FSR is a humanoid dressed in a luminous brilliant white suit. Are we any closer to the realisation that these suited men were indeed accurate descriptions of what was commonly observed in those first fateful days of ufology.



Nothing could prepare me for what was about to happen one evening in Spring 1980. Just before 7.30 pm, I had put my daughter to bed then entered the lounge in order to switch on the TV, when I instantly stopped dead in my tracks. Standing right up close to the back window was a huge figure all in black.

I couldn't move at all I was so paralysed with fear; but as a researcher I was trying to fight this fear that was naturally overwhelming, to carefully take in all that was happening to me. Many different scenarios as to what this could be raced through my mind, but one thing I quickly discounted was that it might have been a burglar or a prowler, because my back garden is protected by a very high fence and hedge all along one side, and the intruder was ridiculously tall, possibly over seven feet in height. Also it was so implausibly dressed to wearing a black helmet with a visor, so I couldn't see any face in fact the whole figure was extremely dark in tone unlike anything I had seen before. The figure had suddenly raised its right hand and I noticed this had what looked like a black gauntlet on, but not made of any material that I could recognize. I also noticed that the suit it was wearing was a seamless all in one garment that had a slight sheen on it from the rays of the setting sun.

The enormous speed of this person was remarkable; it moved at least five feet backwards in less than a second, right up against my garden wall. So it was on the garden steps. I also observed that I couldn't see my neighbour's shed or his greenhouse either, because of the sheer size of this figure. Then in the blink of an eye it vanished.

Was this all in my mind, one might naturally ask? Did I simply imagine the figure? I can reject this emphatically, because I had a second witness with me in the house that also saw the same being when it returned once more. Also of note is the general area where the creature stood, it has had other

strange phenomena. Very odd sounds, thuds against the glass, like clods of earth hitting my lounge window, and noise similar to showers of small pebbles are sometimes heard; yet when I examine the area, there is nothing of the sort to be found, no stones, scattered soil or anything like that.

In July of that same year, late one Sunday evening, I had a phone call from two senior nurses at High Hurlands Hospital in Liphook, a specialist unit for handicapped children. The nurses were in great shock and it took some time for them to recover and reveal to me exactly what was going on. It became apparent that a UFO had repeatedly buzzed the Hospital some months, and was seen by all the staff that worked there, as well as some of the children; but the situation had recently become much worse and this is what prompted the telephone call. According to what I was told, a figure described to me by the nurses as "all in black", with a visor helmet, was coming up to the windows of the ground floor of the Hospital frightening the children and staff alike.

They have a dog on the premises, which was continually barking during these episodes, waking the sleeping youngsters. The nurses said that they recently had taken putting the shutters down so this man could no longer look into the wards. Also, a multi-coloured craft had taken landing in the grounds, and a figure was seen darting at great speed throughout the complex and frightening the nurses who were travelling to and from the nurse's home at the bottom of the hill within this site. Why was this visor figure interested in looking through windows? I realised that my child who was autistic and handicapped and the many similar children in the hospital at Liphook may have been the focus of interest. This strange visitor made his return to my own home in late November 1982. At this time we had another friend staying for supper, she was entertaining my daughter in the lounge while I was cooking the meal, when suddenly she came rushing into the kitchen white and terrified. There's a huge black figure in your lounge window with big gloves on and was banging on the window at Sally" (my daughter). I dashed in and must have frightened this huge life form and I don't know where it went, I only saw it momentarily and as before it just vanished into thin air!

During my research I have come across other reports of the strange figures; some tall, whilst others were of a much shorter stature, always acting stealthily, often described as being dressed in the same black garb and helmet. Nearly always they can move at incredible speed and are able to materialize and de-materialize in an instant. Wherever the alien beings are seen, there are also physical effects such as electrical appliances suddenly failing, strange bangs, objects unaccountably thrown, or perhaps levitated, and objects breaking or disappearing. To me, all of this begs the question are these inter-dimensional effects?

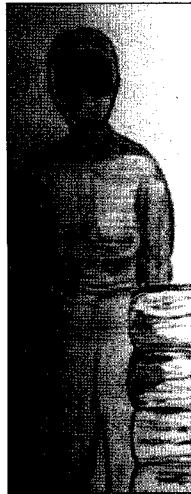
FSR Comment: A most interesting link to this case has arisen in a similar report where another family has noticed that their autistic sibling had also been the subject of alien attention. It is hoped to bring this anonymous case into the light in the next issue. What is most important is to connect with the underlying context; do these cases represent outside interest in the complex pattern of subtle brain damage found in autistic youngsters? Does this cluster of accounts point to a form of experimental observation study being acted out by these unknown entities acquired and developmental defects?

Northern Encounters with giant humanoid Spacemen

Most of us are aware of the spacemen reports in ufology, suited and helmeted as the famous Cumbrian space man of 1964, or dark and heavy hooded like a frogman. The 1970s were a particular busy time for appearances across the U.K. In 1978, while I was at visiting a friend's home in Bingley, I was informed that both my host and his wife were amazed to see a giant 30 foot high space man walking amongst the trees. The figure then disappeared over the hillside, at this point a very bright Silver Blue light flashed above the area. This was on the St Ives Estate. His house overlooked a woodland area called druids altar, a rocky outcrop on the hillside. Later on my research I would learn more of these space men and frogmen. The reports were similar to the strange humanoid I encountered; which I refer to as shadow people. My encounter with them was no more than three miles from Druids Altar, on a road known as ton up mile. You may have read about my encounter in issue of this magazine.



A similar case comes from Utley, where a lady called Rita was walking her dog, in an area near a local beauty spot she had used for many years. As she walked past a very large lorry fully loaded with logs her dog began to act out of character; it began to bark fiercely and then snarl and jump up and down. Then it went quite motionless and just stared looking towards the vehicle, that's when Rita noticed some movement behind the rear of the vehicle. Suddenly, a giant figure in a frogman's suit looked over the top of the vehicle at her. Terrified, Rita pulled her dog away and ran for home. She did not dare look back to see where the figure had gone or if it was still there. The vehicle was large and fully loaded with logs, so the size of the frogman looking head and shoulders over the vehicle must have been gigantic. This area is moor land that runs all the way to Ilkley and is famous for the mythical giant that roamed

there is named Rombald the giant. A giant figure in an area where there are folk law legends about a giant, is this coincidence?

FSR Comment: A question of scale: these two humanoid reports provided by Filey based researcher Russell Kellett tally well with other reports of similar giant humanoids seen in Norfolk in the late 1990s. These figures were seen to walk with their heads fully into the tree canopy, making them well over ten feet tall. They also had immensely long limbs and large light bulb shaped helmets identical to those drawn in the witness sketch above. These kinds of reports are uncomfortable to many researchers as they push the rational limits toward disbelief in how we conceive the real visual effects of a UFO manifestation. When our minds feel instinctively opposed to a novel repeat witnessed phenomenon perhaps we are being presented with an opportunity to raise our level of understanding. The following case taken from the UFO evidence website perhaps gives an insight to the true nature of these most bizarre manifestations of UFO entities: Bradenton, Florida, USA, Nov. 1971. Police Officer Jerald Meiers.

I was a police officer with the city of Bradenton, and after shift change was on my way home, so I stopped near an inland waterway, to sit and relax. It was just about dark as I approached the usual spot; there was a kind of mechanical buzzing sound in the air. As I walked forward I saw what looked like air on a hot highway, that is it moved and shimmered, but in a local area and not around it. It was perhaps like a vortex on its side. The closer I got, it seemed to have the sound inside my head, or brain rather than on the ear. Then a form began to become visible, about two feet off the ground. It was humanlike, in that there were two arms and legs, and a torso and a head but in some form of suit, like a space suit. Bluish black or lead coloured with a helmet and a glass like face plate.

A voice in English, a sound that I heard internally in my language asked, "Why do humans have war?" I thought and questioned what I just heard, I thought I would answer and spoke, "Greed?" The form went on to ask about the use and need for currency and about atomic power and weapons and such. As I continued to listen and answer, the form became more clear, or visible, like it was before me as a real person would appear. It had a clearer voice with less static or fuzz sound. I could barely see inside the helmet, there was a face, just visible, rather human like. I could not see ears, but frontal aspects, eyes, small mouth, skinny nose and a rather normal forehead and cheeks. He looked bluish grey, but this may have been some filter effect of the face shield. After what seemed like minutes, it faded into the vortex in a shimmering round area in the air. The entire time the thing was about two feet off the ground. It did seem to me that after the first few questions, others were being asked in my mind without my being aware of the words, and at way high speed; a kind of scan of high

speed questions? However after the questions on atomics, it stated with feeling, "I will be back, and contact you."

Well its been decades since, without contact and I have returned to the spot over the years, about every ten without result. The only thing I might call a residual result is that I have visions of technical drawings of lens-like craft and the systems that power them and plasma based weapons systems. Also advanced flying devices and advanced electric or plasma based projection devices as best I can describe them. These visions interrupt dreams or come to me when I'm most tired.

FSR Comment: This extraordinary case features a description of mind control type questioning by the entity, digging deeper into the witness mind while asking him profound questions to distract him. There is also a vivid description of a vortex type 'soft spot' portal through which the entity arrives.

However, this case ends with a descriptive term "advanced electric or plasma based projection devices." Are the ludicrous contrasts within the paradox of the flying micro-saucers such as the scale of these giants a result of plasma based projections created by the kind of technology described by Meiers in his mental flash backs? Perhaps these giants are simply evidence of a diverse range of entity sizes. (We must not forget the reports of tiny 'Lemurian' craft often only two feet across).

This brings us to the much less well known ability of humanoids, their capability to distort the structure of their bodies. The humanoids featured in the cover images of this issue 51.2 were also reportedly capable of grossly contorting their knee joints so they could circumduct them a full 360 degrees,

rather like a rotor blade. There was also reportedly solid looking three dimensional holographic projection of a Horus falcon (see left). This still footage also includes a characteristic blue spherical light that apparently emits the luminous bird silhouette as a 3d projection into empty space. It greatly resembles other blue lights seen at the Atherton Table lands in Australia. Are these the important clues to the question of huge variability in scale and appearance that afflict humanoid reports? Is there perhaps a UFO technology that morphs physical matter to either visually appear to take up extra space rather like a 3d magnifier lens or do they in fact physically meld their own matter to occupy a larger area?

Another extraordinary case involving a 'soft spot' like holographic projection.

On August 22nd 2004 from the porch of my home, located on a high ridge in Liberty, Kentucky, my boyfriend and I were watching the dense fog when the fog appeared to divide, forming a cylinder of bright light about three feet in front of us. My friend and I stepped off the porch and approached the beam, both of us attempted to enter the cylinder but as we stepped forward, the beam moved back several feet. We continued to chase the beam around the yard but it would not allow us entrance. When we turned away from the beam and walked away, the beam followed us, staying close at our heels. My friend continued to walk around the yard and the beam followed his movements but whenever entry was attempted, the beam moved away a few feet. I was able to peer inside the beam which contained a very bright shutter-like opening deep within the interior. When we stepped back onto the porch we noticed the ground beneath the beam appeared to be bubbling with thick plasma like substance although no heat was felt. The incident lasted about 10 minutes. The next day I surveyed my yard for evidence but found nothing. The only odd thing I noticed was that the water level in my swimming pool had dropped almost a foot. Several days following this incident I became very ill. I developed a severe skin rash which spread all over my body

and at the same time, a dime sized lump appeared on my breast. In addition to these symptoms, I was physically weak and nauseated most of the time. I did not immediately connect these symptoms with the August 22 incident wherein I had encountered the bright cylinder. Interestingly my friend reported that within days of our experience, I eyesight seemed to be failing. Alarmed, my friend sought medical attention and he underwent surgery on the optic nerve of his eye. My symptoms turned out to be breast cancer. I had 2 surgeries and 35 radiation treatments. Prior August 22, both myself and my friend enjoyed reasonable good health. I have never been prone to skin rashes and have always done self breast exams. The lump in my breast had a sudden onset, and appeared at the same time as the severe skin rash. Although cancer was the diagnosis, none of the 3 physicians I consulted could explain the origin of the rash.

My friend and I stood within inches from the opening of the cylinder and the immense bright light emitting from the beam. We interacted with the "craft" for at least 10 minutes. I don't believe there was any deliberate malicious intent on the "beamers" but the almost immediate dire physical effect on both my friend and me may have their origin from
