## Who Were the "Michelin Men" of Reunion Island?

he logo of the French tire company Michelin is a cute little man made out of tires of different sizes-an image which also looks like a person in a spacesuit. (This type of spacesuit was depicted in the late '50s in the popular comic series Tintin, when he and his companions went to the Moon.) Despite these cultural considerations, the two close encounters with "Michelin Men" reported by French residents of Réunion Island were real enough, with documented physical evidence and physiological effects. Both were investigated by the French Gendarmerie, a state police agency which is charged by law to receive UFO reports from the public. The Gendarmerie conduct all the interviews with witnesses and any necessary followup. The files are then passed on to SEPRA (the French UFO agency) for statistical analysis or further investigation.

The location of the two CE-IIIs was Réunion Island, a remote French outpost in the Indian Ocean. This volcanic island covers 969 square miles and has 705,000 inhabitants. Annexed by France in the 17th century, it is now an overseas department.

The first case, that of farmer Luce Fontaine, occurred in the morning of July 31, 1968, while the second incident, involving 21-year driver Antoine Séverin, took place on February 14, 1975. The remoteness of Réunion is an important factor in ruling out sociological contagion, particularly in a period long before the global culture of the Internet and satellite television. Séverin, for instance, had not even heard of Fontaine's case, though it was reported in the press.

#### The First CE-III on Réunion Island

Although we don't have the actual police dossier of the first CE-III, we do have a good summary of the case in the massive book by Michel Figuet and J.-L. Ruchon, OVNI: Le premier dossier complet des rencontres rapprochées en France (UFO: The first complete dossier of close encounters in France), published in 1979. We also have the November 1968 article published in the French journal Lumières dans la Nuit (Night Lights, usually referenced as LDLN) translated in England's Flying Saucer Review, as well as the beautiful color reproduction of the aliens made long ago by the defunct French UFO group GEOS.

At 9:00 a.m. on July 31, 1968, 22-yearold farmer Luce Fontaine was in an area known as La Plaine des Cafres, picking some grass for his rabbits. "I suddenly saw a sort of oval-shaped cabin in the clearing," Fontaine explained later. "It was 25 meters


from me [about 75 feet], and as though suspended at a height of four or five meters [12 to 15 feet] from the ground. The extremities of it were dark blue, the center part lighter, more transparent rather like the windscreen of a [Peugeot] 404. Above and below it had what looked like two glass feet of shining metal."

The GEOS painting puts the Michelin man outside the saucer, probably to highlight its funny shape since it was part of a set of slides of different types of aliens. But in the real incident at Cafres no such thing occurred.

Basically, Fontaine described two humanoids about 90 centimeters tall (less than three feet) inside the transparent cabin, dressed in the so-called Michelin gear and wearing a shiny metallic helmet covering their faces. One of them was standing with its back to him, but the one on the left turned and faced him. Fontaine's statement continued:

"Then both turned their backs to me, and there was a flash, as strong as the electric arc of a welding machine. Everything went white around me. A powerful heat was given off and then as it were a sort of blast of wind, and a few seconds later there was nothing there any more."

Fontaine rushed to the site but couldn't

find any noticeable landing traces. He first told his wife, a local teacher, and then reported the encounter to the Gendarmerie. The inquiry was conducted by Captain Maljean of St.-Pierre, and Captain Legros of the Civil Protection Service. Luce Fontaine's reputation was excellent, and so everyone—including the police—believed the story without any doubt. But there was

Capt. Legros checked for radioactivity in the landing area ten days later, and found eight radioactive spots on grass and pebbles measuring up to 60 thousandths of a Roentgen. This count is rather low, but it was surmised that it might have been far higher right after the incident, given the

time elapsed and the heavy rains on the days in between. Radioactivity was also found on Fontaine's clothes—precisely on the side which faced the UFO.

All this led in the following months to a series of bizarre rumors that Fontaine had been flown in secrecy to the Curie Foundation in Paris and treated for radiation sickness. All these stories were false, as often occurs even in good UFO cases. According to Figuet and Ruchon, Fontaine experienced abundant nosebleeds and had to recover at home on the days immediately after the incident, but he soon recovered fully.

Antoine Séverin, the witness of the second CE-III on Réunion Island, wasn't so lucky. His physiological effects were quite traumatic.

#### **Blinded and Struck Dumb**

We do have the complete police dossier on the second CE-III with "Michelin" men on Réunion Island. It runs into dozens of pages, featuring interviews with the witness, his family, neighbors, the doctors who treated him, his boss, and so on. The inquiry was conducted by Lieutenant Colonel Lobet of the National Gendarmerie, and it was published by French journalist J. C. Bourret—together with many other official documents—in his 1976 book, *Le nouveau défi des o.v.ni.* (The new challenge of UFOs). We also have an excellent

summary of the case written by Capt. Guillaume Kervendal, the Gendarmerie's top UFO expert, for the official military journal *Armées d'aujourd'hui* (Armies of Today) in September 1975, just a few months after the incident itself.


While very little known, this case should be a classic of that very uncomfortable but at the same time convincing category of UFO incident: the physiological injury cases, which have been documented by John Schuessler, Bob Pratt, and others.

Let's quote from Captain Kervendal's summary:

"It all started with a dream during the night of February 11 to 12. But was it a dream? Antoine S., a young 21-year-old delivery chauffeur, heard or believed to have heard a persistent 'bip-bip,' at times near, at times farther. That noise, which broke his ears, continued until the 14th, at 12 hours 5 [minutes]. After buying some candy, he was walking home. shock that he was both blind and mute. He tried to explain what had happened to the gendarmes, gesturing wildly but unable to talk. Everyone in his family, his neighbors, and his employer vouched that he was a reliable and responsible individual. No solid landing traces or radioactivity were found on the site, but there was still one more troubling detail duly noted in the police reports and in Capt. Kervendal's summary of the case:

the so-called elementary particles to yield up the world we know of in juxtaposition and sequence. If this were not true, then there could be no prophetic dreams, as there would be no sequence to follow. There must therefore be a past, present, and future.

how he responds to the sequence of events, time itself. There is a past and a present, but also a future. If the Gods live in the world of the two-slit experiment upwind of the photon interaction, then no matter what man does, he cannot overcome this huge limitation. #### Michelin Man in Michigan

Having just read Antonio Huneeus's UFO Chronicle about the "Michelin Man" (September 2003), I thought I'd share a report I got about something quite similar several years ago.

In the fall of 1992 I had just started working for a consumer research company. One day in the break room, Marie, one of my co-workers, started telling me about a strange experience she had had on the previous Memorial Day weekend.

Marie and I both lived within two miles of our workplace on the northwest side of Grand Rapids, Michigan. She lived on the edge of a relatively remote, overgrown park which had been an artillery practice range during World War II. On the night in question, her small dog had awakened her because he wanted to go outside. She watched him race toward the park barking aggressively.

Suddenly he stopped. Coming toward her was a three- to four-foot-tall "thing." She told me that it looked just like the Michelin Man or the cartoon cloud chara black panther. It is still in its pen.

For a number of years we have been spotting black cats (panthers) on our farm. Yet no wildlife people will accept these sightings. According to them, there are no native black panthers in North America. There were no native coyotes here until just a few years ago. When we first began to see them, we were told that we were seeing dogs. Now the wildlife people say we have coyotes. I guess they built barges and poled across the Mississippi River.—George H. #### **Strange Photos**

I was delighted when I read your August 2003 issue. One of your readers had sent a photograph of her son's car with a large snake hovering over it. (See page 97 of the August 2003 issue.) Now I know nothing is wrong with my camera.

The photograph I'm enclosing to you was taken sometime in the late spring of this year. I snapped the photograph at a place I frequently go hiking. I didn't see the snake at the time, and I only took the snapshot because it is very beautiful along there. It wasn't until July, when I had the roll of film developed, that I saw the snake.

The snake looks very translucent as it slithers above the grass. In the upper left-hand corner of this photo there is also a blue orb in front of the tree branches. The camera was pointing almost due west. In the upper right-hand corner you can see the day-ending sun filtering through the trees.

As if that isn't incredible enough, I also captured a ball of light in the sky on the same roll of film. This picture was taken about 300 yards to the west of where I took the photograph of the snake.

You can clearly see my shadow in the lower right-hand corner with the camera

up to my face as I was taking the exposure. That indicates the sun was behind me. So, what's streaking past me in the upper left-hand corner of the photograph? As with the snake, I never noticed the ball of light when I depressed the shutter button.

The two photographs are separated by three other exposures, so I can't definitely say they were taken the same day. But my hunch is that they were.

The area where I took these photos is a strange, isolated place. And on at least this day, I believe a portal had opened up.—
