two or three days dead." There were no signs of predators, "In fact, the animal layed there for a full week and not even the coyotes touched it. Not one bite! Finally, it decomposed by itself," said Mrs. Verchomin.

On July 16, a two-year-old Hereford milk cow was found with the rectum cored out and one teat cleanly removed from the udder as if "burned off." Part of the tongue and several teeth were gone. On the left side of its neck was a four-inch slit with a one-inch-wide and two-inch-deep hole in the middle of it.

Tissue samples were taken from the outer region of the rectum and vulva, and forwarded to Dr. Altshuler. He found the excision lines to be <u>darkened</u> and <u>plasticized</u>; under the microscope the cells revealed <u>exposure</u> to <u>high</u> heat.

Mutilation reports are not confined to cattle. They have included most domestic animals, including house cats. Since the 1970s, there have been waves of cat mutilations in Canada, California, Texas and again in 1992. From May 15 on, cats were found dead and mutilated in Vancouver, British Columbia, Canada. Typical was the purebred Russian blue cat that was put out in the evening and never came back. The back half of the cat was found three blocks from its owner's home without a trace of blood. It was the fourth cat found cut in half in a two week period. In the summer of 1991 in Plano, Texas, an upper middle class community north of Dallas, the police department had nearly 100 reports of missing domestic cats along with several mutilated ones.

After my book, An Alien Harvest,\*\* was released in June 1989 about animal mutliations, human abductions and government knowledge, I received a letter from a security guard in Denver, Colorado. He described a night in August when he was patrolling the grounds of a large corporation west of the city. From his truck, he could see a large circle of lights in the dark sky. The lights remained stationary over a pasture a few hundred feet from where the guard watched. He never phoned anyone because he was afraid if he uttered the word "UFO" he might lose his job. But the next morning, he felt guilty as he watched a farmer gather up two dead and mutilated cows from the pasture where the lights had hovered overhead. He asked me, "What kind of technology are we talking about? I never took my eyes off those lights. There was no beam, no sound, nothing. How did they do it?"

If alien life forms have been involved with nearly three decades of worldwide animal mutilations and disappearances, what is it the aliens need?

In 1980, Myrna Hansen and her young son saw two whitesuited beings working on a cow near Cimarron, New Mexico. The cow was bellowing in pain, and Myrna tried to interfere. The result was that both she and her son were abducted by large, brightly-lighted disks which took them to

an underground facility which she thought was in the Las Cruces region. There Myrna saw a <u>humanoid figure</u> floating in a vat of reddish liquid which she perceived to be a "treatment" or sustenance of some kind for the immersed being. She also thought the liquid was related to blood fluids and tissues removed from animals.

A decade earlier in 1973, Judy Doraty watched a brown and white calf rise in a pale beam of yellow light. Inside a small, round, white room, she saw tissue excised from the calf's eye, tongue and testicles by two, small, greyskinned creatures with large eyes. They had four fingers, instead of five, and those long, thin fingers tapered to dark nails. Their eyes were not solid black, but were yellow with a black vertical pupil like a cat's or a snake's. Judy's daughter, Cindy, was also abducted at the same time, and in a 1990 hypnosis session with psychiatric hypno-therapist John Carpenter in Springfield, Missouri, also reported seeing a calf rising in a beam of light. Judy had the clear impression that what the alien beings were doing with the calf had to do with survival — theirs and ours.

In both the Cindy Doraty and Myrna Hansen cases, the women were examined by the beings. Eggs were removed in a painful procedure from Myrna's ovaries. In some cases, men and women have been shown "baby things" which they are told are hybrids, part human and part something else.

If genetic material is what the alien intelligence wants why does it need so much over so many years? And why does it leave animals to be found with strange, bloodless excisions that provoke fear and anger?

universe. In each mirror there is a you and there is an object. I and it, it and I. And in each universe there is a question: Why is this universe different from all other universes?" (4)

An even more urgent question is: Why would this advanced intelligence want to genetically mix their species with ours? And where will all the hybrids live?

#### PART III

#### MYSTERIQUS ANIMAL MUTILATIONS

Now I would like to move on to another part of the UFO jigsaw puzzle: the link between alien life forms and worldwide animal mutilations which began in the 1960s and continue to date. Not only have strange, silent lights been seen over pastures,

but in 1974, in Minnesota, a mutilated cow was found lying right in the middle of one of these circles. A newspaper reporter flew with a photographer over the site and discovered all these overlapping circles. I am not suggesting that the same force or intelligence involved in the crop circle mystery is also responsible for the animal mutilations. What I am showing are the patterns of evidence that are found in the UFO puzzle--and mutilated animals occasionally have been found inside circles.

#### SLIDE 40: SMALL BEING AT PASTURE GATE (Missouri, 1976)

One horse farm owner in Missouri reported that in 1976: He and his son saw a small, gray creature wearing some kind of helmet at their pasture gate.



#### SLIDE 41: SILVER DISK IN HORSE PASTURE (Missouri, 1976)

Later, he saw a silver lens-shaped disk setting in his horse pasture. After it was gone, a circle of dead grass and hard soil remained for over a year. During that period of time, he found five mutilated baby foals, each cut with the precision "of a knife in jello," as he put it. These drawings are by Springfield, Missouri artist Lisa Dusenberry.

Animal mutilations are worldwide and have been reported for 25 years. Eyewitnesses in Texas and Missouri have reported non-human, small gray beings with large black eyes associated with cattle. In a 1980 case, a Texas rancher saw two creatures carrying a calf he later found mutilated.

## SLIDE 42: RON AND PAULA, BEINGS WITH BLACK COW (Missouri, July 1983)

In 1983, Ron and Paula Watson of Springfield, Missouri, watched small, white beings in a pasture with a creature described as looking like a "lizard," and another looking something like a large, round-eyed Bigroot. The couple watched as the small gray being floated a black cow into a nearby cone-shaped craft.

In an earlier 1973 Texas case involving a family of five, both the daughter and mother reported seeing a calf rising in a beam of pale yellow light into something hovering silently in the sky above. Judy Doraty and Cindy Tindle saw during this abduction that animal parts were removed by small, gray, humanoid beings with large eyes that had vertical slits "like a snake."

For those who might not be familiar with the pattern of bloodless, dry excisions in the animal mutilations, here are some typical examples:

SLIDE 43: (1976) - Budin Ranch, Sterling, Colorado.

SLIBE 44: (1988) - Weld County.

SLIDE 45: Vanhuisen Farm in King County, Washington, south of Seattle.

SLIDE 46: CU cow's mouth.

SLIDE 47: Cored rectum, 9-15-89, Bear Lake County, Idaho.

SLIDE 48: Cored out rectum and tail gone, female calf, Idaho, 10-8-89.

SLIDE 49: Cored out teats, Idaho cow, 10-9-89.

SLIDE 50: Hope, Arkansas, 3-10-89, neat oval cut in haunch.

SLIDE 51: Cooked cow blood, Hope, Arkansas mutes.

SLIDE 52: Headless rabbit, Sound Beach, Long Island, N.Y., Apr. 21, 1990.

SLIDE 53: Rabbit with missing eye. Same place and date.

SLIDE 54: Dr. John Altshuler, pathologist and hematologist in Denver, Colorado examined tissue from both rabbits microscopically and found that the excision lines had been caused by high heat, the blood was cooked, just as it had been in the Arkansas cows and at least a dozen other cases we have investigated since then.

The rabbits are similar to hundreds of domestic cat mutilations reported in Canada in 1978; California in the 1980s and most recently in Plano, Texas-an upper middle class suburb north of Dallas. Since last

spring, the police department in Plano has received reports about eight mutilated cats; one puppy that had all organs bloodlessly removed; and a mutilated calf. And in August, eighty-five domestic house cats were reported missing. All with address and phone collars. Not one has turned up anywhere.

I would like to show you a brief excerpt from an edit workprint I did for the FOX-TV Network special, "UFO REPORT: SIGHTINGS" which shows not only evidence of high heat used at the excision line but shows photographs of a very peculiar serrated edge found by law enforcement in Montana in 1976 and photographed on a steer near Portland, Oregon in 1990.

#### VIDEO 1: FOX MUTILATION SEGMENT (Serrated edge and Randy Lee)

Thanks to the good reporting network of Oklahoma MUFON investigators Richard Seifreid and Jean Waller, I have been in discussions with sheriffs in six counties in Oklahoma where there have been more than a dozen cattle mutilations reported since the beginning of January 1992. One of those sheriffs, Archie Yearick in Grant County, talked to me about part of his confusion. He said, "If Satanic cults were involved, why weren't there any tracks at the mutilation sites of five cattle I've dealt with since August?"

I talked with Oklahoma MUFON investigator, Chuck Pine, and asked him if he would go visit Sheriff Yearick. On Saturday, February 1, Chuck made the trip and Yearick told him that he heard there was a fresh mutilation in Caldwell, Kansas, just over the border.

#### SLIDE 55: HEAD - Caldwell, Kansas Steer, Feb. 1, 1992

Chuck went there and told me the cow looked just like the pictures in my book "An Alien Harvest." (1) Here's the head with jaw flesh absolutely clean and an oval scoop taken with teeth from the lower jaw.

SLIDE 56: CU Hole in Belly, Kansas Steer, Feb. 1, 1992

In the belly, was this precise, round excision.

#### SLIDE 57: Head, Caldwell, Kansas Steer

Chuck took these photographs of the Caldwell, Kansas mutilation and excised four tissue samples from the head, genital and rectum area. I arranged to ship the tissues to Dr. John Altshuler in Denver who found the excision lines had been made by high heat, estimated to be at least 300 degrees Fahrenheit, as we have found in more than a dozen other mutilation cases since 1989.

Odd lights in the sky were seen near two of the Oklahoma mutilations. On February 6, near El Reno, Oklahoma, a farmer found a young, mutilated steer lying dead in a pasture. The wounds were dry and

bloodless. His son was so amazed by what had happened to the animal that he got his girlfriend to go see the steer that same evening. As they neared, both saw a large, round white glowing object above the pasture. As they got closer, they could see red, green and blue lights rotating around the rim. The girl was frightened and the boy took her back home. Then he picked up his father and headed back to the pasture. The large white object was gone, but in the sky they both saw a moving "star" that stopped. When they turned their car around to get a better look, the "star" sped off in another direction. Two days later on Saturday, Feb. 8, they found a second mutilated steer just like the first one in the same pasture.

Chuck Pine again helped me get tissue samples from those two steers and Dr. Altshuler this time found no evidence of heat. Why the inconsistencies from case to case, we don't know?

A man named Mike Markum from Cement, Oklahoma, wrote me about rumors of cattle mutilations in his area and his encounters with odd lights: "Near the beginning of January, me and my wife saw 2 bright objects going over our country road. They were not very high up. . . . As one object passed over the road, it just 'blinked out.' It was very bright and then immediately nothing. . . . We heard no sound. Within the last year or so, I have witnessed 'sparkler-like' balls going over our house at low altitudes. One ball shot off at tremendous speed and left a green trail behind it. Another object was sailing across a perfectly clear sky, stopped and just blinked out. Having worked on aircraft myself at Tinker Air Force Base, I do not believe these were any military vehicles."

At the same time as all this activity in Oklahoma, there have been orange lights and mutilations reported in Missouri, Arkansas, and Pennsylvania.

#### SLIDES 58: PENNSYLVANIA NEWSPAPER HEADLINES

A police chief in Williamsport, Pennsylvania, reported that a triangle-shaped craft about 50 feet in diameter had hovered so low to the roof of his house that he checked the shingles to see if they had been burned. The police chief called his dispatcher and reported that the triangle had a blaze of gold-white light around the perimeter and he could see a brown-black metallic surface inside the light. As the craft moved very slowly down into the valley, he could see a round, white bubble of light on top. The police chief was furious the next day when the newspapers reported that a C-5A transport plane had been sighted over his house. In fact, the chief had reported a UFO to his dispatcher and the National UFO Reporting Center. Dr. Samuel Grecco, MUFON investigator, conducted thorough interviews with many of the witnesses of the huge multiple objects observed at close range on February 5, 1992. (5)

The high strangeness in the mutilation cases I've investigated is illustrated in a horse mutilation discovered August 30, near McCall, Idaho, a small town surrounded by large ranches where cattle are raised. In August, a 14-year-old mare was found and the owner wrote to me: "It is different than anything I have ever seen. There was no evidence of blood anywhere. The lips of the labia had been removed. The left ear was gone and the left eye had been removed and the esophagus was cut out."

Dr. Bob Stoll, a vet from McCall, opened the lung cavity. He found that the lungs were completely void of blood or fluid--in other words, dry. He cut open the heart and it also was dry. He told the owner that the incisions in the hide were definitely, in his opinion, knife-like cuts, not bites or tears. Dr. Stoll wrote on his invoice for services rendered that the horse was: "Bled out--no blood in body cavity nor heart. Skin cut with knife." And yet, for cause of death, the vet wrote, "died from stomach rupture." The owner angrily told me, "That horse did not die of a stomach rupture!"

As mutilation reports like these have accumulated in my files over the past decade, I often think of the Air Force intelligence officer at Kirtland AFB in Albuquerque who told me in 1983: "That documentary you did, A STRANGE HARVEST, upset some people in Washington. They don't want UFOs and animal mutilations connected in the public's mind." But denying that alien life forms are here, abducting animals and humans to harvest tissue and fluids, does not change the fact that it's happening.

#### HUMAN ABDUCTIONS, IMPLANTS AND HYBRIDS

It's not only government denial and suppression of the story that confuses the truth. The alien intelligence itself seems to use deceptions and disguises, perhaps to keep humans from finding out what they are really up to.

#### SLIDE 59: Paula with Bubble on Stomach

Both animal mutilations and human abductions are difficult subjects for most people because no one likes the idea of a non-human intelligence having the ability to pluck us or earth animals at will in beams of light, and subject us to examinations and harvests of blood, tissues, sperm and eggs, to create a part human, part alien hybrid species as implied in the presentation of baby creatures to abductees.

Abductees report that one of the alien tasks is to study our biology, emotions and mental reactions. If so, then the experimenters might need to remain hidden. Otherwise, they would interfere with their own investigation because their public presence among us might overwhelm normal human social functioning.

One California abduction case highlights both alien use of deception and a possible implant. The exact purpose of alleged implants



is unknown, but abductees do report either consciously or under hypnosis that a non-human creature stuck an object up a nostril or in an ear--or in this next case--under the skin of a 4-year old boy's ankle. Watch this excerpt from one of my work tapes I edited during the FOX-TV production and notice the drawing this abductee did of what he and his brother thought they saw:

VIDEO 2: Jesse Long segment - 2 minutes

SLIDE 60: JESSE LONG'S DRAWING OF "HOUSE CONSTRUCTION"

Remember that house construction that Jesse thought he and his brother came upon before they were blasted with a light beam and Jesse found himself on his back? Was it a house under construction, or an illusion to disguise a craft? Recently I received a letter from a Delaware resident who told this story: "My one and only UFO sighting happened in 1948 when I was 13 years old. It was an unbearably hot night in August and my grandmother and I were sitting on the front porch to catch whatever breeze there was. It as about 2 a.m. and things were very quiet. All of a sudden, we noticed two lights played over a nearby school The lights were puzzling, not only because of the hour, but also because of their location near the top of the three-story school Finally, I walked down toward the school yard to get a better look at what was going on.

"At a point about 50 yards from the wall of the school, I could see quite clearly a very simple platform-like structure which I assumed to be attached to the building. It looked for all the world like a cross between a common scaffold and the wing structure of an early biplane. About 45 to 60 feet long, it consisted of two horizontal "planks" connected to each other by three "x-type" cross-struts. At the inside edges of the outermost struts were two large and very bright lights which were engaged in scanning the walls and peering in through the third floor windows of the building.

"I assumed at first this was some kind of construction project. But whatever it was seemed to be operating robotically, methodically sweeping the walls and peering in the windows. I entered the school yard and slowly approached the strange looking "scaffold" in the air. I had not taken more than three or four steps into the school yard when suddenly one of the lights shown directly on me, temporarily blinding me with its brightness. Just as suddenly, both lights turned downward toward the ground and went out.

"The light beams took about two or three seconds to extinguish completely, transitioning from white to yellow to red before going black. A moment later, without any sound of its own and without creating any wind noise, the entire structure sped off and disappeared from view. The acceleration was astonishing: the structure went from a dead stop to what I now think must have been more than 100 miles an hour in a split second."

# MOVING LIGHTS, DISKS AND ANIMAL MUTILATIONS IN ALABAMA

#### Linda Moulton Howe, M.A.

#### ABSTRACT

From October 1992 until March 1993, thirty-two mutilations were reported to the Fyffe and Albertville, Alabama police departments. Beginning in January 1993, dozens of people reported odd, bright moving lights over their homes or pastures; dozens more reports described unmarked helicopters in pastures and loud, vibrating chopper sounds in clear skies. At least two families reported large, disk-shaped objects within 45 feet of their bedroom windows.

I was able to help get a substance found on a cow's face to a university laboratory for analysis which confirmed that the substance is an unidentified inorganic compound. I was also able to get tissue samples to Dr. John Altshuler, pathologist and hematologist in Denver, Colorado, who confirmed one cow's udder had been cut with a sharp instrument and that six tissues from another calf had been cut with high heat.

On April 7, 1993, the Fyffe, Alabama Police Department held a press conference and about forty-five reporters from three states attended. The media coverage about the animal mutilations has been extensive, including a CNN report. The animal parts excised are similar to those removed in animals worldwide since the late 1960s. Circumstantial evidence in eyewitness reports continues to link a non-human intelligence to the phenomenon.

In early January this year, I received several phone calls from Fyffe, Alabama police officer Ted Oliphant about animal mutilations occurring in northeastern Alabama. There were also many reports of strange, moving lights in night skies. One farmer saw a red-orange pulsing object the size of the full moon at 2 a.m. over a pasture where they found a mutilated cow later that day. Other lights were compared to the blue-white of the planet Venus and said to be three or four times brighter than that planet. A family of five watched one light above

their home and said it was so intense, it lighted up the ground brighter than moonlight.

There were also constant reports of helicopters, day and night. One farmer copied letters and numbers off a chopper in his pasture. The Albertville Police Dept. checked with the FAA. The helicopter was not registered with the federal agency and that implied to the detective, Tommy Cole, that it was either a military or government intelligence vehicle.

There were also reports of unmarked helicopters landing in pastures, some at night without running lights. Those were reported because farmers could hear the loud, roaring sound of the chopper landing. But in several instances, when the loud helicopter sound was heard, there wasn't anything visible in the sky, day or night. Similarly, in Colorado and other states in the 1970s, people also reported hearing helicopters they could not see.

I went to Alabama with a video crew the last week of February to explore the mystery for a new documentary, and would like to begin today with some excerpts of what local residents around Fyffe, Rainsville, and Ft. Payne, Alabama, videotaped on their camcorders in February of this year. First, let's look at a map for orientation of the area.

SLIDE #1 - MAP Wideshot of Alabama, Georgia, Tennessee corner.

SLIDE #2 - MAP Closeup of Fyffe area.

On February 18, 1993, at 7 p.m. in Ft. Payne, AL, a woman named Susan Eads videotaped a large white light in the sky above her home. If a VHS camcorder is zoomed in on a light and not focused correctly, an odd shape--like a Batman emblem, occurs. That's what happened in the next sequence. But there still was a moving, bright light in the sky above the Ft. Payne home.

<u>VIDEO #1 - C(2:30) - Time Code:</u> 02:22:48 to 2:25:19 Feb. 18, 1993, 7 p.m.

Light above home of Susan Eads, Ft. Payne, AL

#### SOUND UP FULL

Do you see it? Believe it or not, they left the white light moving in the Real Life Sky and went in the house to watch their tape on TV. It was as if nothing were real until they saw it on their television set!

On Sunday, February 21, thunder and lightning raged throughout northeastern Alabama, Georgia, and Tennessee and tornadoes caused severe damage. The crew and I were in Ted Oliphant's police car listening to radio reports about strange lights between Fyffe and Albertville. There were also calls about unidentified helicopters which puzzled law



enforcement because the weather was too violent for choppers to be flying. And when the police checked airports for IDs, no one knew of anyone on flight plans.

While we were chasing light reports, a mother and son about 30 miles southeast of Fyffe in Cedar Bluff, were videotaping first one light, and then several right above their house at 7:30 p.m.

## <u>VIDEO #2 (5:10)</u> - T.C. 02:07:08 - SOUND UP FULL CRICKETS to 02:08:38, February 21, 1993

Approximately 7:30 p.m. - Tape B was actually taped first until need for tripod. Then a battery change. After that, Tape A began 20 minutes later.

Tape B (Beards)

- A) 30 SEC Dub from 2:07:08
  "I got it right here. It moved!"
- B) 1:30 SEC Dub from 2:20:54 to 2:08:38
  "It's moving to the right.

Wants to get tripod.

"Now it's gone!. GOES TO BLACK at 2:08:38

After James got his tripod, the tape isn't much smoother because the object moved side to side, up and down and in and out and the mother kept moving the camera to follow. But what happened next is not a shaky tripod. You will see the bright, white light suddenly disappear and in its place are several bright objects flashing on and off at different times. Or one object jumping in space. Or perhaps lights flashing on and off that are attached to an enormous black object which cannot be seen. The mother and son did not know what they were looking at except that the big white light stayed in the sky off and on, while the smaller bright lights flickered on and off over a wide area of sky.

#### Tape C

## C) 3:10 - Dub from 2:14:30 to 2:17:40 JUMPERS begin at 2:14:54

("God!" They're jumping everywhere. "This is second one, not the big one. This is one (smaller) that keeps circling it (the bigger light.)" Now you can hear thunder, lightning and dogs in the background. But no sound at all from the unknown objects. At 2:17:10 you can see big white object in addition to small, jumping lights. At 2:17:40, all the lights blink out to BLACK. Then they had to replace the camera battery. It took 20 minutes and when they went back outside, this is what they saw.
