



## How do we react to UFOs; with anarchy or civilisation?

A metropolitan policeman wrote in early August 2004. At about 04.45am I was on duty at \*\*\*\*\*\*\* Police Station and my partner was working in the control room at \*\*\*\*\*\* at the time. A member of the public phoned the room stating that she and her husband were watching a strange object in the sky above her house. The call was logged and my partner requested a police unit to respond over our personal radios. At the time I was with several other officers and we all had a good laugh. This was because we receive many silly calls from the public and this appeared to be another one. An officer was assigned who attended shortly after. All other officers remained at the station.

On arrival this officer called up over his radio that he was indeed watching a large object in the sky. He described a large solid object with lights rotating around its middle. On hearing this all the other officers including myself left the station to go and look at this possible UFO. During this time my partner and several other officers watched the object on the CCTV. The CCTV is controlled from the control room which is based at \*\*\*\*\* and uses state of the art equipment which covers the area extensively. The control room watched three different objects in the sky; all were different. By the time myself and the others arrived the objects were gone, but they were seen from 2 police officers on the ground and from officers in the control room at \*\*\*\*\*. That morning my partner and I collected the CCTV from the police control room at \*\*\*\*\* in a sealed evidence bag, but the control room staff had taped a second copy for us. I spoke with the CCTV control room staff who stated that they watched and recorded the three objects in the sky over \*\*\*\*\* and could not explain what they saw. At the time the police helicopters were contacted but they stated that they were all grounded at the time.

The next day the M.O.D. arrived and took away the tape, and we have not heard from them since. I have watched the tape and it's very weird. You see a ball of light in the sky and it is travelling very fast from left to right across the screen. This ball of light then expands to about three times its size and stops in mid-air and then comes down behind some trees. The second object is different and again travels from left to right across the screen. This object is bigger and again stops over the trees where the first object went down. This object appears to be rotating and looks solid with blunt edges. The third object cannot be seen on the CCTV tape but was described by the CCTV control staff as a jelly fish type object.

This report suggests that UFO craft were filmed on police CCTV landing in the Greater London area in early August

2004. These objects may only have been momentarily and locally visible by sheer chance. An alien strategy that routinely secretes their craft on the ground in and around our capital may be anything but a fantastic idea. Their very appearance over our metropolis would be quite plausible if we recall the silent invisible stealth technology commonly employed by UFOs, and the possibility that these craft may also utilise local time-field distortions that may further conceal their activities. Reports of these "drop UFO craft" landing under cover of woodland, also on urban scrub-land and even MOD land under sensitive air space are suggestive that something akin to subversive air commando operations may be taking place under our noses. Are these strategic insertions of UFO craft and alien personnel the regular city-wide UFO sightings have been coming through this office in recent years?

This particular weekend, in early August 2004, was crucially significant because civilian observers had already picked up the presence of these grounded craft in the Greater London area a whole 24 hours prior to the police sighting, and probably well before the authorities had been mobilised. Civilian observers had a succession of near encounters involving some element of communication with these craft and others. At one point a complex flying object christened "The flving City" was seen arriving and then leaving the area after an hour at speed. The next day a large white arrow-shaped craft was observed leaving the West of London and was intercepted by a wing of strike aircraft near Reading. The object appeared to target the centremost aircraft of the formation and subsequently accelerated to pass through their line, causing one to drop rapidly and almost lose control; a near crash. Civilian ufologists soon came into contact with the police unit featured above after the event and agreed to view the CCTV footage of the craft. An address was given and a date on which to meet the officers involved. Two nights later the owner of the property assigned for the meeting was awoken at dawn by stepping sounds on his stairs. His dog stood motionless at the bottom. The front door was wide open. A tall shadowy figure retreated back down the stairs. This attempt to meet with police was abandoned and no further contact was forthcoming.

This editorial was written to remind us of the folly of those who exclusively prevaricate on the cultural, psychological and document-led aspects of the UFO phenomena in order to confine it to the sedate realm of the technocrat. What is apparent to those with eyes to see is that prolonged technical debates will establish nothing at the front end of our subject; the acute security problem of the incursions and the likely steady infiltration of our society by the objective mind of an alien power.
