are torn and scratched. Other animals are left wounded, and, after adequate treatment, they recover completely.

Arturo López Pérez, a wealthy cattle-owner from the locality of Sarria (Lugo) even fired shots to scare off the wolves. He told us: "Thanks to that, of my animals they killed only one heifer. Had it been otherwise, God only knows what destruction they would have wrought. They killed the heifer calf because wolves always attack the WEAKEST of the animals." (Statement to us when we visited his farm at Pena).

Others who lost a number of cows and heifers as a result of the wolf were Manuel Pombo, Carlos Valladares and Antonio Albaredo. A man named Ramón, owner of a furniture store, lost two valuable colts. None of these animal deaths pointed to anything *abnormal*, despite the fact that that particular region is not one with many wolves.

But, on the other hand, we encountered a whole series of cases showing a very distinct pattern and fully deserving of the label "Strange".

Julia Chousa Losada, co-proprietor of the farm "Os Dogos" (= English "The Bulldogs". G.C.) at Barbadela, lost 35 sheep. Her detailed account of the wounds was very different indeed from the other category mentioned above. She said: "The sheep had two little round holes right in the neck... Outwardly it hardly looked as though they had any wounds at all. All that you could see was just a tiny bit of blood... One of the sheep had a small gash... As for being eaten, none of the sheep were eaten at all.... Five were still alive, but after a few days all of those were dead. None of them recovered. There was even one that was still standing, and I got hold of it and said "This one can still be saved'. But no sooner had I said it than the animal fell down and died. Many of the ewes were carrying lambs. It 'went for' the youngest, the most lively. Normally, wolves always attack the weakest."

In fact, so do all the predators. Curiously, just as in other cases, we found footprints there of two different sizes.

These happenings in Galicia show us once again that we are confronted with two distinct problems. ON THE ONE HAND - THE WOLF. ON THE OTHER HAND, "THAT OTHER THING".

A STRANGE AND ELUSIVE CARNIVORE KILLS SCORES OF CATTLE ON THE FARMS OF TERUEL *. (TERUEL, 40°22N., 1°08W. G.C.)

VICTIMS LEFT WITH THROATS SLASHED AND BLOOD SUCKED OUT

More than 80 head of cattle have been killed by a mysterious predator that, over the past two months, has become legendary and is destroying both the sheep and the savings of farmers in the Teruel districts of Almohaja, Santa Eulalia, Ródenas, and Pozondón, the losses totalling Pesetas 800,000.

According to a statement published in the newspaper *Heraldo De Aragón* last Monday, nobody knows whence "it" came and very few have managed to get a clear view of it, despite the organisation of numerous unsuccessful "sweep-searches".

The characteristics of the animal are: *great intelligence*, shown by its stealthiness; its skill in leaving no tracks; it enormous ferocity (for it leaves its victims with the throat slashed and some folk even assure us that it sucks the victim's blood); and its terrifying appearance, a sort of cross between a dog, a wolf, and a fox.

There are already various theories as to what species the animal belongs to. Many think it is a wolf - an animal that vanished from this Teruel region (due east from Madrid. G.C.) all of 50 years ago. - and there are others who think it is a cross between dog and fox and even betwen dog, fox and wolf. But these hybrids would be biologically impossible.

The most reliable version is that it is a wolf or a dog "gone wild". Though it is quite possible that there are several of them, since the attacks have been very numerous and have often occurred in various places simultaneously.

A group of naturists have promptly started demonstrating in front of the Provincial Office of Agriculture saying that it is illegal to carry out sweep-searches without having secured the necessary permission - particularly if -as the ecologists insinuate - "the opportunity is being taken to shoot anything that moves".

There have also been warnings that it is illegal to kill a wolf, or several wolves, because in any case this species is already protected thoughout Spain.■

Don tells me that he has on file a "choice collection" of no less than a hundred or so truly "nasty" abduction cases. I hope that eventually we may even be able to publish *all* of them. In the meantime, I asked Don to let us have an initial instalment of six of his "nastiest", and here they are.

It seems that, apart from case No.1. ("Mary Brock" - a pseudonym), the names given in all the other five cases are their real names.

I suspect that there are not a few people in the United States and elsewhere who strongly disapprove of Don Worley and his writings - no doubt because he likes to try to "tell it as it was" - warts and all. A very bad habit! EDITOR OF FSR]

INTRODUCTION.

The presence of black-suited or cloaked entities and their autos in a low percentage of abductee cases is a documented fact. In this type of phenomenon, usually called "Men in Black (MIB)", it is abundantly clear that these unseen emissaries from darker realms dimensionally coexist with us in this time-frame. They are another extension of the UFO intelligence, surfacing to play their incredible games from the edge of a reality of which we are not aware. One can trace these enigmatic forms back into Antiquity. "Brethren of the Shadows", lurking in darkness, and very real to the Ancients, who rightfullly equated them with evil. You may choose to feel that all of this is hearsay and fantasy, but I have investigated the following cases and I am urgently telling you such an attitude is wrong and pure self-delusion.

The acquisition of MIB data has been very haphazard and apathetic so we probably fail to realize the actual inroads already made by this type of phenomenon. One thing is sure, the thick files I have on some of these cases represent gripping dramas that I can never portray in just these few pages. Although several cases have occurred quite near to me I have chosen to stay clear of the site when it was apparent that the MIBs didn't exactly welcome me there. I have chosen six of my best cases with MIB involvement, out of my total of 100 abductee cases. Seeking to simplify the MIB menagerie, I'll classify them into three groups; (A) CADAVER-LIKE MIBs, (B) TALL OR CLOAKED MIBs. AND (C) ORIENTAL MIBs.

1. CADAVER-LIKE MIBs. THE MARY BROCK CASE. (I did not have this person's permission to reveal her real name. In the other five cases, all names are real. D.W.)

A troubled voice on the phone was my introduction to this amazing case. As it turned out I never did get up to South Bend, Indiana, to meet her in a secluded outdoor place of her choosing. Seventeen years had passed, so Mary thought it was safe to telephone to me. We both were proved wrong. The silver saucer in a blue glow appeared on three nights running, and was witnessed by Mary, her family, and neighbours including a policeman. Mary's attempt at a photo got only black film and a damaged camera (which the Government men took away and never returned). As Mary was pulled toward her doorway, a coded bubbly voice came into her mind. It began asking about her work (under \$20,000 bond) in a manufacturing plant in Cleveland, Ohio, where she

worked on a secret Air Force device containing tiny glass tubes. Her physical effects following this event were severe headache, eye pain, brittle orange hair, and sunburned skin.

Several days later when Mary answered her door she found herself looking at a deathly-white-faced, glassyeyed individual. The figure wore a black silky topcoat and a hat. His message was that she was not to say a word about the UFO incident. Then he walked away with a limp, got in the back seat of a big black car with tinted windows and it drove away.

Now, after 17 years, Mary, with her children away and safe, had gotten up the nerve to call me. Four days later she was back on the phone and it became apparent that the MIBs didn't want blabber-mouth Worley finding out about this case. She said a big black auto was parking on the street out in front of the house and would leave when she turned out her lights to go to bed. Our next attempt to communicate was to send her 11 pages of questions and plan to set up a meeting date. One month later I heard from Mary for the last time. Our attempt to use the mails had brought the MIBs back to her door and this time the envelope containing Mary's answers to my questions that she had mailed that morning was displayed to her. She was told that they had people working everwhere, and that if she loved her three kids, three grandchildren, and herself, not to send me any more information.

2. CADAVER MIB. THE MILAN, INDIANA, CASE.

This series of events occurred only 25 miles south of me, in Dearborn County. On a sunny afternoon in January 1967, schoolboy Reed Thompson took an amazing photo of a monitor-type UFO as it moved slowly through the trees within 32 feet of his home. Dead tree limbs later marked its route. This was the start of a series of events which I would investigate continuing into the 1990s. Reed experienced lost time during the event, and later had nose-bleeding problems.

On a warm April day in 1973, two thin, longhaired, grotesque-looking individuals entered Reed's auto parts store in Milan, Indiana. Reed's shepherd dog ran to a corner and whined in terror. Several patrons in the store later could not remember the event. The beings were dressed in tan jump suits, and wore heavy gloves. It was their faces that were upsetting. A local news reporter later coined the term, "Plastic-Facers" to describe them. One of the creeps, speaking in a mechanical monotone, knew exactly when Reed had taken the UFO photo. He demanded the photo and negative immediately. Being of a stubborn nature, Reed replied that the photo was in a bank vault and would stay there. "Plastic Face" said it didn't matter, they would get it anyway. Meanwhile a man named Craft, a friend of Reed's, had hurried outside to see the car in which these weirdos had come. It was a 1969 bright yellow Buick LeSabre. Peering through the dark glass, Craft was stunned to see that the auto had no steering wheel or seats. As the creeps neared the car, Reed's elbow brushed one of them and this seemed to disturb it.. (Craft died two years later, and two autopsies failed to find the cause of his early sudden demise.)

Reed hoped his strange visitors were gone, but, as he was en route to the welding shop at Versailles, a wild twilight chase began, when his "nemesis" appeared, inches from his bumper. At the welding shop the "Plastic-Facers" parked right behind him, and followed him to the shop door like shadows. As Reed opened the door a blue arc- welder flash was emitted. Reed looked around, and found that the unwelcome pair and their phantom car had vanished.

Reed Thompson has had his share of abductions. His exits and returns at the hands of the aliens have been phenomenal. He is no stranger to scoop-marks and puncture-marks; Grey alien face recall; debilitating accidents; and ill luck in general. Big black Cadillacs or Lincolns might be thought "out of place" in quiet Milan or on nearby highways, but Reed and his friends have seen them, usually following at a distance. Reed never knew that his persecutors can appear in this fashion until I told him. I have urged him to make his UFO photo available and set it, as a protection, on his bedroom dresser, for the sake of his loved ones and himself. My own presence on the scene always seemed to be countered by them in various ways, so I have stayed clear.

3. CADAVER-LIKE. THE PAMARA CASE.

Pamara Johnson is a mother from Richmond, Indiana, who has near total recall of one of her abductions and of her strange experience with the MIBs. As often happens, Pamara was taken at sandbox age. When she was 14, on a sunny June day, a black limousine began to slowly circle the block where Pamara lived in Richmond. She went out on to her front porch to watch for it. The limo stopped, and a figure got out, and approached her up the walk. Pamara describes him this way, "He had on black pants, a black jacket and a black hat. It looked like a chauffeur's hat. He walked normal. His complexion was real white. His eyes were dark, and I didn't see any pupils in them. He spoke in a normal tone English. "I didn't hear any motor sound from the limo with tinted windows." The figure was polite, and wanted to know from her if a Rhonda Smith lived there. Pamara had never heard of such a person, so the figure thanked her and returned to the auto which then departed.

Shortly after that, Pamara and her sister left to go to a nearby store. The limo seemed to appear again out of nowhere. It pulled up to the kerb and Pamara saw a rear window go down and a rifle-barrel appear in it. Badly frightened, she shoved her sister behind a wall and jumped behind a nearby tree. Three shots were fired and she heard them hit the tree. The limo then sped away up 18th street, which is a dead-end. A nearby lady had seen it all from her home, and she called the police who soon arrived at the scene where the two weeping girls were. They dug the bullets out of the tree. And decided that it must have been a case of a hit-man choosing the wrong target!

Four years later, Pamara was to undergo the abduction she remembers most clearly. She and her mother and sister were taken near the little town of Abington seven miles northeast of here. it was a cold

December day but as the UFO came down, it buzzed the tree-tops. (Since dead.) Aboard the craft, Pamara had her confirmed foetus taken from her. The culprits were the Grey type aliens. A vibrating wire-type instrument was used. Pamara was also shown large jars with foetuses in clear fluid with wires running to them.

The family arrived home four hours later, and Pamara was in such a state that, terror-stricken, she had to crawl from the floor of the car and into her house. The mother and sister have chosen to never talk about their abductions to me, but the sister hides a neck implant with her hair. Each December it swells up and fluid runs out of it.

4. TALL OR CLOAKED MIB. THE PATSY WINGATE CASE.

Patsy, who lives in one of the Appalachian mountain towns, has had all manner of paranormal activity all through her life. (Maybe her Blackfoot Indian/Dutch/ Irish ancestry has something to do with it?) Perhaps her strangest abduction incident was on the night when the little aliens came to take her again and she was pregnant, and angry, and wanted no part of it. As the three little Greys approached her across the bedroom floor, she jumped up and grabbed the middle one by its thin neck. She squeezed, and there was a crack, and its head fell back on its spine. Startled looks appeared on the faces of its companions who were on each side of it. They quickly grabbed the disabled one's arms, reversed direction in a robot-like manner, and soon disappeared in the light that had appeared in the bathroom. Patsy went back to bed feeling remorse. She had not intended to hurt anyone. (The only other time that I've heard of this sort of happening was in a case familiar to Dr. David Jacobs).

Patsy has been branded, with a V with a reversed 7 in it, and a B with a circle under it, whatever these may mean. Once, when a child, she remembers walking down a forest path with a tall blond man in a suit. His eyes were "gentle", and she was transfixed with his face and his wings! He made a squeaking sound instead of talking. At another time, when living near a cemetery, she would see, on a windy night, a figure in a black robe that seemed to be watching her house. Then, again, one day in the cemetery, she encountered a tall black-cloaked man with light coming from his face. (Was he her guardian angel or was he a devil?) In several different residences, over the years, Patsy and others have had black limos follow them. Also they have been followed by what looked like police cars, but they had 'a low rolling fog' that moved with them. One afternoon, as Patsy was driving toward an intersection, she momentarily blacked out. Her husband nudged her, and she recovered just in time to stop at the intersection. Near the intersection there was a dark-windowed limousine. And the mental voice which she sometimes heard said, "See - we can kill you anytime we want to."

Black helicopters were also seen by Patsy and those around her. On one momentous night, when she lived near Windblow, North Carolina, in the middle of a huge peach orchard, three black helicopters were in the sky. These 'seemed to be linked to a huge curved piece of

lightning that was also there'. On another occasion, when the MIB accosted Patsy on her own front porch in Kentucky, her children had climbed up into a nearby tree and they watched it all. The white-faced beings were dressed in silky black suits, white shirts, ties and dress hats. Using a large needle they filled a vial with Patsy's blood.

5.THE ORIENTAL MIB. THE CARROLL WATTS CASE.

Watts was a cotton farmer who lived in the Texas 'panhandle' area. He knew nothing about UFOs, and pounded with his fist on the first one that landed on his farm, thinking it must be a Government craft! In his second encounter with the large grey cylinder object, he was abducted. The craft also appeared again later, so he got 7 polaroid photos of it. Watts was seeking some answers about it all from a reliable source, so he got in touch with the then ongoing Government-financed UFO study at the University of Colorado led by by Dr. Condon. He got no answers, and - according to Condon - the original photos and negatives got "lost". In fact Condon told him to "quash" and stop talking about what had happened to him. When Watts later went public he became a national sensation, and he began to receive threats to silence him. Dr. Allen Hynek urged him to prove his claims in a polygraph test.

As he was driving to Amarillo, where he was to take the test, he saw ahead of him a blue-green Plymouth parked along the road with its hood up. (Hood = British "bonnet"). An attractive young blonde woman was standing by it, and waved for him to stop. As he stepped out, he was knocked down by a blow to his neck. When he opened his eyes, two figures towered above him. They were clean-cut, brown-skinned, oriental-looking gents. They were about six feet tall, of maybe 190 lbs. or so, wore expensive looking dark suits and turtle-necked sweaters. They pointed submachine guns at him. Speaking in precise English one told Watts that he would fail the lie detector test or else. About an hour later Watts was very glad to do just that.

The following night a big black car haunted the Watts home, and finally shotgun blasts were heard coming from it as it moved slowly past. Watts had fled to a nearby field and he emptied his M1 Carbine at it without effect. In the home his frantic wife was calling the police. All this was more than enough for Watts. He proclaimed to all that his UFO story was a hoax.

Watts began having behavioural problems, and his brother told me he was influenced by a stranger who had come. Paranoia set in, and Watts now began to believe that certain people were out to 'get him'. Finally, out of mistaken fear, he pulled his gun on a law officer. Once upon a time he had been a happy husband and father. Then the aliens came. From his cell in Texas State Prison Watts told me, "The incident cost me my wife, my children, \$285,000, my freedom, my health (heart trouble) and nearly my life. Simply because something happened to me that I didn't uderstand, and that I talked about, and I think now that I would have been better off myself if I had died in the incident."

6.ORIENTAL MIB. THE STANLEY INGRAM CASE

My friend Stanley, a former judge, city manager, news column writer, is dead. But he and his incredible struggle with the aliens will never be forgotten. In the end bankrupt, ridiculed, and disillusioned, he died of a heart attack. But he has never been forgotten, because I have preserved a large quanity of data on his situation over the years 1973 to 1976 in rural south-central Tennessee, USA. It all began when he and his daughter Becky began to watch UFOs from firetowers in the region. At school one day a jumbled voice began to come in the daughter's head. She was very upset, and sought her father's help. Later, when the voice became clear, it urged her to come to the football field. Finally one day she gave into it, and went there and found herself inside a brightly lit UFO. This was the first of the series of mental summonses to the craft wherever it had landed. Another local man named David Swanner was also affected in similar fashion. Stanley himself was never abducted but through these persons the struggle between him and the aliens ensued. His efforts to understand and cope would all end in final defeat. At first he thought the aliens might be "good", but with the arrival of the MIB he became sure they were not.

The two beings that his daughter Becky met in the UFO called themselves 'Alton' and Tombo' and said they were from the planet 'Plantos.' They were off-white stick-on suits, rolled-edged-stocking hats from which a little blond hair showed, and pointed shoes. They were about 4 1/2 feet tall, had thin necks, small eyes, ears, and noses, and pointed faces. At home after the event Becky had nausea, headache, thirst, frequent urination, and great sleepiness. She recoved after three months under a physician's care.

With regard to David Swanner's case, the oriental MIB came in June 1974, and when they stopped Swanner the second time, it was in an alley. They showed him a brief-case supposedly containing \$500,000 for the propulsion formula which he had been allowed to copy on the craft. Stanley Ingram had the formula, in his safe. The three alien figures were in a late model black Cadillac three-seated auto bearing a California plate. No one was ever able to get the long number.

The beings had big round dark complexioned oriental faces with piercing eyes. All were heavy-set in build, looked about 30 or 40 years old, and had thick black hair cut in the style of 'pre-crew-cut' years. They wore black suits, white shirts, and black ties. Their voices had a Chinese accent pitched low and gruff, and they spoke in a normal unexcited tempo. Amazed and afraid, Swanner sped off in a cloud of dust.

On Aug.2nd. 1974(?), Becky parked and ran into a bowling alley to get away from the limo behind her. On Sept. 23rd Swanner bluffed them out with a handful of rocks he had grabbed at the roadside. They backed up and left. On Sept. 25th Becky discouraged them by brandishing a small choppping axe when they got too close. On the night of Feb. 25th 1975 the black MIB limo flashed around Becky on a rural road. Four MIBs with revolvers jumped out. The biggest of them, a barrel-

chested being about 5ft 10, jerked Becky out of her car. They wanted to know where her father was, and where the formula was. Really foolish questions in an "incomprehensible game. Becky received a blow to her stomach and another to her face which knocked her onto the hood of her car. Then her strange assailants drove away. When she got home, Stanley was furious. He took her to the sheriff's office and also called in friends with guns. Early next day he took his swollen-faced daughter to the doctor and alerted other law enforcement officers in the area. Becky would see the MIB one more time, several days later, when she looked out of her upstairs window. The MIB, wearing an old style Stetson hat, was standing in the rain in the yard and looking up at her. Evryone rushed out and scoured the area in two cars, but the MIB had vanished.

I have given you only an outline of these six cases. Clearly these are counter to the quasi-spiritual, loving guidance convictions held by some researchers and experiencers. (However there *must* presumably be some alien groups who have noble motives. *The trouble is that personally I have yet to find any that I would fully trust!*).

In the Brock case, remember, (Case No.1) the MIB said, "We have people everywhere." In some of my cases the MIBs show an intimate knowledge of all things human. I believe these lying forces of destruction and evil are just beyond your mental fingertips. Kept at bay by the love and truth of our original Creator who exists beyond the furthest galaxy. All too often now dear reader, you perceive the rising crescendo of Evil in its many forms engulfing the entire Earth. There is a special book that constantly warns of it. It is known as "The Bible".

WHAT ST. PAUL IS ACTUALLY REPORTED TO HAVE SAID..

Ephesians 6:12, "For we wrestle not against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this world, against spiritual wickedness in high places." (Authorized King James version of the Bible). *

was intensely interested when I saw that Don Worley had focused his attention on these words of St. Paul's EPISTLE TO THE EPHESIANS, VI,12, because it is a passage that has been the object of my own speculation and study *for many years past*.

In these modern times every one of us is of course familiar enough with the idea of "cover-ups" in connection with well nigh every aspect of human life or thought or activity, — particularly "Government cover-ups," today apparently regarded as one of the chief banes of our existence.

of her small abductors.

But few, I suspect, realise that "cover-ups" and deliberate deceptions and distortions, many of them centuries-old, are also to be found in such places as the standard texts of Christendom — as of course indeed also in the texts of all or any of the world's OTHER "Great

Religions". By this I mean deliberate distortions or falsifications, either in the wording of the original language, or *in translations* of the same.

Obviously unwitting or accidental errors might easily arise in any sort of translation, on whatever theme, and however trivial. But that is not what we are discussing.

But when it occurs in a religious passage of truly massive importance like the one which we are considering, then we should always be mindful of the high possibility that we are looking at a piece of what can only have been *deliberate deception*, and not an accident.

And such is the case with this passage from EPHESIANS, Chapter VI., verse 12.

We have been hearing such an awful lot lately about "sleaze" and immorality and 'dodgy' ways of conduct in general, and according to what our own Kremlin Bosses now tell us, these dreadful defects are found exclusively in *just one* of Britain's political parties. (At least one other party, it seems, is 'as pure as the driven snow', and totally free of the blight.)

The language in which our texts of the *New Testament* have come down to us is a rather simple form of Greek — on the whole far less complex than the old classical tongue of ancient Greece. And here, in the box below, is a word-for-word translation which I made, about ten years ago, in order to lay bare what the Greek text of these lines *ACTUALLY SAYS*. Anyone who is familiar with this thing that we call "the UFO Problem" may find the result quite surprising!)

A fter the first ten Greek words we see at once of course that the main thrust of the statement is not simply against what today we folk would call "sleaze" or "immorality" or "dishonesty" in our own human social, political and financial/commercial lives. Clearly it embraces much more than merely that. It points to the presence of malignant non-human entities that were then (and, as we can now see, still are!) active in the skies of

our planet. And I suggest that whoever was responsible for the 'official' and 'accepted' translation as published in the Authorised King James Version of the Bible (its date was 1611) was knowingly perpetrating a 'cover-up' and undoubtedly was acting on instructions, and those instructions will have been received either consciously from someone high up in the Protestant Anglican Church or in our Government (someone who, as the Buddhists would say, "was on the Left-Hand Path") or, unconsciously, telepathically, from some non-human entity or agency of an evil type.

As Gurdjieff always emphasised in his writings and his teachings, there is "something" in man - his soul - which is part of the Divine and which has come to us from beyond Time and beyond Space and which causes us to seek to return to the Divine. ("To Him alone is the Return!" as the Koran puts it). Gurdjieff calls this 'something' in the human soul "the Sacred Impulse".

As the Swiss writer Blaise Cendrars (1887-1961) once put it, "Mankind has an enormous need for the Divine, and this is why there are so many Gods in the world".

But if - as seems only too evident - all of the world's "Great Religions" were infiltrated and vitiated long, long ago by the Satanic Forces, then surely it would have been of the very greatest importance that this piece of evidence in *Ephesians VI*, 12 ABOUT MANKIND'S REAL, DESPERATE, SITUATION SHOULD BE CAREFULLY BLOTTED OUT!

So you may be sure that this "mis-translation" did not come about by any chance or accident. Note how skilfully the very concept of evil forces flying in our skies has been eased right out!

Both Jesus and Paul referred to the SATANIC POWER as "THE PRINCE OF THE AIR". See, for examples, the Gospel of St. John, Chapter Xii, verse 31:

"The Prince of this world".


" άξχων τοῦ κόσμου τούτου".

And see also Paul's *Epistle to the Ephesians*, Chapter II, verse 2:

"The Prince of the authority of the Air, the Spirit that *now* works in the Sons of Disobedience". (See the text below.)

This Greek word for *now*, which I have here underlined, seems to me to be most extraordinarily interesting. The "Sons of

Disobedience" seem surely to be the "Sons of Belial", who, as we are told in all the three religious sources - Jewish, Islamic, and Christian -



rebelled against God. They are headed by SATAN, *Shaytan* as the Jews call him, or *Iblis* or *Shaytan* as the Muslims call him, or *Ahriman* as the Zoroastrians of Iran called him, or *Lucifer* as he is sometimes - incorrectly -

called, (for "Lucifer" originally meant Venus or the Morning Star); he is patently the Leader of the Revolting Angels whom the Hebrews called the NEPHILIM



("THOSE WHO FELL") and whom the Sumerians and Babylonians called that faction of the ANNUNAKI, who were the Rebels. (See the books of Zecharia Sitchin, who, incidentally, although Jewish himself and presumably an excellent authority on all the Semitic languages, seems to have got it a bit wrong in his earliest books, where he began by calling the Rebels "THOSE WHO CAME DOWN", But the word "NEPHILIM" cannot possibly mean that. It means clearly "THOSE WHO FELL", and I note that in his later books this is the translation that he gives.)

With reference to the word "now" mentioned by me above, it is surely interesting inasmuch as it might be suggesting that there was an earlier period — i.e. before the *Fall of Man*" into the control of Evil Forces — when "things were different", and when mankind was "in a better state".

On this question of the great Battle which, according to all three of our great "Western Religions", has been going on for an immense period of time between the Forces of the Light (i.e. of Michael) and the Powers of Darkness (Satan, Iblis, Ahriman), I feel that nobody has written so much and thrown so much light as the great Austrian teacher and founder of Anthroposophy, Rudolf Steiner (1861-1925). A seer and clairvoyant from his earliest years, Steiner produced a vast flood of books and articles and lectures, much of which has still not been translated from his very difficult style of German. Some of his most important work has dealt with the Dark Forces that menace mankind, whom he describes under two categories which he labels "Ahriman" and "Lucifer". A series of lectures delivered by him in 1917 reveal an astonishingly prophetic view of the Bolshevik Revolution then just starting in Russia and the terrible results that it would bring for the whole of mankind. Most important however, are his books and lectures on the Satanic Powers. From around 1840 until about 1879, so Steiner claimed, another tremendous round was being fought between the Cohorts of Michael and the Dark Ones, ending in a severe defeat for the latter. However, says Steiner, the result was that the Forces of Evil have been driven down firmly upon the Earth and are now

closer to mankind, and working more fiercely to overpower and control us, than ever before. The present scene of unprecedented violence, drug-taking, sexual abnormality and general crime and disorder is the clear result, and it will all get far, far worse. (The Russian emigré Nikolai Berdyaev, writing in France during the 1930s, also produced several important books in which he warned that another Dark Age is at hand).

It is perfectly evident that Paul had seen quite clearly that mankind is engaged in an ongoing struggle against something desperately *evil*. But, Christianity having been already successfully infiltrated at a very early date, it was easy to hide the truth and distort the meaning when the time came for the Bible to be translated and printed on a massive scale.

Nowadays, of course, few are expected any longer to be wanting to consult the texts of the Bible. And who, anyway, any longer (in our Western world) believes in the **existence** of devils and demons and evil spirits!

In his wonderful little book, *The Screwtape Letters: Letters from a Senior to a Junior Devil (1942)*, doesn't C.S. Lewis have his Senior Devil pronouncing these famous words to his Junior Colleague?:

"Remember, Wormwood, our trump card is the fact that everybody KNOWS that we don't exist!"

There you have it in a nutshell!

N.B. Just because the text contains this mention of the "skies", don't assume that this means that the "Nasties" are all "ETs". Being the Prince of the Air", it is surely not surprising that Old Nick and his cohorts should be making such widespread use of aerial craft. Which has made it all the easier to bluff mankind into the fatuous belief that they are our beloved "Cosmic Brothers", from other planets, who have come here to get us off the hook if only we will place ourselves in their hands! FLYING TRIANGLES: THE GROWING THREAT?

last reviewed the progress of Flying Triangles over the U.K. in FSR Vol. 39, No.4 (Winter 1994) and Vol. 40, No.1 (Spring 1995). In those issues I concentrated mainly on the FT activity over the Midlands area of England. Now, with the aid of information made available from a wide number of groups throughout the U.K., I am able to present a wider picture of the increasing presence of Flying Triangles in our night skies.

Although there has been some speculation that the Flying Triangles are a new *Stealth* type of aircraft, there are numerous reasons why this theory can be discounted.

- a) Flying Triangles have been reported for many years, pre-dating the *Stealth* technology period. One of the earliest verified reports that we have is that of Mr Robin Gibbard, an experienced observer from Derby. At 11 a.m. on the 19th April 1956, Robin watched the approach of an 'Avro Anson' aircraft. As it drew closer, he observed a small triangular craft flying around the aeroplane; it then "shot straight up at a phenomenal speed".
- b) The shape of the Triangle is not related to any aerodynamic design. They have often been reported as travelling "wide-side-first".
- c) The FT can vary its velocity from hovering, quietly or with a faint hum, to an estimated speed range of between 25 mph to 650 mph. (See graph.)
- d) The FTs have been observed hovering low over nuclear power plants, main highways, traffic islands, and populated areas. Hardly the actions of a new 'secret' aircraft.
- e) Although there have been claimed sightings of the FT along the Lancashire coast, **it is not** based, and **does not** originate from the British Aerospace facility at Warton, Lancs.

Mr Simon Lewis, of the North Lancashire UFO Investigation Group, recently addressed a meeting of aeronautical engineers at British Aerospace, Warton. They had heard reports of Flying Triangle craft being observed in the Lancashire area, and had stated that "it is not one of ours!" Simon Lewis was invited to give a presentation on the FT craft. He later commented that there had been great interest in the subject, and particularly in the video of an FT passing over Morecambe, Lancashire, on the 2nd February 1996.

f) The Flying Triangle reports are not peculiar to the United Kingdom. There have been numerous FT encounters around the world for many years. Readers may be familiar with the 'Hudson Valley' (USA) flap, when boomerangs and triangular craft visited the area in the mid-80s. (See FSR 30/3, February 1985, for two articles by Philip Imbrogno and others.)

We have a first-hand report from Mr Clay McLean of Longview, Texas, who in 1967, at the age of twelve, was returning from watching a local basketball game at his school. As he was walking home a large, black Flying

Triangle quietly floated over him at a height of only 100 ft. "It was very black against the sky, emitted no lights at all, and was completely silent", commented Clay.

There was also the Flying Triangle 'flap' over Belgium (1989/90). The Belgian Air Force scrambled several F16 fighters in an attempt to intercept the FTs. They failed completely, as the FT craft were able to execute feats of acceleration, climbing and diving which utterly outperformed the F16 aircraft. (See FSR 35/2, June 1990, for several articles; also 35/4, December 1990 for more.)

I cannot stress the importance of the interchange of UFO information between groups. There are still a number of individuals who feel that the FT information they have obtained is 'theirs', but fortunately more than 30 U.K. groups are currently submitting their reports to the FT databank. Prominent among these is the Essex UFO Group, under the leadership of Ron West.

This information is being gathered and correlated by Victor J. Kean under the 'Project FT' programme. Victor's work has resulted not only in the number, but the speed, track and prime target areas of the FTs being identified.
